### **Qualification for the posts of Chairperson and Members of Child Welfare Committees (CWCs)**

1. The Chairperson and Members of the Child Welfare Committee shall be above the age of 35 years on or before on the last date of the submission of application.
2. The Chairperson and Member shall have a minimum of seven years of experience of working with children in the field of education, health or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer.
3. No person shall be eligible for selection as a Chairperson and a member of the Child Welfare Committees if ;
  - (i) Has any past record of violation of human rights or child rights;
  - (ii) Has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
  - (iii) Has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
  - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
4. A member of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous.
5. Chairperson will be selected from the members by the State Selection Committee.

Note: All the applicants must submit their applications in the following prescribed format along-with copies of certificates of educational qualifications and experience.

### **Qualification for the post of Social Worker Member, Juvenile Justice Boards (JJBs).**

1. The social worker member shall not be less than 35 year of age on or before the last date of the submission of application.
2. The Social Worker member shall have at least seven year of experience of working with children in the field of education, health or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or Sociology or in the field of law.
3. No person shall be eligible for selection as a Chairman or Member of the Board, if he-
  - (i) Has any past record of violation of human rights or child rights;
  - (ii) Has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
  - (iii) Has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
  - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act
4. A member of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous
