#### **Important Days**

#### National Handloom Day: 7 August 2017

- National Handloom Day is being observed today to encourage people to use handmade loom in the country. The main event will be held in Guwahati to celebrate the third National Handloom Day.
- Central Government has declared August 7 as National Handloom Day, to be celebrated every year due to its significance in India's history, as 'Swadeshi Movement' was launched in 1905 on this day. The movement involved revival of domestic products and production processes.
- Prime Minister Narendra Modi had launched the first National Handloom Day on August 7 in 2015

## World Bio Fuel Day: 10 August 2017

 Every year 10th August is observed as World Bio-Fuel Day in a bid to create

- awareness about non-fossilfuels (Green Fuels).
- On this day in 1893, Sir Rudolph Diesel (inventor of the diesel engine) for the first time successfully ran the mechanical engine with Peanut Oil.
- His research experiment had predicted that vegetable oil is going to replace the fossil fuels in the next century to fuel different mechanical engines.
- Thus to mark this extraordinary achievement, World Biofuel Day is observed every year on 10th August.

#### International Youth Day: 12 August

- On 17 December 1999 the United Nations General Assembly endorsed the recommendation made by the World Conference of Ministers Responsible for Youth that 12 August be declared International Youth Day.
- It reaffirms the important role youth can play in deterring and resolving conflicts, and are key constituents in ensuring the success of both peacekeeping and peacebuilding efforts.
- Theme 2017: "Youth Building Peace"
- In 1985, the UN celebrated the first International Year of Youth.

#### Organ Donation Day: 13 August 2017

- Organ Donation Day in India is celebrated on 13th of August every year by the people, government organizations and other related professions in order to motivate normal human beings to donate the organs as well as to understand the value of organ donation in the life of an individual.
- The organ donor can be anyone of which the organ can be transplanted to the patient urgently requires.
- The organ donated by the normal human being is saved properly to transplant into the patient whenever he or she require.
- One can get the new life through the organ transplantation donated by someone.

## India Celebrates Independence Day: 15 August 2017

 Independence Day is an annual observance celebrated every year on 15th of August. India's Independence Day is a day of great significance for the people of India.

- At this day India got freedom from the British rule after long years of slavery.
- It has been declared as the National and Gazetted Holiday all across the India in order to independently commemorate the independence of the country from British Empire on 15th of August in 1947.

#### World Photography Day: 19 August

- August 19 is observed as World Photography Day, which aims to inspire photographers across the planet to share a single photo with a simple purpose: to share their world with the world.
- World Photo Day originates from the invention of the Daguerreotype, a photographic process developed by Frenchmen Louis Daguerre and Joseph Nicephore Niepce in 1837.
- On August 19, 2010 World Photo Day hosted its first global online gallery.
- Almost 270 photographers shared their pictures and people from over 100 countries visited the website. This marked the first official, globally reaching World Photo Day.

#### World Humanitarian Day: 19 August

- On 19 August 2003, a terrorist attack hit the United Nations headquarters in Baghdad, killing 22 people. Among those who lost their lives was Sergio Vieira de Mello, the UN's top representative in Iraq.
- Five years later, the General Assembly adopted a resolution designating 19 August as World Humanitarian Day.
- Every year since then, the humanitarian community has organized global campaigns to commemorate WHD, advocating for the safety and security of humanitarian aid workers, and for the survival, well-being and dignity of people affected by crises.

#### National Sports Day 2017: 29 August 2017

 National Sports Day in India is celebrated on August 29, the birthday of Dhyan Chand, one of the greatest field hockey players of all time. Dhyan Chand won gold medals for India in Olympics in the years 1928,1932 and 1936.

- National Sports Awards such as Arjuna and Khel Ratna are conferred on selected athletes by the President of India every year, on this day.
- The National Hockey stadium in Delhi was renamed as Dhyan Chand National Stadium in 2002.
- The National Sports Day celebrations are a commemoration of his achievements.
- The day is also known as Rashtriya Khel Divas. The Major Dyanchand Awards conferred on athletes is the highest award for lifetime achievement in sports and games in India.

#### United Nation observed International Day against Nuclear Tests on August 29

The UN-established
 International Day against
 Nuclear Tests was observed across the world on August 29
 'to galvanize the United Nations, Member States, intergovernmental and nongovernmental organisations, academic institutions, youth networks and the media to inform, educate and advocate the necessity of banning nuclear weapon tests as a

- valuable step towards achieving a safer world'.
- Since 2010 the event is being observed by coordinating various activities throughout the world, such as symposia, conferences, exhibits, competitions, publications, and lectures in academic institutions, media broadcasts and other initiatives.

#### National Events

Government enters into nine Unilateral Advance Pricing Agreements (UAPAs) with Indian taxpayers in July, 2017

■ The Central Board of Direct
Taxes (CBDT) entered into nine
Unilateral Advance Pricing
Agreements (UAPAs) with
Indian taxpayers in the month
of July, 2017. Some of the
UAPAs signed had rollback

provisions also.

 The APA Scheme endeavours to provide certainty to taxpayers in the domain of transfer pricing by specifying the methods of pricing and determining the Arm's Length Price of international transactions in advance for a maximum period of five future

- years. Further, the taxpayer has the option to rollback the APA for four preceding years, as a result of which, a total of nine years of tax certainty is provided. Since its inception, the APA scheme has attracted tremendous interest among Multi National Enterprises (MNEs).
- The nine APAs signed in the month of July, 2017 pertain to diverse sectors of the economy. CBDT has signed its first APA with a taxpayer engaged in supplying rigs used in Oil & Gas exploration. Other than the Oil & Gas Sector, the APAs pertain to Education, Banking, Pharmaceutical, Manufacturing and Information Technology sectors of the economy. The international transactions covered in these nine APAs include the provision of software development services, provision of IT enabled services, provision of engineering design services, distribution, contract manufacturing, etc.

## Supreme Court no to use of heavy metals in firecrackers

 Citing health hazards, the Supreme Court asked firecracker manufacturers not

- to use heavy metals like lithium, antimony, mercury, arsenic and lead and chemical elements like antimony "in any form whatsoever" in their products.
- A bench of Justices Madan B Lokur and Deepak Mehta said it was the responsibility of the Petroleum and Explosives Safety Organisation (PESO) to ensure that the order was complied with, including in Sivakasi in Tamil Nadu where there were a large number of cracker manufacturers.
- Though the compounds of strontium too were cited as hazardous for health, the court sought more clarity on the matter and fixed August 23 for the next hearing.

#### Govt nod to rename Mughalsarai railway station as Deen Dayal Upadhyaya

- The centre approved a proposal to rename the Mughalsarai railway station in Uttar Pradesh after RSS ideologue Deen Dayal Upadhyaya
- The proposal was given by the BJP government in Uttar Pradesh in a bid to revive the

- legacy of Upadhyaya, who died in 1968 at the junction itself.
- The junction, the fourth busiest railway station in the country, is located on the main Howrah-Delhi Grand Chord line. The Uttar Pradesh government, headed by Yogi Adityanath, had in June approved the proposal of renaming the station and forwarded it to the Ministry of Railways for final approval.

Mukhtar Abbas Naqvi launches Jiyo Parsi Publicity Phase-2" in Mumbai

- The Union Ministry of Minority Affairs launched Jiyo Parsi Publicity Phase-2 in Mumbai,
- Maharashtra under the Jiyo Parsi scheme.
  - The Jiyo Parsi Publicity Phase-2 aims to decline trend of the population of the Parsi community and reverses it to bring their population above the threshold level.
  - Jiyo Parsi scheme is a Central Sector Scheme for containing population decline of Parsis in India. Its main objective is to reverse the declining trend of the Parsi population by adopting a scientific protocol and structured interventions. It

aims to stabilize and increase the population of Parsis in India.

#### Government Forms Panel To Suggest Data Protection Framework

- The government has constituted a 10-member committee to recommend a framework for securing personal data in the increasingly digitised economy as also address privacy concerns and build safeguards against data breaches.
- The panel will study and identify key data protection issues and recommend methods to address them.
- The formation of the panel comes amid concerns over personal information being compromised with increasing use of biometric identifier Aadhaar in an array of services from filing tax returns to availing government doles.
- The committee of experts headed by Justice BN Srikrishna, former judge of Supreme Court, will suggest a draft data protection bill,
- The panel will make specific suggestions to the government on principles to be considered

for data protection in India and "also suggest a draft data protection bill"

## Govt launches e-RaKAM portal for selling agri produce

- The government today launched a portal, e-RaKAM, to provide a platform to sell agricultural produce.
- The portal is a joint initiative by state-run-auctioneer MSTC and Central Warehousing Corporation arm CRWC.
- E-RaKAM is a first-of-its-kind initiative that leverages technology to connect farmers of the smallest villages to the biggest markets of the world through internet and e-RaKAM centres.
- E-RaKAM is developed by MSTC Limited and supported by marketing & logistics partner CRWC Limited.
- E-RaKAM is a digital initiative bringing together the farmers, FPOs, PSUs, civil supplies and buyers on a single platform to ease the selling and buying process of agricultural products.

#### India Permitted To Construct Kishanganga, Ratle Projects: World Bank

- India is allowed to construct hydroelectric power facilities on tributaries of the Jhelum and Chenab rivers with certain restrictions under the 1960 Indus Waters Treaty (IWT), the World Bank has said.
- The World Bank's comments came as officials from India Pakistan concluded the secretary-level talks over the IWT.
- Pakistan opposes the construction of the Kishanganga (330 megawatts) and Ratle (850 megawatts) hydroelectric power plants being built by India in Jammu and Kashmir,

## Cabinet to take up scrapping of no-detention policy in schools

 States will soon be able to able to conduct exams for students of class 5 and 8 who fail in the annual exams to give them another chance to pass with the Union cabinet likely to take up a proposal on Wednesday of scrapping the 'no-detention policy',

- States will have the discretion to give another opportunity to these students to pass. Under the proposal, students of classes 5 to 8 who do not pass the examination in March will be given a chance in May or June.
- However, they will be detained if they fail again according to the proposal.
- In case a student is unable to pass the annual exam in March, he/she will get another opportunity in May or June. Before sitting for the exams once again, the students will be asked to attend 'remedial classes'. Once the new system comes into force, the onus would be on the states to decide whether to hold examinations in classes 5 and 8.

CIC reconstitutes bench to hear complaints against political parties

Chief Information
 Commissioner R K Mathur has
 constituted a larger bench to
 hear complaints against six
 national political parties not
 adhering to the CIC order
 bringing them within the ambit
 of the RTI Act.

- The bench will replace a threemember panel headed by Sridhar Acharyulu which was hearing the matter since July 22, 2016 until one of its members Bimal Julka decided to recuse himself citing workload. After his recusal, Mathur had put the matter in abeyance till further notice.
- Besides Mathur himself, the new Bench will have Information Commissioners--Sharat Sabharwal, Manjula Prasher and Divya Prakash Sinha.
- The new Bench will start hearing the matter from August 16

## Bills to extend GST to J-K passed by Lok Sabha

- The Lok Sabha passed legislation to extend the Goods and Services Tax (GST) to Jammu and Kashmir, making it part of the "one nation, one tax" regime.
- The House passed the Central Goods and Services Tax (Extension to Jammu and Kashmir), Bill, 2017 and the Integrated Goods and Services Tax (Extension to Jammu and Kashmir), Bill, 2017 after a brief discussion in which

- members by and large welcomed the measures.
- The two bills replace an order promulgated by the President

#### Online tatkal railway tickets: Now you can pay on delivery

- People can now pay later for tickets booked under the tatkal quota on the Indian Railway Catering and Tourism Corp (IRCTC) website, it was announced on Wednesday.
- Till now, this service was available only for general reservations. For tatkal bookings, people had to pay first via the standard online payment gateways before the IRCTC portal confirmed their ticket.
- For tatkal tickets, IRCTC users will be able to pay via cash, debit card or credit card by opting to have tickets delivered at their doorstep, said IRCTC payment provider Anduril Technologies.
- IRCTC processes 130,000
   Tatkal transactions daily. A majority of these tickets are booked within minutes of the quota opening.
- The new feature eliminates the transaction failures as often the money gets debited and the ticket is not issued due to multiple reasons. The refund

cycle is of about seven to 15 days.

# Haryana bans govt school teachers from taking mobile phones to classrooms

- The Haryana government barred school teachers from stepping inside the classrooms with mobile phones and decided to hold head of the school "accountable" for violation of this norm.
- This restriction of going to the classroom without mobile phones also applies to the head of school.
- The education department has directed that all inspecting officers, whether on regular inspection or surprise
- inspections, will check whether these instructions are being followed in letter and spirit.
  - Teachers will keep mobile phones in the staff room or in an area earmarked by the head of school.
  - However, in case of unavoidable reasons the teacher has to take mobile phone to the classroom for "academic use" then prior permission of the head of the school is must.
  - The teacher will have to write the reason(s) in a register that

- will specially be maintained for this purpose.
- In case someone wants to reach out to the teachers in case of emergency, the head of the school will make available two contact numbers

#### 'Aadi Perukku' celebrated

- Thousands of men and women celebrated 'Aadi Perukku' festival at the bathing ghats of the Periyar river in Veerapandi and Uthamapalyam in Tamil Nadu
- Pilgrims began to throng the banks of the river since morning as the flow was good, thanks to discharge of a large quantum of water from Periyar dam in order to improve the storage level in Vaigai dam.
- Women performed special pujas to the river and prepared sweet pongal and offered to it.
   Irrespective of caste and community, both men and women prayed together for rain. Men performed rites for their forefathers. Many took holy bath in the river before offering prayers.

Maharashtra Government launches two online portals MahaDBT, MahaVASTU

- Maharashtra Government launched two online portals MahaDBT and MahaVASTU to streamline the process of direct benefit transfer (DBT).
- It is the first state in the country to launch such a system that will provide direct benefits with Aadhaar authentication.
- MahaDBT portal: It is an Aadhaar-authenticated electronic mechanism that will enable direct transfer of benefits for over 40 schemes currently implemented.
- MahaVASTU portal: It is an online building permission management system, through which construction approvals will be sanctioned with full transparency.

#### Lok Sabha passes bill to raise Nabard's capital to Rs 30000 crore

- A bill to enable exit of RBI from Nabard and increase authorised capital of the development institution six times to Rs 30,000 crore was passed by the Lok Sabha
- The National Bank for Agriculture and Rural Development (Amendment) Bill, 2017 also seeks to amend certain clauses in the light of

- reference of the Micro, Small and Medium Enterprises (MSMEs) Development Act, 2006 in the proposed legislation.
- Minister of State for Finance Santosh Kumar Gangwar said that the law is one of the "major step" towards doubling farmers' income by 2022.
- This is a small bill but irrespective of that, 28 members put their views on this legislation, which reflects the interest of members's on agriculture related issues

#### Lok Sabha passes Banking Regulation Bill 2017

- The Banking Regulation (Amendment) Bill 2017 was passed by the lower house of the parliament.
- It will replace the Non-Performing Assets Ordinance, which came into effect earlier this year.
- Finance Minister Arun Jaitley, on Monday, had introduced a bill in Lok Sabha to amend the Banking Regulation Act 1949. The measure allows the RBI to initiate insolvency resolution process on specific stressedassets.
- The RBI would also be empowered to issue other directions for resolution,

- appoint or approve for appointment, authorities or committees to advise the banking companies for stressed-asset resolution.
- The non-performing assets of banks have increased to more than Rs 9 lakh crore and now RBI is empowered to refer the cases to Insolvency and Bankruptcy Board. In June, RBI had identified 12 large loan defaulters who account for 25% of the total bad loans in the Indian banking system.

#### Bengaluru will soon have India's first helicopter-taxi service

- Bengaluru will become the first city in the country to provide a helicopter taxi service
- The service will be operated by Thumby Aviation Private Limited who have partnered with the Bangalore International Airport Limited to start the Heli Taxi service.
- The helicopter service will initially be operated between Bengaluru's Kempegowda International Airport and the Electronics City area.

 The travel time will be cut down to 15 minutes instead of the two hours taken by road.

# Government announces new PSU ETF called Bharat-22 with diversified portfolio

- Finance Minister Arun Jaitley announced creation of new Exchange Trade Fund called Bharat 2022, comprising of 22 companies, or investments from central public sector undertakings, public sector banks and some other strategic holdings.
- Compared to energy heavy CPSE ETF, Bharat 22 is a well diversified portfolio of companies from six sectors (basic materials, energy, finance, FMCG, industrials & utilities) with a 20% cap on each sector and a 15% cap on each stock.
- It will feature four banking stocks -- SBI, Axis Bank, Bank of Baroda and Indian Bank -other than CPSEs such as Nalco, ONGC, IOC, BPCL and Coal India.
- Besides, there will be nine other PSUs as well as REC and PFC.
- The first central public sector enterprises (CPSE) ETF, which was set up in 2014, comprised

of 10 companies — Oil and Natural Gas Corp. (ONGC), Coal India, Indian Oil Corp. (IOC), GAIL (India), Oil India, Power Finance Corp. (PFC), Bharat Electronics, Rural Electrification Corp. (REC), Engineers India Ltd and Container Corporation of India.

 Government had raised Rs 8500 crore by divesting through CPSE ETF in FY'16-17.

## 'All ASI-protected monuments declared polythene-free zones

- All monuments and archaeological sites protected by the ASI have been declared as polythene free zones
- A total of 3,686 historical monuments and archaeological sites have been declared protected as that of national importance by the Archaeological Survey of India (ASI).

#### Second phase of measlesrubella vaccination drive launched in eight states

 Aiming to eliminate measles and curb instances of rubella by 2020, the Centre has rolled out the second phase of its measles-rubella (MR)

- vaccination campaign in the country.
- Nearly 3.4 crore children across eight states and union territories — Andhra Pradesh, Chandigarh, Himachal Pradesh, Kerala, Telangana, Uttarakhand, Dadra and Nagar Haveli and Daman and Diu will be covered in this stage.
- While measles is a viral infection that can be fatal, congenital rubella syndrome is responsible for irreversible birth defects. The Union health ministry's campaign against the two diseases intends to cover approximately 41 crore children in a phased manner, making it the largest-ever worldwide.
- The first phase of the campaign was launched across five states — Tamil Nadu, Karnataka, Goa, Lakshadweep and Puducherry — in February this year.

#### Govt declares entire Assam as 'disturbed' area under AFSPA for another month

 The Centre has declared entire Assam as a "disturbed" area under the controversial Armed Forces (Special Powers) Act (AFSPA) for one more month, citing various violent activities

- by insurgent groups ULFA, NDFB, and others.
- The Union home ministry also declared Meghalaya's border areas adjoining Assam, and three districts in Arunachal Pradesh as "disturbed" under the AFSPA for two more months with effect from August 3.
- In separate gazette notifications, the home ministry said the entire Assam, has been declared "disturbed" under the AFSPA with effect from August 3 till August 31.
- The ministry said the 20 km belt in Meghalaya bordering Assam will also continue to be a "disturbed area" under the AFSPA with effect from August 3 to September 30.

## NCRB merged with bureau of police research

In a debatable move, the government merged the National Crimes Records Bureau (NCRB) - which, over the years, has been the principal source of reference by policy makers, police, criminologists, researchers and media - both in India and abroad, with the Bureau of Police Research and Development(BPR&D).

- The ministry of home affairs issued an order on Friday evening placing NCRB's functions under the Director General of BPR&D, who will now oversee all the data collection related to Crime in India, Accidental Deaths and Suicides, Prison Statistics and Fingerprints.
- Sources say that BPR&D has been given charge of NCRB so that there is more research based and methodological data collection in future as data collection by NCRB as of now was that of taken from states and sometimes inaccurate.
- It was felt that if the researchers of BPR&D, which conducts its own researches and commissions many to private institutes/bodies to study the crime patterns, policing and other related aspects, and statisticians of NCRB work together, there will be more accurate and research based data collection

## Luxury cars, SUVs to cost more as GST Council approves cess hike

 Sports utility vehicles (SUVs) and luxury cars, which became cheaper after the 1 July rollout of the goods and services tax

- (GST), may cost more with the GST Council, federal indirect tax body, planning to raise cess on them from 15% now to up to 25%.
- The proposal to raise the ceiling of cess covers large motor vehicles with capacity for 10-13 persons, mid segment and large cars, sports utility vehicles, mid segment hybrid cars and other hybrid vehicles, all of which at present attract 15% cess. However, it is not clear if cess will be raised on small petrol cars which at present attract 1% cess and and diesel cars bearing 3% cess, although they fall under the same heading in the tax manual as the other cars.

#### August 15 to be celebrated as 'Sankalp Parva': Govt

- The Centre has decided to observe this Independence Day as 'Sankalp Parva' and asked the people to dedicate themselves to social causes and share their ideas to make a new India.
- Terming 'Quit India Movement' as an important milestone, the government has asked people to take a pledge to create a new India that is strong, prosperous and inclusive.

The Quit India Movement or 'August Kranti' began on August 9, 1942. "Under the leadership of Mahatma Gandhi, people across India, in every village, city, transcending all barriers came together with a common mission to uproot imperialism,

## Justice Dipak Misra to be next Chief Justice of India

- The Union government appointed Justice Dipak Misra as the next Chief Justice of India.
- He will be replacing incumbent Justice J S Khehar, who is set to retire on August 27.
- It was Khehar who had recommended Misra's name to succeed him as the next Chief Justice of India.
- Justice Misra will be sworn in as the 45th Chief Justice of India by President Ram Nath Kovind on August 27.

## Govt launches a new scheme to boost agri startups

 Joining hands with the IIM Ahmedabad, India's premier farm research institute - Indian Council of Agricultural Research (ICAR) - on Friday launched a central scheme to

- promote agri startups in the country.
- The programme known as AGRI UDAAN - Food and Agribusiness Accelerator 2.0 will help select innovative startups to scale up their operations in agri value chain for effective improvement in agriculture.
- This is a six month programme in which short-listed agri startups with promising innovative business models will be mentored and guided to scale up their operations.
- During this period, the startups will be trained in different aspects of technology commercialization, product validation, business plan preparation, risk analysis, customer engagement, finance management and fund raising.

# UP Cabinet changes name of scheme launched by SP government

The Uttar Pradesh
 Cabinet approved renaming of
 another Samajwadi Party (SP)
 government-run scheme, and
 the Samajwadi Sarvhit Kisan
 Bima Yojna will now on be
 known as the Mukhymantri
 Sarvhit Kisan Bima Yojna

- One major rule that has already been done away with vis-a-vis police recruitment is addition of physical test marks in the final results; now on, the marks of physical test will not have any bearing on the final results.
- Previously, physical fitness marks were added to the Class X and Class XII marks. Now on, the recruitment will be done through a written examination, following which a merit list will be made and the physical test will be conducted later.
- The applicants will have to fulfil certain physical test criteria like 4.8 km race, which for women will be 2.4 km.

## Kerala, Haryana top sanitation survey

- The Ministry of Drinking Water and Sanitation released the findings of the survey of 1.4 lakh rural households, undertaken by the Quality Council of India (QCI) between May and June this year.
- The survey, covering 4626 villages across all States and Union territories, claimed that 62.45% of the households had access to a toilet.
- The survey also pointed that 91.29% of the people who had

- access to a toilet also used it, indicating a change in sanitation behaviour.
- Northeastern States of Sikkim, Manipur and Nagaland were top performers with 95% rural households covered by toilets. And so were the Himalayan States of Himachal Pradesh and Uttarakhand with over 90% toilet coverage of the rural houses.
- Interestingly, BJP-ruled Uttar Pradesh and NDA-ruled Bihar were among the worst performers in terms of rural sanitation. In Bihar, only 30% of the rural household had access to toilets while Uttar Pradesh was marginally better at 37%. Another BJP-ruled State, Jharkhand, too scored the same as U.P.

## Coconut regains `tree status in Goa as Assembly passes bill

- The Goa Legislative Assembly passed a bill which reclassifies coconut as a `tree, ensuring legal protection for it.
- Goa Forward Party, a partner in the Manohar Parrikar-led government, had promised to reclassify coconut.
- The previous Laxmikant Parsekar-led government had changed classification of coconut tree to a `palm.

- However, the decision kicked up a controversy as green activists claimed that it would make it easy to cut down coconut trees indiscriminately in the coastal state as it would require no formal permission.
- The Assembly, on the last day of Monsoon session today, passed the Goa, Daman and Diu (Preservation of) Trees Act, 1984 to regulate felling of coconut trees and reclassify it as tree.

# NITI Aayog selects 3 States for transformative change in Health & Education sectors

- In a major push to competitive, cooperative federalism, NITI Aayog, today,
- announces partnership with three States each to radically transform their Health and Education sectors.
  - NITI Aayog has selected Uttar Pradesh, Assam, and Karnataka to improve healthcare delivery and key outcomes in these States. In Education, Madhya Pradesh, Odisha, and Jharkhand have been selected for support to better learning outcomes.
  - The six States have been chosen after a rigorous competitive process based on

- comprehensive metrics to determine potential for impact and likelihood of success.
- States were called to, first, express intent of collaborating with NITI Aayog to better their Health and Education indices. States then made presentations for each sector which was assessed by a committee comprised of senior members of NITI Aayog and Health and Education ministries.
- The States highlighted the initiatives undertaken by them thus far, their willingness to accelerate improvement and justified why they should be selected for the institutional support being offered by NITI Aayog.
- This three-way partnership between NITI, State Governments and a knowledge partner for each of the sectors is part of the Sustainable Action for Transforming Human Capital (SATH) initiative of NITI Aayog.

## Panel to make drugs more affordable constituted

 The government has formed a committee in its bid to make drugs more affordable in the country.

- The government has constituted a committee of joint secretaries for ensuring enhanced affordability, availability and accessibility of drugs for the citizens,
- Elaborating on the terms of reference of the committee, the minister said it would suggest ways to make pricing policy in favour of poor patients. The committee would also review the scope of Drugs (Price Control) Order 2013 and suggest ways for strengthening the regulatory provisions of the order.

Gujarat first state to implement coal utilisation between power units

- Setting a precedent, the Gujarat government has issued a tender for power developers to receive cheap coal marked for the state in return for selling coal-based power at less than Rs 2.82 a unit.
  - Through the auction, Gujarat will transfer the coal allocated to power generating stations owned by Gujarat State Electricity Corporation (GSECL) to more fuel-efficient private power plants.
  - The reverse auction would be held in September for

- procuring 1,000 megawatt (Mw) of power. The successful power plant would be selling electricity to the state from October 1 to June 30, 2018
- The move is in line with the initiatives of the central government to ensure fuel availability to stressed power plants.
- The aim is to reduce the cost of fuel for financially ailing distribution companies and ensure effective distribution of domestic coal.

# UP CM Yogi Adityanath flagged off 'Namami Gange Jagriti Yatra' from Lucknow

- Uttar Pradesh Chief Minister Yogi Adityanath flagged off the 'Namami Gange Jagriti Yatra' from his official residence in state capital Lucknow.
- The 'Namami Gange Jagriti Yatra' is being organised by the Uttar Pradesh Home Guards.
- 'Namami Gange Jagriti Yatra' will conclude on September 6.

## India ratifies 2nd commitment period of Kyoto Protocol

 India has ratified the second commitment period of the Kyoto Protocol that commits

- countries to contain the emission of greenhouse gases, reaffirming its stand on climate action.
- In a brief statement, India's Permanent Mission to the UN said that India deposited its Instrument of Acceptance of the Doha Amendment to the Kyoto Protocol under the UN Convention on Climate Change here yesterday.
- With this, India became the 80th country to accept the amendment relating to the second commitment period of the Kyoto Protocol, the international emissions reduction treaty.
- The Kyoto Protocol is an international agreement linked to the United Nations Framework Convention on Climate Change (UNFCCC),
- which commits its Parties by setting internationally binding emission reduction targets.
  - The Kyoto Protocol was adopted in Kyoto, Japan, in December 1997 and entered into force in February 2005.

# PF account to be automatically transferred on job switch

 From next month, your PF account will be transferred automatically when you change

- your job, chief provident fund commissioner V P Joy has said.
- The EPFO has also stepped up efforts to expand coverage, and initial results have been positive.
- PF money should be withdrawn only for major purposes like housing, education of children, or serious hospitalisation.

- The Fifteenth BIMSTEC Ministerial Meeting was attended by His Excellency Mr. Abul Hassan Mahmood Ali,M.P., Minister for Foreign Affairs of the Government of the People's Republic of Bangladesh; His Excellency Lyonpo Damcho Dorji, Minister for Foreign Affairs of the Royal Government of Bhutan; Her Excellency Smt. Sushma Swaraj, External Affairs Minister of the Government of the Republic of India
- The Meeting considered and approved the Reports of the Seventeenth and Eighteenth Sessions of the BIMSTEC Senior Officials' Meetings held in Kathmandu, Nepal on 07 February 2017 and 10 August 2017 respectively.

## Parliament passes Banking Regulation Bill for nonperforming assets

 The Rajya Sabha passed the Banking Regulation (Amendment) Bill, 2017, which

- will enable the government to empower the RBI to direct lender banks to act against big loan defaulters.
- The bill, which amends the Banking Regulation Act, 1949, will replace the Banking Regulation (Amendment) Ordinance, 2017.
- Once it becomes a law, the central government may authorise the RBI to issue directions to the banks to initiate proceedings in case of loan repayment default. These proceedings would be under the Insolvency and Bankruptcy Code, 2016.
- The RBI may, from time to time, issue directions to banks for resolution of stressed assets and may specify authorities or committees to advise banks on resolution of stressed assets.
- Stressed assets are loans where the borrower has defaulted in repayment or where the loan has been restructured (such as by changing the repayment schedule).
- The bill inserts a provision to state that it will also be applicable to the State Bank of India, its subsidiaries, and Regional Rural Banks.

#### Aajeevika Grameen Express Yojana (AGEY) To be launched

- The Government of India has decided to launch a new subscheme named "Aajeevika Grameen Express Yojana (AGEY)" as part of the Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM).
- The Self Help Groups under DAY-NRLM will operate road transport service in backward areas. This will help to provide safe, affordable and community monitored rural transport services to connect remote villages with key services and amenities for the overall economic development of backward rural areas.
- This will also provide an additional avenue of livelihood for SHGs. The basic outline of AGEY was discussed in a meeting of State Transport Ministers of 13 States held in June 2016 at Dharamshala, Himachal Pradesh and all the Transport Ministers had expressed their appreciation of this initiative.
- AGEY will be initially implemented in 250 Blocks in the country on pilot basis with each Block provided upto 6 vehicles to operate the transport services.

- During the current year implementation of the scheme has been so far approved for 52 Blocks in 8 States namely Andhra Pradesh, Jharkhand, Maharashtra, Tamil Nadu, Telangana, Uttarakhand and West Bengal with a total provision of Rs.16.06 Crore of which the Government of India share would be Rs.10.16 Crore. The balance funding would be provided by the respective States.
- The Blocks will be selected by States from among the Blocks where NRLM is being implemented intensively and where mature CBOs are already functioning.
   Backwardness, lack of transportation links and sustainability of service would be the guiding factors in the selection of Blocks and routes.

India's first aviation university to open in UP's Rae Bareli next week

- The country's first aviation university at Fursatganj in Uttar Pradesh's Rae Bareli district is all set for inauguration on August 18.
- Civil aviation minister Ashok Gajapathi Raju, his deputy

- Jayant Sinha, Uttar Pradesh chief minister Yogi Adityanath, Congress vice-president and Amethi MP Rahul Gandhi, among others are expected to attend the inaugural event
- The Cabinet had in 2013 given its approval to the proposal for setting up of the university.
- The Rajiv Gandhi National Aviation University Bill, 2013 had received the assent of the President of India and published in the Gazette of India on September 19, 2013.
- About 26.35 acres of land available with the Indira Gandhi Rashtriya Uran Akademi, an autonomous flying training institute under the central government, was identified for setting up of the RGNAU in its first phase (2013-14 to 2018- 19).
- Fursatganj lies at the border of Rae Bareli and Amethi.
- In line with its objective of promoting aviation teaching and training, RGNAU has signed an MoU with GMR Aviation Academy for Joint PG Diploma in Aviation/ Airport Operations which is an employability oriented program focused at providing trained manpower to the industry, officials said.
- The university is also planning to launch MBA programme in

aviation management in near future, they said, adding RGNAU shall also be affiliating colleges/ institutes for BSc (Hons.) in aircraft maintenance.

## Indian Coast Guard ship 'Shaurya' commissioned in Goa

- Indian Coast Guard ship "Shaurya", the fifth in the series of six 105-metre offshore patrol vessels (OPVs) commissioned in Goa by Union Minister for Petroleum and Natural Gas Dharmendra Pradhan.
- The OPV, which draws 2,350 tonne and is propelled by 9100 kilowatt diesel engine, has been designed and built indigenously by Goa Shipyard Ltd and is fitted with state-of-the-art navigation and communication equipment, sensors and machineries.
- The features include 30mm CRN 91 Naval Gun, integrated bridge system, integrated machinery control system, power management system and high-power external fire fighting system
- The ship will be based at Chennai and operate under the operational and administrative control of Commander Coast Guard Region (East) and will

be deployed extensively for Exclusive Economic Zone surveillance, apart from safeguarding India's maritime interests.

- African elephants are listed as "vulnerable" and Asian
- elephants as "endangered" in the IUCN Red List of threatened species. As per the available population estimates, there are about 400,000 African elephants and 40,000 Asian elephants.

- The railways has earmarked the 3.32 sq km village of Hejjala, with a population of 3,483 people, to develop its Disaster Management Institute and Safety village at a cost of Rs44.42 crore
- The focus is on imparting state of the art training on rescue, medical relief and rolling stock restoration techniques in a classroom and also using various simulated teaching aids. However, it is the practical reproduction of accidents on site and the ensuing rescue operations that are being touted as the big ticket venture.

## India's first online course on Infusion Therapy launched

 A global authority in infusion therapy launched India's first online course on Infusion

- Therapy for nurses, under which it aims to train over 3,000 nurses in the vital medical procedure.
- Announcing the initiative, which will boost nurses even in rural parts of India, INS said that utilising the reach and ease of the digital platform, the course will enable members to access the various infusion therapy modules and presentations through its website.
- Infusion therapy means the administration of a drug intravenously, but the term also may refer to situations where drugs are provided through other non-oral routes, such as intramuscular injections and epidural routes.

 India will host the next steering committee meeting of the proposed 1,814 kilometrelong Turkmenistan-Afghanistan-Pakistan-India

- (TAPI) gas pipeline, senior officials on both sides confirmed.
- The decision was came during the sixth joint Inter-Governmental Committee (IGC) meeting on trade, economic, scientific and technological cooperation.
- The pipeline, that had its ground-breaking ceremony in December 2015, has seen flagging interest since then for a number of reasons. India's effort is to tap Turkmenistan's Galkynysh gasfields, which are the fourth largest in the world.
- The Turkmenistan— Afghanistan—Pakistan—India Pipeline (TAPI), also known as Trans-Afghanistan Pipeline, is a natural gas pipeline being developed by the Asian Development Bank.
- The pipeline will transport
   Caspian Sea natural gas from
   Turkmenistan through
   Afghanistan into Pakistan and
   then to India. Construction on
   the project started in
   Turkmenistan on December
   13th, 2015. The pipeline is
   expected to be operational by
   2019.
- The abbreviation TAPI comes from the first letters of those countries. Proponents of the project see it as a modern continuation of the Silk Road

# Cabinet approves creation of a single non-lapsable corpus fund

- The Union Cabinet chaired by the Prime Minister Shri Narendra Modi has accorded its approval today for the creation of a non-lapsable pool in the Public Account for secondary and higher, education known as "Madhyamik and Uchchtar Shiksha Kosh" (MUSK) into which all proceeds of "Secondary and Higher Education Cess" will be credited.
- The funds arising from the MUSK would be utilized for schemes in the education sector which would be available for the benefit of students of secondary and higher education, all over the country.
- The major benefit will be enhancing access to secondary and higher education through the availability of adequate resources while ensuring that the amount does not lapse at the end of financial year.
- Ongoing Rashtriya Madhyamik Shiksha Abhiyan Scheme and other approved programs including: National Means-Cum-Merit Scholarship Scheme and National Scheme for Incentives to Girls for Secondary Education.

# India opens first Partition museum 70 years after bloody event

- In the 70 years since India and Pakistan were created from the former British Empire, there has never been a venue focused on the stories and memorabilia of those who survived that chaotic and bloody chapter in history until now.
- A new museum on the Partition of the Indian subcontinent opens this week, as the two South Asian giants mark seven decades as independent nations.
- The exhibitions, housed in the red-brick Town Hall building in the north Indian border city of Amritsar, include photographs, newspaper clippings and donated personal items meant to tell the story of how the region's struggle for freedom from colonial rule turned into one of its most violent episodes, as communal clashes left hundreds of thousands of Hindus, Muslims and Sikhs dead and another 15 million displaced from their ancestral homes.

Karnataka launches 'Indira Canteen' in Bengaluru

- 'Indira Canteen', aimed at serving the poor at subsidized rates, was inaugurated in Bengaluru on Wednesday by Congress vice president Rahul Gandhi.
- Mr. Gandhi, who had the first breakfast at the canteen in Jayanagar, said 'Indira Canteens' would serve the migrants who came to Bengaluru with a dream to build something. "No person in Bengaluru should ever go hungry and the canteens are a great means towards it," he said, asking the government to give much attention to cleanliness and taste.
- Chief Minister Siddaramaiah said that Indira Canteens was a continuation of the Congress's commitment to a hunger-free Karnataka.

# Govt extends tax exemption for industry in North East, hilly states

- As many as 4,284 industrial units in the North East and the Himalayan States will get GST relief in the form of a refund of Central share of CGST and iGST.
- The Cabinet Committee on Economic Affairs (CCEA) on Wednesday gave its nod for a new scheme to refund the Central share of Central GST (CGST) and integrated GST (iGST) to these units in lieu of the excise exemption lost due to the onset of goods and services tax (GST) and scrapping of excise laws from July 1 this year.
- The 4,284 eligible industrial units were granted excise duty

- exemption for the first 10 years after commencement of commercial production under the North East Industrial and Investment Promotion (NEIIPP) 2007 and package for special category States for Jammu & Kashmir, Uttarakhand and Himachal Pradesh to promote industrialisation.
- Under the scheme, if the Centre collects, say, Rs.100 in the form of CGST and iGST, then the aggregate refund will only be Rs.58, that being the Centre's share under the devolution formula approved by the Finance Commission

# Cabinet clears stalled Bihar dam project

- The Union Cabinet has decided to revive the North Koel Reservoir Project, stalled since 1993, and claims it will irrigate over 40,000 hectares in some of the most backward and drought-prone regions in Jharkhand and Bihar.
- However, the centre piece of the project, the Mandal dam, will be made smaller than proposed and capacity reduced by up to 85%, to accede to environmental and forest norms.
- The dam threatened to submerge portions of the Betla

- National Park and the Palamau Tiger Reserve and in its truncated avatar will cause only "minimal" submergence of the reserve
- The National Wildlife Board cleared the project two months ago but imposed conditions.
- A 24 MW power project that was to be part of the original design has also been scrapped.

# MyFASTag apps launched by NHAI

- National Highways Authority of India has launched two mobile Apps, MyFASTag and FASTag Partner.
- These mobile apps will help in the availability of FASTags for Electronic Toll Collection.
- The cumbersome method of purchase and recharge of FASTags has been one of the major challenges. The mobile Apps launched will ease the process, making it possible to buy or recharge FASTags at the click of a mobile button.
- MyFASTag is basically a consumer App that can be downloaded from the App Store for both Android and iOS systems.
- A consumer can purchase or recharge FASTags on this App.
- The App also helps to keep track of transactions and

- provides for online grievance redressal
- From 1st October 2017, all lanes of all 371 NHAI toll plazas in the country will become FASTag enabled. One lane in every toll plaza will be a dedicated FASTag lane where no other form of payment will be accepted.

# CCEA approves proposal of DIPAM for strategic disinvestment

- The Cabinet Committee on Economic Affairs, CCEA has approved the proposal of Department of Investment and public Asset Management, DIPAM for the strategic disinvestment.
- The approval will help in speedy completion of strategic disinvestment transactions.
- The department will set up an alternative mechanism comprising of the Finance Minister, Minister for Road Transport and Highways and Minister of Administrative Department, to decide on the matters relating to terms and conditions of the sale from the stage of inviting of Express of Interests till inviting of financial bid.

 It will also empower the Core Group of Secretaries to take policy decisions with regard to procedural issues and to consider deviations as necessary from time to time for effective implementation of decisions of CCEA.

## Navika Sagar Parikrama: Indian Navy's all women team to circumnavigate globe

- A six-member all-woman team of the Indian Navy will set sail in early September to circumnavigate the globe on the sailing vessel, INSV Tarini. This is the first-ever Indian circumnavigation of the globe by an all-woman crew.
- Titled Navika Sagar Parikrama, the voyage will begin from Goa in the first week of September and culminate on their return in March next year. The distance will be covered in five legs, with stop overs at four ports — Fremantle (Australia), Lyttelton (New Zealand), Port Stanley (Falklands) and Cape Town (South Africa).
- INSV Tarini is a 55-foot sailing vessel, which has been built indigenously, and was inducted in the Navy early this year.

## SDMC launches 'terminator train'

- A special train called the 'mosquito terminator' was pressed into service on Friday by the South Delhi Municipal Corporation (SDMC), in collaboration with the Northern Railway, to spray anti-larval chemicals along the tracks to control mosquito breeding.
- To fight vector-borne diseases such as dengue and chikungunya, insecticide will be sprayed using power sprayers, which will be attached to trucks placed on the train.
- The power sprayers will allow the insecticide to be sprayed around 60 metres on both sides of the track.

## Defence Ministry approves delegation of powers to Border Roads Organisation

- The Ministry of Defence has decided to delegate administrative and financial powers to the Border Roads Organisation (BRO) to avoid delays on account of references between the Chief Engineer, HQ DGBR and the Ministry.
- The Defence Ministry intends to bring transformational

- changes in the organisation in order to improve the pace of execution of works and to achieve desired outcomes according to the requirement of the armed forces.
- Enhancing the powers at all levels in the BRO, the Ministry of Defence has now approved that for both departmental and contractual mode of execution, a chief engineer of the BRO can accord administrative approval up to Rs. 50 crore, ADGBR up to Rs. 75 crore and DGBR up to Rs. 100 crore.
- The Ministry of Defence has approved policy guidelines based on which the BRO may engage big construction companies for taking up road projects on a turnkey basis.
- It is expected that with a delegation of powers by the Ministry of Defence to the BRO, the pace of road construction in border areas would improve and the BRO would be able to complete ongoing and new projects in compressed timelines.

#### Cloud seeding begins in Karnataka

 The cloud seeding experiment taken up at cost of Rs.35 crore, called Project

- Varshadhari, began on Monday.
- This cloud seeding operation, a first in Magadi and Ramanagaram, aims to condense small water particles by clouds (size less than 10 microns) to droplets of 50 microns, which can constitute rains.
- The flight for cloud seeding -BQ-100 Beechcraft - was scheduled to take off from Jakkur Airport at 2.45 p.m.
- The flight is expected to a onehour sortie and will spray Silver Iodide, Sodium Chloride and Potassium Chloride to condense the water particles.
- A committee, comprising meteorologists, experts in cloud physics and hydrologists, will monitor the process.

# Home Minister Rajnath Singh launches digital police portal

- A digital police portal under the CCTNS project, which aims to create a national database of crimes and criminals, was launched by Home Minister Rajnath Singh.
- The police portal will provide 11 searches and 46 reports from the national database for state police and central investigation agencies.

- Central investigating and research agencies have also been provided logins to the digital police database to access crime statistics
- Crime and Criminal Tracking Network and Systems Project (CCTNS) has enabled 13,775 out of 15,398 police stations to enter 100 per cent data into the software.
- The CCTNS project will interconnect about 15,398 police stations and additional 5,000 offices of supervisory police officers across the country and digitise data related to FIR registration, investigation and chargesheets in all police stations.
- This would lead to development of a national database of crimes and criminals, the official, privy to the development

- The Vizag Digital Dhan Sankalp project is an initiative spearheaded by the Government of Andhra Pradesh and Visa, to develop Visakhapatnam into India's first "less-cash" city.
- Visa and bank partners will focus on driving the digitization for a range of key use cases determined to significantly boost the rates of cashless payments.

## SC strikes down instant triple talaq

 The Supreme Court banned on Tuesday a controversial Islamic practice of instant divorce as arbitrary and unconstitutional, in a landmark verdict for gender justice that will stop Muslim men calling off a marriage on a whim.

- In a split verdict, three of the five all-male judges on the case said the practice of saying "talaq", or divorce, three times in one go – sometimes even over email and WhatsApp – violated women's right to equality and was not integral to Islam.
- The dissenting note came from Chief Justice of India JS Khehar and justice S Abdul Nazeer, who argued instant talaq should be suspended and the government asked to bring a law to regulate the practice within six months. The majority verdict overrides the minority view.
- Muslim men in India can still divorce using two other forms of talaq that have a threemonth cooling off period.
- Muslim women usually divorce using a practice called Khula. Instant talaq, or "talaq-ebiddat", is banned in 22 Muslim-majority countries, including Pakistan, for being sinful and arbitrary.

## Cabinet Approves Indo-Nepal MoU On Prevention of Illicit Trafficking in Narcotic Drugs

 The Union Cabinet chaired by the Prime Minister Narendra Modi has given its approval for

- signing of a Memorandum of Understanding (MoU) between India and Nepal on Drug Demand Reduction and Prevention of Illicit Trafficking in Narcotic Drugs and Psychotropic Substances and precursor chemicals and related matters.
- The MoU indicates the mechanism of information exchange and the competent authorities in the two countries who are responsible for the implementation of the MoU and exchange of any information.
- Cooperation on drug matters is expected to curb the illicit traffic of narcotic drugs, psychotropic substances and precursor chemicals in the two countries.
- The MoU provides that the parties shall endeavour to develop mutual cooperation with a view to resolve the issue of illicit traffic in narcotic drugs, psychotropic substances and their precursors.
  - It also aims to exchange information of operational, technical and general nature in drug matters, exchange literature on their existing laws, rules, procedures, best practices and methods of curbing illicit trafficking in narcotic drugs, psychotropic substances and their

precursors and any further amendments to the existing legislation.

# Cabinet approval for panel to study quotas within OBC quota

- The union Cabinet approved the setting up of a commission to examine the subcategorization of almost 5,000 castes in the central list of Other Backward Classes (OBCs) to ensure a "more equitable distribution" of reservations in central government jobs and educational institutions.
- Under Article 340 of the Constitution, the President would be recommended to constitute a commission that would examine the central list of OBC and sub-categorise it.
- The proposal is that there will be sub-categorisation within the OBC list for the purposes of central government employment,

- Mentor India is aimed at maximizing the impact of Atal Tinkering Labs, possibly the biggest disruption in formal education globally.
- The idea is to engage leaders who will nurture and guide students in the Atal Tinkering Labs. These labs are nonprescriptive by nature, and mentors are expected to be enablers rather than instructors

#### Right To Privacy Is Fundamental Right Under Constitution, Declares Supreme Court

- A nine-judge bench of the Supreme Court has ruled that Indians enjoy a fundamental right to privacy, that it is intrinsic to life and liberty and thus comes under Article 21 of the Indian constitution.
- The bench, led by Chief Justice J.S. Khehar, pronounced a unanimous judgement even if the judges had slightly different arguments as to how privacy is intrinsic to right to life and liberty.
- The bench comprised Chief Justice Khehar and Justices J. Chelameswar, S.A. Bobde, R.K. Agrawal, Rohinton Nariman, A.M. Sapre, D.Y.

- Currently, many of the 90-plus RPOs and PoEs function from rented offices and the implementation of Videsh Bhavans in different state capitals is expected to cut costs besides ensuring improving efficiency and hastening delivery of services.

## CCEA nod to rename food processing scheme as PM Kisan Sampada

- The Cabinet Committee on Economic Affairs (CCEA) today approved renaming the new central food processing scheme SAMPADABSE 4.95 % as Pradhan Mantri Kisan Sampada Yojana (PMKSY) with an aim to benefit 20 lakh farmers and generate 5.30 lakh jobs by 2020.
- The objective of the PMKSY is to supplement agriculture by promoting processing and reducing farm wastage.
- The scheme with an allocation of Rs 6,000 crore is expected to leverage investment of Rs 31,400 crore
- The CCEA today approved a proposal to rename the scheme SAMPADA as PMKSY for the period 2016-20 coterminous with the 14th Finance Commission cycle,
- The PMKSY will promote setting up of food processing units to boost availability of processed food items in the domestic market and for export purpose. The scheme will encourage creation of modern infrastructure with efficient supply chain management from farm gate to retail outlet.

### National Sports Museum to be established in New Delhi

- The Ministry of Youth Affairs and Sports is going to establish National Sports Museum, first of its kind, at Jawaharlal Nehru Stadium, New Delhi.
- Museum will showcase India's achievements in sports and also focus on the traditional sports within the country.
- The aim of the Museum is to popularise the sports as a way of life within the country. Accordingly, the proposed Museum would go beyond the classical approach of a collection of memorabilia to become an interactive venue of interest for all age groups.
- In addition, Shri Goel said, it will display achievements of the Indian greats in sports and also act as an educational hub and offer opportunity for the young to delve into some sporting activity.

## Government finalises new cadre policy for IAS, IPS officers

 The new policy for cadre allocation has been finalised by the Central government for IAS, IPS and other officers, aimed at ensuring "national

- integration" in the country's top bureaucracy.
- Officers of all-India services -the Indian Administrative Service (IAS), Indian Police Service (IPS) and Indian Forest Service (IFoS) -- will have to choose cadres from a set of zones instead of states. The new policy will seek to ensure that officers from Bihar, for instance, will get to work in southern and north- eastern states, which may not be their preferred cadres
- Under the new policy, candidates appearing for the civil services examination-conducted annually by the Union Public Service Commission -- will have to first give their choices in a descending order of preference from among the various zones.

### Govt restricts import of gold, silver items from South Korea

- The government restricted imports of gold and silver items from South Korea in a bid to check spurt in inbound shipments of precious metals from that country.
- The importers will now have to obtain a license from the Directorate General of Foreign Trade (DGFT) for importing gold and silver from South Korea.
- These restrictions are being imposed against the backdrop of sudden surge in imports of precious metal from South Korea, with which India has a

- free trade agreement since January 2010.
- Gold imports from South Korea has jumped to USD 338.6 million between July 1 and August 3 this year. The import in 2016-17 stood at USD 70.46 million.
- Imports of gold from non-FTA countries, attract 10 per cent customs duty.
- India is the world's second biggest gold consumer after China. The imports mainly take care of demand by the jewellery industry.
- The collections from customs duty and IGST from imports post implementation of GST has almost doubled to Rs 30,000 crore in July.

## KSTDC announces special Golden Chariot packages for Dasara

- India is a global diamond polishing hub where 14 out of every 15 rough diamonds in the world are polished. At the launch, the first diamond contract for delivery in November was traded at Rs 3,279/cent. One cent is the one-hundredth of a carat (ct).
- ICEX has launched 1 ct diamond futures contract for delivery in November and followed by contracts with monthly settlements.
- 50 cents and 30 cents contracts will be introduced after making the initial contract successful.

- The 1-carat contract for expiry in November, December and January will have delivery centre at Surat. The merger of Ahmedabad-based National Multi Commodity Exchange (NMCE) into ICEX was also announced.
- ICEX will soon approach the National Company Law Tribunal (NCLT), Ahmedabad, to initiate the merger procedure. After merger clearance, ICEX would automatically get approval for the launch of some agricultural commodities like rubber, coffee.
- ICEX will offer HVS2 quality diamond certified by the International Institute of Diamond Grading & Research (IIDGR), a De Beers group company, and vaulting services will be offered by Malca Amit.

#### Narendra Modi inaugurates `hanging bridge' in Kota

- Prime Minister Narendra Modi threw open to traffic Rajasthan's first six-lane cable stayed (CS) bridge in Kota via video conferencing from Udaipur
- The bridge, over Chambal River, has the longest main span of 350 metre in the

- country and will also act as a bypass to Kota City.
- Meanwhile, large LED screens had been put at the bridge to broadcast the PM's speech from Udaipur and a large number of people arrived at the bridge to witness the ceremony.
- This bridge will reduce commuting time by 60 minutes through National Highway no 27 (Kota-Chittor National Highway) and National Highway no 12 (Kota-Jhalawar NH).

### Gobindobhog rice gets geographical indication status

- Gobindobhog rice,a speciality from Burdwan district of West Bengal, has got the geographical indication (GI) status. The state government had applied for GI status for Gobindobhog rice on August 24, 2015.
- The region of Burdwan (now divided into the districts of east and west Burdwan) is known as the rice bowl of Bengal. As a result of getting the GI tag, as the certification is also called, rice from other regions or rice of other varieties cannot be branded as 'Gobindobhog'. he marketability of the rice would be strengthened, for the local, national and international markets, government officials said.
- This variety of rice is primarily cultivated in east Burdwan district - in the southern basin of the Damodar river in the

Raina 1, Raina 2 and Khandaghosh blocks. Gobindobhog was cultivated in an area of 35 hectares last year. Of this, 20 hectares were spread over f Raina 1 and Raina 2 blocks.

 The south Damodar belt has been the traditional area of Gobindobhog rice cultivation.

### Room rent in hospitals exempted from GST

- Rent paid by patients for hospital rooms will be exempted from the Goods and Services Tax (GST),
- Issuing clarifications on levy of GST on the tariff for various accommodation services, the Central Board of Excise and Customs (CBEC) said the tax on rooms in the hotel, guest house or inns will be payable on the actual amount charged and not on declared or
- No GST is applicable on room tariffs of less than Rs 1,000.

### India-Bhutan trade & transit pact come into force

- India and Bhutan mutually decided to bring into force the 'new' bilateral Agreement on Trade, Commerce and Transit with effect from this July 29, an official statement said on Monday. The new agreement will further strengthen the bilateral trade relations between India and Bhutan, it said.
- The agreement provides for a free trade regime between the territories of India and Bhutan. The agreement also provides for duty-free transit of Bhutanese merchandise for trade with third countries. It was last renewed on July 29, 2006 for ten years. The validity of this agreement was extended (with effect from July 29, 2016) for one year or till the new agreement comes into force, through exchange of diplomatic notes.
- The new agreement was signed on November 12, 2016, and as per its provisions, the

pact was to come into force on a mutually decided date.

### John Kelly Sworn In as White House Chief of Staff

- John Kelly was sworn in as President Donald Trump's new chief of staff Monday, tasked with bringing order to an often chaotic White House and jumpstarting the President's stalled legislative agenda.
- Republicans on Capitol Hill hope Kelly, a retired United States Marine Corps general known for his fastidious nature, will bring order to a White House where disorder -in the eyes of those on the Hill -- has led to few legislative victories and slumping poll numbers.

### Shahid Khaqan Abbasi elected as interim Pakistan PM

- Shahid Khaqan Abbasi was elected as the interim Prime Minister of Pakistan by the National Assembly. He will be taking over from Nawaz Sharif, who was disqualified by the Supreme Court over the Panama Papers scandal.
- Abbasi will be sworn in later at a special ceremony at the President's House, where

- President Mamnoon Hussain will administer the oath to him.
- He first entered into politics after the death of his father Khaqan Abbasi, who was the Minister of production at that time.
- Abbasi won from Rawalpindi in 1988 as an independent candidate. He was reelected in 1990 and became the Parliamentary Secretary for Defence. He also was the Chairman of Standing Committee of National Assembly on Defence.

### China opens first overseas base in Djibouti

- China has formally opened its first overseas military base in Djibouti with a flag raising ceremony and military parade.
- More than 300 people attended Tuesday's ceremony, including deputy Chinese naval commander Tian Zhong and Djibouti's defence minister
- The event was timed to coincide with the celebration of the 90th anniversary of the establishment of China's military, the People's Liberation Army, on August 1.
- China began constructing a base in Djibouti last year. It will be used to resupply navy ships taking part in

- peacekeeping and humanitarian missions off the coasts of Yemen and Somalia, in particular.
- Home to only around 800,000 people, Djibouti also hosts troops from US, France and Japan.
- Djibouti is a tiny barren nation sandwiched between Ethiopia, Eritrea and Somalia. It is at the southern entrance to the Red Sea on the route to the Suez Canal.

## India and Somalia sign agreement on transfer of sentenced persons

India and Somalia on Tuesday signed a bilateral agreement for the transfer of sentenced persons, thus deepening humanitarian cooperation between the two countries.

The agreement was signed between External Affairs Minister Sushma Swaraj and Foreign Minister of the Federal Republic of Somalia Yusuf Garaad Omar.

The agreement will help Indian inmates imprisoned in Somalia or vice versa be near their families while serving the remainder of their sentence and also facilitate their social rehabilitation.

### BRICS trade ministers meet concludes in Shanghai

- The two-day meeting of the BRICS (Brazil, Russia, India, China and South Africa) trade ministers was held in Shanghai
- A six-member delegation led by Commerce and Industry Minister Nirmala Sitharaman participated in the August 1-2 meeting.
- The ministers adopted seven documents at the conclusion of the meeting and that includes trade in services cooperation roadmap, e-commerce cooperation initiative and framework on strengthening the economic and technical cooperation, and outlines for BRICS investment facilitation.

### Donald Trump signs Russia sanctions Bill into law

- U.S. President Donald Trump has signed legislation imposing new sanctions on Russia into law,
- The U.S. Congress voted last week by overwhelming margins for sanctions to punish the Russian government over interference in the 2016 presidential election, the annexation of Ukraine's Crimea and other perceived violations of international norms.

- The new law allows Congress, which passed the measure to punish Russia over interference in the 2016 U.S. presidential election and the annexation of Ukraine's Crimea, to halt any effort by Trump to ease sanctions on Russia.
- His hands were tied after the Republican-controlled Congress approved the legislation by such a large margin last week that any presidential veto of the bill would have been overridden.

### US issues ban on tourist travel to North Korea

- The United States issued a ban prohibiting its citizens traveling to North Korea, a move triggered by the death of a US
- student imprisoned by Pyongyang during a tourist visit.
- The ban, which comes into effect September 1, was introduced after officials said the "serious risk" of arrest by Pyongyang officials during tourist travel presented an "imminent danger to the physical safety" of its citizens.
- "All United States passports are declared invalid for travel to, in, or through the DPRK unless specially validated for such travel,"

### Iran's Hassan Rouhani sworn in for second term

- Iran's President Hassan
   Rouhani vowed to continue his
   efforts to end the country's
   isolation as he was sworn in for
   a second term on Thursday by
   supreme leader Ayatollah Ali
   Khamanei.
- However, his inauguration came less than 24 hours after fresh sanctions were imposed by US President Donald Trump, who has threatened to tear up the nuclear deal entirely.
- Rouhani, a 68-year-old moderate who has faced fierce criticism from conservatives for his efforts to rebuild ties with the West, issued a call for unity.

### Qatar to approve permanent residency for some expats

- Qatar plans to allow some expatriates to obtain permanent residency
- A draft law approved at a cabinet meeting will allow permanent residence to the children of Qatari women married to non-Qataris, as well as expatriates who provide outstanding services to Qatar
- Gulf Arab countries have a high number of expatriate workers but do not allow naturalisation

of foreigners, except in rare cases.

- Japan on Sunday marked 72 years since the world's first nuclear attack on Hiroshima, with the nation's traditional contradictions over atomic weapons again coming into
- The anniversary came after Japan sided last month with nuclear powers Britain, France and the US to dismiss a UN treaty banning atomic weapons, which was rejected by critics for ignoring the reality of security threats such as North Korea.
- Japan is the only country to have suffered atomic attacks, in 1945.

### Dhaka to open diplomatic station in Chennai

- Bangladesh will soon open a new diplomatic station in Chennai.
- The new post was likely to focus on medical tourism and educational centres that drew thousands of Bangladesh citizens to India every year.
- The main focus of the new diplomatic station in Chennai will be to address the needs of Bangladeshi citizens who visit India for medical and educational purposes.
- Medical treatment, especially super-specialty treatment of kidney, eye and neurological issues available in southern India, is the best in the region, which draws our citizens to India in large numbers. This has helped build a strong people-to-people bond

 Bangladesh at present has a High Commission in Delhi, two Deputy High Commissions in Kolkata and Mumbai, and two Assistant High Commissions in Guwahati and Agartala. The outpost in Agartala was the latest to be upgraded in the past decade.

### Qatar offers visa-free entry to 80 countries, including India

- Qatar announced on Wednesday a programme to allow visa-free entry for citizens of 80 countries to encourage air transport and tourism amid a two-month boycott imposed on the Gulf state by its neighbors.
- Nationals from dozens of countries in Europe and elsewhere including India, Lebanon, New Zealand, South Africa, and the United States will now receive tourist visas on arrival to the gas-rich country which hosts the soccer World Cup in 2022.

## India placed at 43rd among 45 nations in global innovation index

 In a global retirement index of 43 countries, India has ranked the lowest.

- The index by French asset management company Natixis Global, ranks countries on the basis of four factors -- the material means to live comfortably in retirement; access to quality financial services to help preserve savings value and maximize income; access to quality health services; and a clean and safe environment.
- On all four, India has ranked the lowest. Switzerland, Norway and Iceland top topped the ranking.
- The index ranks 43 countries which include International Monetary Fund (IMF) advanced economies, members of the Organization for Economic Cooperation and Development (OECD) and the BRIC countries (Brazil, Russia, India and China).
- India ranks 43rd in this year's GRI and has the same score compared to last year but its sub-indices all rank in the bottom five.

### Indian Film Festival of Melbourne 2017

#### India, Russia to Hold Major Tri-Service 'Indra' Combat Exercise in October

- In the midst of evolving security situation in the region, India and Russia will hold a mega war game in October involving their armies, navies and the air forces for the first time to further ramp up military ties.
- The exercise Indra, which will be held in Russia from October 19 to 29, will primarily focus on achieving coordination between forces of the two countries in a tri- services

- integrated theatre command scenario
- It will be for the first time India will participate in a tri-services exercise with a foreign country with such a large scale participation by the Navy, the Army and the Air Force
- The armies, navies and air forces of Russia are holding bilateral exercises separately but this is for the first time, both the countries will carry out a tri-services exercise.
- Russia has been a longstanding defence partner of India and both the countries are now eyeing to further deepen the ties.

### Kenya election: Uhuru Kenyatta defeats Raila Odinga

- Kenya's President Uhuru Kenyatta has been re-elected following Tuesday's election, officials say.
- Mr Kenyatta, in office since 2013, took 54.3% of votes, ahead of his rival Raila Odinga, with 44.7%.
- However, it has been endorsed by international observers.
- Mr Kenyatta said they had ensured a "free, fair and credible election".

## UN declares Somalia free of polio

- The UN World Health
   Organisation (WHO) said on
   Sunday it had not recorded any
   case of polio disease in
   Somalia in the last three years,
   declaring the country polio
   free.
- The WHO said the country recorded the last case of polio

- in 2014 in the central part of the country but has since then remained free of the paralyzing disease.
- The UN health agency, however, warned Somalia remained vulnerable, calling for continued vaccination campaign,
- The declaration by WHO keeps Somalia outside the last group of countries which still record cases of polio in the world.
- Afghanistan, Nigeria and Pakistan are the remaining countries where polio is still being recorded. The WHO chief warned Somalia remains at risk of importation of the virus from these countries.
- Norway has the fastest mobile internet in the world: Ookla
- According to global leader in broadband testing Ookla, Norway has the fastest mobile Internet in the world. In only 13 months, Norway has jumped from 11th to first place on the list of world best providers of fast Internet connection
- The development has been specially noticed after Telenor, a major operator in Norway, increased the speed on individual subscriptions last September. Telenor is one of the three operators in Norway that have built their own

- mobile networks which other operators are hiring.
- The Netherlands and Hungary are ranked number two and three on the list of the world's fastest mobile networks.

- US President Donald Trump has signed a memo ordering the Pentagon to ban an Obama-era plan of recruiting transgender individuals in the military,
- Trump directed the Secretary of Defense, Secretary of Homeland Security with respect to the US Coast Guard, to return to the longstanding practice on military service by transgender individuals that was in place prior to June
- 2016.The memorandum has requested the Pentagon to develop an implementation
- develop an implementation plan for the ban by February 21, 2018, which should be put in place on March 23, 2018.

Taiwan Launches First Homegrown Satellite From US Air Base

- It is a white crystalline powder mostly used in the pharmaceutical and dye industries, lubricants, lubricants, construction

# Kenya just imposed the world's toughest law against plastic bags

 Kenyans producing, selling or even using plastic bags will risk imprisonment of up to four years or fines of \$40,000 from Monday, as the world's

- The East African nation joins more than 40 other countries that have banned, partly banned or taxed single use plastic bags, including China, France, Rwanda, and Italy.
- Many bags drift into the ocean, strangling turtles, suffocating seabirds and filling the stomachs of dolphins and whales with waste until they die of starvation.
- Kenya's law allows police to go after anyone even carrying a plastic bag.

## U.N. nuclear watchdog opens uranium bank in Kazakhstan

- The International Atomic Energy Agency, the U.N. global nuclear watchdog, opened a uranium bank in Kazakhstan, a \$150-million facility designed to discourage new nations from enriching the nuclear fuel.
- The Low Enriched Uranium (LEU) Bank in the city of Oskemen, in eastern Kazakhstan, will store up to 90 tonnes of the fuel, enough to power a large city for three years, and sell it to IAEA members if they are unable to procure it elsewhere.
- The LEU Bank will serve as a last-resort mechanism to provide confidence to countries that they will be able to obtain LEU for the manufacture of fuel for nuclear power plants in the event of an unforeseen, noncommercial disruption to their supplies
- Russia has operated a similar bank since 2010 but the one in

Kazakhstan will be the first one fully owned and operated by the global nuclear watchdog.

# Lebanon gets first animal protection law

- Lebanese President Michel Aoun on Tuesday signed the country's first animal welfare bill into law, guaranteeing that domestic and wild animals will be legally protected from abuse.
- The bill is the culmination of years of lobbying for the protection of animals in the Mediterranean country,
- The law, passed by parliament on August 16, outlines requirements for keeping domestic pets, regulations for zoos and pet shops, and penalties for violations -including jail time and fines.
- It also outlaws abusing pets or owning wild or endangered animals.
- The trade of rare animals is big business in Lebanon, where prized tigers and lions are often locked in cramped cages, forced to perform in circuses, and paraded by wealthy individuals as status symbols.
- Other countries in the Middle East, including Tunisia and Qatar, also have animal welfare legislation, although

enforcement continues to present a challenge.

### RBI cuts repo rate by 25 bps to 6%, loans may get cheaper

- The Reserve Bank of India (RBI) cut interest rates, in line with what the Street was expecting. Repo rate the rate at the which the central bank lends short-term money to banks was cut by 25 basis points to 6 per cent from 6.25 per cent. RBI's move comes on the back of inflation running well below its target for consecutive quarters. The central bank had last cut key rates in October 2016.
- The current rate of 6 per cent is the lowest since November 2010.

- The RBI also cut reverse reporate -- the rate at which the central bank borrows money from commercial banks by 25 basis points to 5.75 per cent from 6 per cent.
- Marginal Standing Facility
   (MSF) rate -- the rate at which
   banks borrow overnight funds
   from RBI against approved
   government securities -- and
   the bank rate were also
   adjusted to 6.25 per cent.
- SBI also informed the stock markets that it had cut MCLR (marginal cost of funds based lending rate) or its key lending rate, by 90 basis points effective January 1, 2017, on the strength of large inflows in savings and current accounts after demonetisation.

#### RBI widens Basel-III-compliant asset base of banks

- Ahead of the implementation of the stringent capital requirements under the Basel-III regime from 2019, the Reserve Bank today amended a slew of previous regulations on the same, helping banks shore up their capital buffers and improve liquidity coverage ratios.
- Accordingly, the new amendments widen the assets of banks such as the excess

- CRR; excess G-secs holdings in SLR; and also excess g-secs under marginal standing facility, which all would now be included in the stock of liquid assets without any limit as also without applying any haircut, the central bank said in a notification.
- The liquid stock will also include marketable securities issued/guaranteed by foreign sovereigns which have only 0 per cent risk weight under the Basel II standardised approach for credit risk; actively traded repo or cash markets operations with zero risks, reserves held with foreign central banks in excess of the reserve requirement.
- Other term deposits with the central bank are not eligible for this. However, if the term expires within 30 days, the term deposits could be considered as an inflow, the RBI circular added.

- The panel, under the chairmanship of former law secretary T K Viswanathan, would suggest measures for

improvement in PIT (Prohibition of Insider Trading) norms, PFTUP (Prohibition of Fraudulent and Unfair Trade Practices) regulations and mainly related to 'trading plans' and handling of "unpublished price sensitive information' during takeovers.

- It would be responsible for recommending steps to align insider trading regulations with Companies Act provisions.
- The committee will suggest short term and medium term measures for improved surveillance of the markets as well as issues of highfrequency trades, harnessing of technology and analytics in surveillance
- The other members of the committee are representatives of law firms, mutual funds, retail and institutional brokers, forensic auditing firms, foreign portfolio investors, stock exchanges, chambers of commerce, data analytics companies and the markets regulator.

#### BigBasket gets nod for FDI in food retail

After Grofers and Amazon
 India, online grocery firm
 BigBasket on Wednesday
 received the government's nod

- for foreign direct investment to undertake retailing of food products, which are manufactured or produced in India
- The start-up, which applied for FDI in September last year, will have to spin off a new entity to start this business since 100% FDI is only applicable for food products manufactured or produced in India, whereas currently BigBasket sells other household products such as soap, shampoos etc through its e-commerce channel.
- Last year, three online commerce firms — Grofers, Amazon and Bigbasket — had applied seeking approval for FDI in food retail with an overall investment of \$695
- million over a period of time with the Department of Industrial Policy and Promotion (DIPP).

#### NCLT approves Airtel-Telenor merger

- The National Company Law Tribunal (NCLT) has approved the proposed merger between Bharti Airtel and Telenor India.
- The tribunal has instructed the companies to hold a meeting of

- equity shareholders and unsecured creditors.
- The Sunil Bharti Mittal-led company had announced in February that it would acquire the business of Telenor India for an undisclosed sum.
- Airtel would take over its spectrum in all seven circles — Andhra Pradesh, Bihar, Maharashtra, Gujarat, UP (East), UP (West) and Assam. It would also acquire its licences and operations, including its employees and customer base of 44 million.
- This would help Airtel augment its overall customer base and network. It will also enable Airtel to bolster its spectrum footprint in the seven circles, with the addition of 43.4 MHz spectrum in the 1800 MHz band.

- Mastercard and PayPal have extended their partnership into Asia Pacific to enhance the consumer experience and make Mastercard a clear payment option with PayPal.

- PayPal will also have the opportunity to give consumers and small businesses across Asia Pacific the ability to cash out funds held in their PayPal accounts to a Mastercard debit card.

#### Kotak Bank launches debit card offer for zero balance account

Lok Sabha passes bill approving merger of associate banks with SBI

- The government said the merger of the five associate banks with the SBI will lead to increased capital base and availability of loan, as the Lok Sabha passed the bill approving the amalgamation.
- The Lok Sabha passed the bill to repeal the SBI (Subsidiary Banks) Act 1959, State Bank of Hyderabad Act 1956 and to further amend the State Bank of India Act, 1955, following the merger of five associates with the parent SBI.
- SBI has come in the list of top 50 banks globally and is ranked at the 45th position.
- The merger will bring about increased capital base and increased ability to give loans. Also, small banks will get access to products like mutual funds
- According to the statement of object and reasons of the State Banks (Repeal and Amendment) Bill 2017, after the acquisition of the subsidiary banks by SBI, the subsidiary banks have ceased to exist and, therefore, it is necessary to repeal the State Bank of India (Subsidiary Banks) Act, 1959 and the State Bank of Hyderabad Act, 1956.
- Five associates and the Bharatiya Mahila Bank became part of State Bank of India

(SBI) beginning April 1, catapulting the countrys largest lender to among the top 50 banks in the world. The five associates that were merged are State Bank of Bikaner and Jaipur (SBBJ), State Bank of Hyderabad (SBH), State Bank of Mysore (SBM), State Bank of Patiala (SBP) and State Bank of Travancore (SBT).

#### MCX gets Sebi approval for launching options contract in gold

- The Multi Commodity Exchange Ltd (MCX) has received markets regulator Securities and Exchange Board of India's (Sebi) approval to launch
- country's first gold options contract soon.
  - In June this year, Sebi allowed options trading in commodities to deepen the market but permitted each exchange to launch options on futures of only one commodity initially.
- Putting in place strict eligibility criteria, Sebi said options could be launched on futures contract of only those commodities that are among the top five in terms of total trading turnover value of previous 12 months.

- Besides, the average daily turnover of underlying futures contracts of such a commodity in past one year should be at least Rs 200 crore for agricultural and agri-processed commodities, and Rs 1,000 crore for other commodities.
- Exchanges have been demanding for long that options trading in commodities be allowed. While Sebi had agreed to permit options trading last year itself, some legal requirements were holding back the move.
- Sebi had also stipulated necessary guidelines with regard to the product design and risk management framework to be adopted for trading in options on commodity futures.

### Canara Bank unveils two new digital services

- State-run Canara Bank unveiled two new digital services for online payments.

- It will facilitate mutual assistance, contribute towards efficient performance of the supervisory functions, and enable effective enforcement of laws and regulations governing the securities markets.

- The MoU was signed by Sebi chief Ajay Tyagi and SEO Iran chairman Shapour Mohammadi here.
- Sebi has signed nearly two dozen bilateral MoUs with the regulators of various jurisdictions. The markets regulator is also a signatory to the multilateral MoU of International Organization of Securities Commissions (IOSCO).
- In order to encourage the exchange of information and assistance, Sebi has been signing pacts with the jurisdictions who are yet to become a signatory to the multilateral MoU of IOSCO.

### IOC buys more US crude; first to purchase Eagle Ford shale oil

- Indian state-refiner IOCBSE 0.41 % bought 1.9 million barrels of US crude in its second import tender seeking oil from the Americas, making it the first Indian refiner to purchase Eagle Ford shale oil
- IOC bought 950,000 barrels of light sweet Eagle Ford shale oil and 950,000 barrels of heavy sour Mars crude for end-October delivery from trading firm Trafigura
- The latest purchase comes after a previous import tender

- where IOC bought 1.6 million barrels of Mars crude and 400,000 barrels of Western Canadian Select.
- Indian refiners have turned their sights to crude from the Americas as they are keen to diversify their crude import sources as arbitrage opens due to global oil supply cuts.

#### SBI gives leg-up to CSR initiatives, adopts 50 villages

- The nation's largest lender State Bank of India launched a CSR initiative, SBI Gram Seva, which will work in the areas of health, education, environment and rural infrastructure.

### Government extends Bhim cash back scheme for merchants till March'18

### Regional rural banks' mergers gets exemption from CCI ambit

 The mergers of regional rural banks that are ordered by the government are now exempt from seeking CCI approval

- The Competition Commission of India (CCI) keeps a tab on unfair business practices across sectors. Mergers and acquisitions beyond a certain threshold compulsorily require clearance from the fair trade watchdog.
- Regional Rural Banks (RRBs) set up under the RRB Act, 1976 -- provide credit and other facilities to small farmers, agricultural labourers and artisans, among others, in the rural areas.
- The mergers of RRBs directed by the government have been exempted from seeking CCI approval. The exemption has been granted for a period of five years.
- The provisions of Section 5 and 6 of the Competition Act would not be applicable for five years on such transactions.

# Banks to pay 3% GST on gold imports: CBEC

- Banks importing gold and precious metals will have to pay 3% tax under the GST which can be claimed as input tax credit
- Central Board of Excise and Customs said banks did not pay any VAT on the import of precious metals previously.

- They only paid customs duty. However, under GST, "3% Integrated-GST is payable on all imports of precious metals in addition to the basic customs duty. IGST paid can be taken as input tax credit by the banks
- Import of gold attracts a 10% basic customs duty. On top of that a 12.5% countervailing duty (CVD) was levied prior to GST.
- Since GST subsumed CVD, hence the GST rate on gold at 3% has to be paid at the time of imports in the form of IGST with effect from 1 July.
- The CBEC also clarified on levy of GST where the total value of a gold ornament is Rs30,000, including Rs2,000 as making charge

## Cabinet approves plans to merge some state-run banks

- The government today decided to set up an Alternative Mechanism to oversee the proposals for consolidation of public sector banks (PSBs) with a view to creating fewer but stronger lenders.
- The Alternative Mechanism will be decided by Prime Minister Narendra Modi, Finance Minister Arun Jaitley said after the Union Cabinet meeting.

- The Cabinet gave in-principle nod to the constitution of the mechanism which will clear proposals of banks for mergers and amalgamation
- The final scheme will be notified by the central government in consultation with the Reserve Bank.

- Walmart and Google are today announcing a new partnership that will enable voice shopping through Google Assistant, Google's virtual assistant that lives on devices like its smart speaker, Google Home. - Other decisions included a nod to two MoUs between India and Nepal. While one MoU will be signed to curb illicit trafficking of narcotic drugs and psychotropic substances between the two countries, another MoU will be signed between the two countries for laying down implementation arrangement on cost sharing, for starting construction of a new Bridge over Mechi River at the Indo-Nepal border.
- The CCEA has also approved the renaming of the new Central Sector Scheme — SAMPADA (Scheme for Agro-

Marine Processing and Development of Agro-Processing Clusters) as 'Pradhan Mantri Kisan Sampada Yojana (PMKSY)' for the period of 2016-20.

## Modi government notifies introduction of Rs 200 note

- The Modi government today notified introduction of new Rs 200 notes, according to a notification in the Gazette of India. The printing process of the new currency is almost over and the Reserve Bank of India (RBI) is likely to circulate them any time now.
- This will be the first ever new note to be introduced by the RBI after the Rs 500 and Rs 2,000 notes introduced post the massive currency culling exercise in November last year.
- According to reports, Rs 200 notes will help bridge the gap between Rs 100 and Rs 500 notes and the RBI believes that they will become a 'very popular' denomination.

### OBC Creamy Layer Bar Raised To Rs 8 Lakh P.A.

- The income limit defining 'creamy layer' for OBC reservation has been raised by Rs 2 lakh per annum even as the Union cabinet today approved setting up of a panel for sub-categorization within the other backward classes for even distribution of reservation benefits.
- The government also ruled out having a relook at the present reservation system.
- The ministry of social justice and empowerment had proposed that OBC families which earn more than Rs 8 lakh per year should be classified as 'creamy layer' - the ceiling which bars members of the other backward classes from availing reservations in employment.

- There had been three revisions of the creamy layer bar. It was fixed at Rs one lakh in 1993 and hiked to Rs 2.5 lakh in 2004 and Rs 4.5 lakh in 2008.
- The present ceiling of Rs six lakh came into being in 2013. Jaitley also announced the decision of the cabinet to set up a commission to work out sub-categorization within other backward classes for a "more equitable distribution of reservation benefits amongst the OBCs".

# Government notifies changes in Banking Regulation Act

- The government has notified the Banking Regulation (Amendment) Act under which it can authorise the RBI to issue directions to banks to initiate insolvency resolution process to recover bad loans.
- The banking sector is saddled with non-performing assets (NPAs) of over Rs 8 lakh crore, of which Rs 6 lakh crore is with public sector banks (PSBs).
- Earlier this month, Parliament had approved the Act, which replaced an ordinance in this regard.
- The government in May had promulgated an ordinance authorising the Reserve Bank of India (RBI) to issue

- directions to banks to initiate insolvency resolution process under the Insolvency and Bankruptcy Code, 2016.
- Following the ordinance, the RBI had identified 12 accounts each having more than Rs 5,000 crore of outstanding loans and accounting for 25 per cent of total NPAs of banks for immediate referral for resolution under the bankruptcy law.
- The loan defaulters identified by the RBI include, Essar Steel, Bhushan Steel, ABG Shipyard, Electrosteel and Alok Industries.

# RBI launches Rs 200 note; promises to ramp up supply

- The Reserve Bank today launched the bright yellow Rs 200 notes and said it will shortly ramp up the supply of the new currency note across the country.
- Long queues of people were witnessed at RBI offices today to get the new Rs 200 currency note that has been introduced for the first time by the central bank.
- As per the new policy on theme-based currency notes, the Rs 200 bill bears motif of Sanchi Stupa to depict India's cultural heritage.

- The base colour of the note is bright yellow, the RBI said.
- The RBI had said that Rs 200 note will provide the "missing link" and ensure optimal mix of currency denominations.
- Prior to the introduction on the new notes, India has currency denominations of Rs 1, 2, 5, 10, 20, 50, 100, 500 and 2000.
- As such, in the lower end of the denomination series, Rs 200 has been the missing link. The RBI had recently introduced Rs 50 note with a new look and additional security features.

# NPCI approves Spice Digital's operation under Bharat Bill Payment System

- Bill payments is a major component of the retail payment transactions in India, and is characterized by the presence of large number of billers, and aggregators, who provide a variety of payment options to customers.
- According to the Digital Payments 2020 report by Google and Boston Consulting Group, non-cash contribution in the consumer payments segment will double to 40 percent.
- Spice Digital forayed into FinTech space three years ago. Today, SDL's Spice Money is India's leading India stack based FinTech Company.
- In August, 2016 the NPCI launched a pilot project for BBPS with eight BBPS
- operating unit, Spice Digital being one of the chosen units.

# IRDAI launches central database of insurance sales persons

- The Insuranace Regulatory and Development Authority of India (IRDAI) has launched a Central Database of all Insurance Sales Persons in the country.
- Christined as `Envoy', the database will esnure that all licensed insurance sales

- persons working for insurers and intermediaries including entities such as insurance agents, broker qualified persons, specified persons of corporate agents, authorised verifiers of web aggregators, point of sales persons (POS) etc do not work with multiple insurers and intermediaries in the same business category.
- At the present stage, Envoy covers POS, specified persons of corporate agents, qualified persons of insurance brokers and authorised verifiers of web aggregators.
- The database also provides a search facility for insurers and insurance intermediaries whereby an applicant insurance sales person's details are queried for a match in the database. Appointment of such a person by the insurer or insurance intermediary shall be taken up only after ensuring that the Applicant does not already figure in the database.

# Jaitley launches BEML's metro manufacturing facility

 Defence Minister Arun Jaitley today launched BEML's third Line ultra modern metro manufacturing facility to enhance the production of

- metro cars for the forthcoming metro projects in India.

- The monetary income will, however, continue to attract the relevant income tax.

- The compensation to employees in the form of money is not a supply. However, fringe benefits are a supply of goods or services and are liable to tax if not exempted
- The fringe benefits are transactions in furtherance of business.

## Scientists just created a flexible bio-glue for healing wounds

- Scientists have developed a super strong, flexible adhesive material inspired by the glue secreted by slugs that sticks to biological tissues – even when wet – without causing toxicity. The "tough adhesive" is biocompatible and binds to tissues with a strength comparable to the body's own
- The key feature of our material is the combination of a very strong adhesive force and the ability to transfer and dissipate stress, which have historically not been integrated into a single adhesive

resilient cartilage

 Slugs secrete a special kind of mucus when threatened that glue it in place, making it difficult for a predator to pry it off its surface.

## Bitcoin 'clone' sees a slow start following split

- Bitcoin's underlying software code was split, generating a new clone called "Bitcoin Cash," but the new virtual currency got off to a slow start due to lacklustre support for its network.
- The initiative was headed by a small group of mostly Chinabased bitcoin miners programmers who essentially operate the bitcoin network who were not happy with scheduled improvements to the currency's technology meant to increase its capacity to process transactions.
- These miners, who get paid in the currency for contributing computing power to the bitcoin network, initiated what is known as a "fork" on Tuesday, where the underlying blockchain splits into two potential paths, creating a new digital currency.
- Bitcoin's split has created a new competitor to the original digital currency, which remains the oldest and most valuable in circulation.
- Yet only a small fraction of bitcoin miners have been contributing their computing power to the new blockchain, and it took nearly six hours for

the first batch of Bitcoin Cash coins to be mined this afternoon, according to Blockdozer Explorer, a firm providing data on digital currencies.

# Google's Internet Saathi programme reaches 100,000 villages

- American Internet giant, Google India said that it has reached a milestone of 100,000 villages with its Internet Saathi programme which was launched as a pilot in Rajasthan in July 2015 along with Tata Trusts.
- Google will also be expanding the program in two new states
   Haryana and Bihar.
- Live in ten states in India, 25,000 fully trained Internet Saathis are working everyday across these villages to help women and children learn about the Internet. In total, over 10 million women have gained from the programme
  - In Haryana, the program has already started to roll out and will be covering around 1000 villages and in Bihar the programme has kicked off from Ramnagar, Bagaha, Lauria, Manjha and Chakai villages and we will be covering over 7000

villages expanding it further later in the year.

#### Israel Launches Its First Environmental Research Satellite

- The first Israeli satellite for environmental research was launched from the European spaceport in Kourou, French Guiana. The satellite is a joint effort by the Israel Space Agency, under the aegis of the Science and Technology Ministry, and the French Space Agency (CNES) and was built in Israel by Israel Aerospace Industries.
- It is considered the smallest satellite of its kind in the world, and is built to survey and monitor large areas to study soil, vegetation, forests, agriculture, water and air quality and other aspects of the environment.
- The satellite, which weighs only 265 kilograms and was launched on a Vega platform, was dubbed Venus, an acrostic that stands for Vegetation and Environment monitoring on a New (μ) Micro-Satellite.

#### Army launches app for soldiers

- The Indian Army has developed a mobile application through which serving soldiers can track details like postings and promotions, an army official said on Wednesday.
- Through the 'Humraaz' app, soldiers can also view their monthly salary slips and the Form 16 and also download them.
- The mobile app has been developed in-house by the Army and will be launched in the second week of August for prompt communication of information to junior commissioner officers and other personnels.
- The Aadhar details will be verified with the Army database over (National Information Centre) NIC cloud and he will get a one-timepassword on his registered mobile number.

## India's first private missile production facility unveiled

 India's first private sector missile sub-systems manufacturing facility, a joint venture between the \$2.5 billion Kalyani Group and Israel's Rafael Advanced Defence Systems Ltd., was inaugurated near Hyderabad

- To begin with, the Kalyani Rafael Advanced Systems (KRAS) plant will make antitank guided missile (ATGM) Spike and the production is expected to begin in a few weeks, Kalyani Group chairman Baba N. Kalyani said. Besides supplying to the Indian Army, the plan is to export to South East Asian countries
- Formed in line with the 'Make in India' initiative of the Centre and the policy to encourage private sector participation in defence production, the 51:49 joint venture will develop a wide range of advanced capabilities.
- These include command control and guidance, electrooptics, remote weapon systems, precision guided munitions and system engineering for system integration. The plant would employ more than 300 engineers and provide indirect employment to 1,000 people.

#### Microsoft ties up with Telangana to provide AI-based eye care solutions

Microsoft is going to help the government of Telangana use artificial intelligence to provide eye care screening for children in the

State.

As part of the agreement, Microsoft's cloud based machine learning eye care screening Microsoft Intelligent Network for Eyecare (MINE) will align with the Rashtriya Bal Swasthya Karyakram programme under the National Health Mission. MINE is a global consortium of eye care providers, research and academic institutions that will apply artificial intelligence to help in eye care delivery.

Microsoft system can predict whether a lasik, cataract or other surgery is going to be successful for a given patient or not. It is now also able to predict how a patient's refractive error is going to progress over time.

For the new partnership with Telangana, the idea is that Insights derived from MINE will help make early interventions and prevention through treatment of refractive errors in children. This partnership will also offer access to Microsoft's cloud based analytics to derive insights from all the health screening programmes being run for infants to 18-year-old students.

## Hubble detects Exoplanet with glowing water atmosphere

- An international team of researchers, led by the University of Exeter, made the new discovery by observing glowing water molecules in the atmosphere of the exoplanet WASP-121b with NASA's Hubble Space Telescope.
- In order to study the gas giant's stratosphere - a layer of atmosphere where temperature increases with higher altitudes - scientists used spectroscopy to analyse how the planet's brightness changed at different wavelengths of light.

Water vapour in the planet's

- atmosphere, for example, behaves in predictable ways in response to different wavelengths of light, depending on the temperature of the water. At cooler temperatures, water vapour in the planet's upper atmosphere blocks light of specific wavelengths radiating from deeper layers towards space.
  - WASP-121b, located approximately 900 light years from Earth, is a gas giant

But at higher temperatures, the water molecules in the upper atmosphere glow at these wavelengths instead.

- exoplanet commonly referred to as a 'hot Jupiter', although with a greater mass and radius than Jupiter, making it much puffier. The exoplanet orbits its host star every 1.3 days, and is around the closest distance it could be before the star's gravity would start ripping it apart.
- This close proximity also means that the top of the atmosphere is heated to a blazing hot 2,500 degrees Celsius – the temperature at which iron exists in gas rather than solid form.

# Low-cost, highly sensitive blood test for cancer detection developed

- Stanford scientists have developed a low-cost and highly sensitive blood test that may quickly detect cancer growth and spread.
- The test, called single-colour digital PCR, can detect genetic mutations in minute amounts of DNA released from cancer cells into the blood.
- The highly sensitive test requires only a fraction of a tube of blood and can detect as few as three mutation-bearing molecules in a single reaction, researchers said.
- It has the potential to be personalised to recognise mutations unique to any individual cancer,
- In contrast, molecular tests like the one we have developed will enable patients to be monitored at every visit, and thus have the potential for quickly tracking cancer growth and spread

## Tata Power introduces QR code for bill payment

#### NASA Successfully Launches Latest Communications Satellite

NASA's Tracking and Data Relay Satellite-M (TDRS-M), which is the third and final in a series of next generation communications satellites, has successfully been placed into orbit following separation from an United Launch Alliance (ULA) Atlas V rocket. TDRS-M launched Friday at 8:29 a.m.

- EDT from the Cape Canaveral Air Force Station in Florida.
- Ground controllers report the satellite is in good health at the start of a four-month checkout in space by its manufacturer, Boeing.
- NASA will conduct additional tests before putting TDRS-M into service early next year. When ready, TDRS-M will become part of NASA's Space Network providing navigation and high-data-rate communications to the International Space Station, NASA's Hubble Space Telescope, rockets and a host of other spacecraft.
- The mission of the TDRS project, established in 1973, is to develop, launch and deliver data communications relay spacecraft to support NASA's Space Network, which provides high-data-rate communications and accurate navigation.
- The TDRS-M spacecraft is effectively identical -- in both function and performance -- to the TDRS-K and -L spacecraft launched in 2013 and 2014, respectively.

## UK scientists create world's smallest surgical robot to start a hospital revolution

 British scientists have developed the world's smallest surgical robot which could transform everyday operations

- for tens of thousands of patients.
- From a converted pig shed in the Cambridgeshire countryside, a team of 100 scientists and engineers have used low-cost technology originally developed for mobile phones and space industries to create the first robotic arm specifically designed to carry out keyhole surgery.
- The robot, called

Versius, mimics the human arm and can be used to carry out a wide range of laparoscopic procedures – including hernia repairs, colorectal operations, and prostate and ear, nose and throat surgery – in which a series of small incisions are made to circumvent the need for traditional open surgery.

- This reduces complications and pain after surgery and speeds up recovery times for patients.
- The robot is controlled by a surgeon at a console guided by a 3D screen in the operating theatre.

Twitter launches digital education programme for media agency professionals in Asia Pacific

### India Gets Its Own Sniper Rifle From West Bengal's Ishapore

 After using German sniper rifles Heckler & Koch for decades, India got its own sniper rifle from Ordnance Factory Ishapore in West Bengal. The new rifle is likely to eliminate country's dependence on importing rifles from other manufacturers abroad.

- Kolkata Police will be introducing it to services after it is tested by a group of commandos.
- The Ishapore sniper costs Rs.2.5 lakh plus taxes.
- The rifle has a calibre of 7.62 mm and weighs 6.7 kg.
- The rifle can shoot the target up to 800 Metres.
- The biggest advantage of the rifle is the abundance of indigenous ammunition.
- Kolkata Police will be introducing it to services after testing.
- Ishapore Ordnance Factory received orders from Central Reserve Police Force, Haryana and Rajasthan Police.
- The rifle will be important for urban police for VIP protection, hostage situations and terror attacks.
- The research and development for the sniper was done at Ishapore for more than a year.
- The factory also produced INSAS rifle which is used by many forces.
