Recruitment of Assistant Engineer/Electrical cadre and Assistant Engineer/Civil cadre in Haryana Power Utilities viz. HVPNL, HPGCL, UHBVNL & DHBVNL based on score of GATE-2017 (Graduate Aptitude Test in Engineering- 2017)

1. Haryana Power Utilities (HPUs) i.e. Haryana Vidyut Prasaran Nigam Limited (HVPNL), Haryana Power Generation Corporation Limited (HPGCL), Uttar Haryana Bijli Vitran Nigam Limited (UHBVNL) & Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL) are carrying the work of Transmission, Generation and Distribution of electricity in the State of Haryana. Haryana Power Utilities (HPUs) have decided to undertake recruitment of Assistant Engineer/Electrical cadre & Assistant Engineer/Civil cadre against the available vacant posts meant for direct recruitment as on 31.05.2017 based only on the merit of GATE-2017 score conducted by Indian Institute of Technology, Roorkee in the month of February, 2017.

Haryana Power Utilities (HPUs) viz. Haryana Vidyut Prasaran Nigam Limited (HVPNL), Haryana Power Generation Corporation Limited (HPGCL), Uttar Haryana Bijli Vitran Nigam Limited (UHBVNL) & Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL) invites applications for the post of Assistant Engineer/ Electrical cadre and Assistant Engineer/ Civil cadre from the eligibles, who have qualified/ cleared the GATE-2017 exam and fulfills the qualification criteria of the HPUs as given in para-2 below.

2. The essential qualification of various disciplines with respective code of GATE- 2017 paper for the post of Assistant Engineer/ Electrical cadre and Assistant Engineer/ Civil Cadre is given here under:-

Gen- General Category, SC- Schedule Castes, BC- Backward Classes, EBP(G)- Economically Backward Persons in General Category, ESM- Ex-servicemen, OSP-Outstanding Sports Persons, PwD- Persons with Disabilities.

### 4. Reservations / Relaxations / Concessions:

- i. Reservation / Relaxation / Concession, wherever applicable, are applicable to Haryana domicile candidates only, subject to reservation policy.
- ii. The benefit of reservation will be given to those SC/BC/EBP(G)/PwD/ESM and OSP candidates who are domicile of Haryana State only.
- iii. Candidates belonging to reserved categories of states, other than Haryana, shall be considered as General category candidate and treated against Un-reserved vacancies.
- iv. The reservation of posts for different categories is governed by the instructions of State Government of Haryana as issued from time to time.
- v. Reservation / Relaxation / Concession wherever applicable, is subject to the submission of attested copy of certificates in the format prescribed by Government of Haryana and issued by the Competent Authority, alongwith the application form. The original certificates shall be checked at the time of verification/ checking of documents.

## 5. Persons with Disabilities:

- i. Only such Persons with Disabilities (PwD) of Haryana Domicile would be eligible for reservation in service/posts who suffer from not less than 40% (40 percent) of relevant disability.
- ii. PwD candidates of Haryana Domicile shall be given reservation, age relaxation & fee concession, as per Government of Haryana directives.
- iii. PwD candidate would have to submit a Disability certificate issued by Competent Authority in the format prescribed by Government of Haryana alongwith the application form. The original certificates shall be checked at the time of verification/ checking of documents.

## 6. Nigam/Corporation Candidates:

- i. Nigam/Corporation Candidates of HPUs in order to be eligible for direct appointment as Assistant Engineer are also required to qualify in the corresponding paper of GATE- 2017.
- ii. Nigam/Corporation candidates of HPUs fulfilling the eligibility criteria can also apply for the above posts.
- iii. The Nigam/Corporation candidates of HPUs are required to apply and forward their application to respective Utility through proper channel on or before closing date of application i.e.31-08-2017.
- iv. Nigam/Corporation candidates of HPUs should attach a copy of the ID card issued by respective Haryana Power Utility, along with the application form.
- v. The names of only such eligible Nigam/Corporation candidates of HPUs forwarded by respective HPUs shall be considered for selection. Mere forwarding of name does not make an employee eligible for selection.
- vi. Nigam/Corporation candidates of HPUs are not exempted from Application fees.
- vii. In case of selection of Nigam/Corporation candidate no benefit of past service rendered in Nigam/Corporation will be admissible. He/ She be treated as fresh entrant for all intent and purposes.

#### 7. Ex-Servicemen:

- i. Upper Age limit is relaxable for an ex-military person whether he joined military service before or after the declaration of emergency to the extent of his military service added by three years provided he had rendered continuous military service for a period of not less than six months before his release and further provided that he had been released otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.
- ii. If suitable ESM of Haryana are not available only then dependent sons/daughters of ESM will be considered against the posts reserved for ESM.
- iii. The dependents of ESM candidates will be considered General Category candidates for all intents and purpose.
- iv. The dependent sons/daughters of ESM who fulfil all conditions of qualifications, age etc. prescribed for posts will be considered on merit for the posts reserved for ESM to the extent of non-availability of suitable ESM candidates. This entitlement would be available to one dependent child only.
- iv. Candidates claiming dependent sons/daughters of Ex-Servicemen must submit the latest eligibility certificate issued by Secretary, Zila Sainik Board, Haryana (specifically indicating the name of post for which the candidate is applying) in support of their claim alongwith the application form. The original certificates shall be checked at the time of verification/checking of documents.
- v. Mere dependent certificate will not be entertained.
- vi. None of the persons mentioned below shall fall within the definition of word "Dependent of Ex-Servicemen":
  - (a) A person may be unemployed at the time of making the application but he may have other source of income viz. from agriculture, trade, property, bank balance etc.
  - (b) A person may be working on adhoc basis on the post advertised or somewhere else.
  - (c) A person who is a member of Joint Hindu Family and remains dependent upon the Karta till there is partition in the family or he ceases to be a member of the Joint Hindu Family and is obliged to pass on all his income to Karta and draws money for his subsistence from the pool of the Joint Hindu Family with the consent of the Karta.
  - (d) A person who is a member of the Joint Hindu Family is employed on adhoc basis but he is otherwise dependent on his father.
- vii. The dependents of ESM are required to pay the fees as applicable for Gen, SC, BC & EBP(G) category candidates as the case may be.

### 8. Reservation for freedom fighters & their children/ grandchildren of Haryana:

- i. The reservation will be applicable only if quota reserved for Ex-Servicemen or Backward Classes remain unfilled to that extent due to non-availability of suitable Ex-Servicemen or their dependents or non-availability of suitable candidates from Backward classes.
- ii. Overall reservation either from the unfilled vacancies of Ex-Servicemen or from the Backward classes for Freedom fighters/their children/grandchildren will remain limited to 2% only.
- iii. This benefit will be available to grandchildren i.e. sons or daughters of sons and daughters (Paternal as well as Maternal) of the Freedom Fighters.

#### 9. AGE LIMIT:

Eligibility of age limits is as on last date of submission/ receipt of application form i.e. 31.08.2017. The age limit for the post of Assistant Engineer is 20 to 42 years.

## 10. RELAXATION IN AGE LIMIT (FOR CANDIDATES OF HARYANA DOMICILE ONLY):

The relaxation in age limit is admissible to candidates of **Haryana Domicile only.** Upper age limit is relaxable as admissible under rules/registrations/instructions of HPUs/ Haryana Government. Relaxation in age in different categories, subject to the condition that the candidate is meeting other eligibility criteria for the post, is as given below:

**Note:-** If benefit of age relaxation is admissible to a candidate for more than one of the categories mentioned above, then benefit shall be considered only for one of those categories which allows maximum age relaxation to the candidate.

The upper age limit is relaxable upto 45 years for the candidates belonging to the following categories:-

- a) Unmarried female candidates of Haryana State Only.
- b) Women whose husbands have been ordered by civil/criminal courts to pay maintenance to them; women whose husbands have remarried; windows; women who are legally separated from their husbands or have been divorced; women living separately from their husbands for more than two years because of desertions; wives of serving disabled military personnel and widows of those who are were killed in action. Women living separately from their husbands due to desertion will be required to submit with her application, an affidavit to the effect that she has been deserted by her husband and has been living separately from him for more than two years and this affidavit should be countersigned by two responsible persons such as members of the Legislatures, Local Bodies including Panchayats and Bar Association where however, a woman who has re-married she would not be eligible for the above concession in the matter of age.

## 11. STUDENTS APPEARING IN FINAL YEAR/SEMESTER:

No person (including students appeared/ appearing in final year/ semester in session 2016-17) shall be eligible to be appointed as Assistant Engineer Electrical cadre and Assistant Engineer Civil in Haryana Power Utilities i.e. HVPNL, HPGCL, UHBVN & DHBVN unless he holds the essential qualification certificates issued by the concerned authority prescribed for the posts from a University established/ recognized by Central Government or a State Government as per Sr. No.2 of the advertisement on or before closing date i.e. 31.08.2017.

#### 12. SELECTION PROCESS:

- i. The candidates who have acquired the essential qualification as mentioned at Sr.No.2 above and must have qualified the GATE-2017 (Graduate Aptitude Test in Engineering-2017) conducted by IIT, Roorkee in Feb, 2017 in corresponding paper i.e. Electrical Engineering (EE), Mechanical Engineering (ME), Computer Science & Information Technology (CS), Electronics & Communication Engineering (EC) and Civil Engineering (CE) shall only be eligible to be considered for selection.
- ii. The selection of the candidates in each discipline/ category would be done by the HPUs from the eligible candidates as given in para-(i) above, purely on the basis of score of the GATE-2017 (Graduate Aptitude Test in Engineering-2017) in the respective discipline as per requirement of HPUs.
- iii. The qualifying marks in respect of GATE-2017 (minimum cut-off) shall be as declared by GATE-2017 Organizing Institute i.e. IIT, Roorkee for respective GATE Paper/discipline/category given as under:-

- iv. The selection process consists of marks obtained (Normalized Marks out of 100) in the corresponding paper of GATE-2017. No interview will be carried out for the posts being advertised by HPUs. Appointments will be made purely on the basis of merit of the GATE-2017. GATE Score of 2016 or prior will not be valid.
- v. Besides this, Educational qualifications must be from a recognized Institution/ University/ Board.
- vi. In case of GATE-2017 Score of two or more candidates are equal then candidate having more marks in the essential qualification as given in Sr. No. 2 of advertisement would be considered higher in merit. Further, in case of marks in the essential qualification are also equal then candidate older in age would be considered higher in merit.
- vii. The shortlisted candidates numbering 2 times of advertised posts plus 10% waiting list (subject to minimum of 2) for a particular post/ category would be called for verification/checking of original documents/ certificates in order of Merit prepared on the basis of Gate-2017 Score.
- viii. Offer of Appointment will be issued by respective HPUs to the selected candidates in the order of category wise Merit prepared on the basis of GATE-2017 Score & as per the preference indicated by the candidate in the application form and based on the requirement of HPUs.
- ix. Waiting list equivalent to 10% (subject to minimum 2) of the posts advertised for a particular category will be prepared. The persons from the waiting list will be offered appointment only if the person from the main list do not join. The waiting list would be valid for one year from the date of declaration of result in terms of Instruction issued vide memo No. 42/43/84-5GSI dated 20.01.1988 and amended from time to time.
- x. The selected candidates for the post of Assistant Engineer will produce Medical Fitness certificate required for first entry into service from the Civil Surgeon of any district in Haryana State before joining the services.

13. AMOUNT OF FEE (NON TRANSFERRABLE/ NON REFUNDABLE/ NON ADJUSTABLE): The candidate is required to deposit the fee separately for each post applied for as per the details given below:-

- i. The fees is to be paid in shape of Indian Postal Orders (IPOs) or Demand Draft in favor of "AO/ Cash, HVPNL, Panchkula" payable at Panchkula.
- ii. Fees once paid is neither transferable nor refundable / adjustable.
- iii. No concession of fee is admissible to candidates belonging to States other than Haryana.
- iv. PwD candidates of Haryana Domicile only are exempted from payment of fees.
- v. Dependents of ESM are required to pay the fees as for General and SC, BC-A & BC-B candidates of Haryana Domicile as the case may be.
- vi. Application fee for OSP candidates of Haryana domicile is as per their respective category i.e Gen/SC/BC and Gender.

#### 14. GENERAL INFORMATION:

- 1) Only those candidates are eligible to apply as mentioned in para No. 1.
- 2) Before applying, the candidate should ensure that he/she fulfils the eligibility criteria and other norms mentioned in this advertisement, as on the cut off date i.e. **31.08.2017**.
- 3) Essential Qualification should be from a University / Institution duly recognized by Central Government or State Government. The Candidates who have obtained Degrees / Diplomas / Certificates for the various courses from any institution declared fake by the University Grants Commission shall not be eligible for being considered for recruitment to the post advertised.
- 4) The merely holding of prescribed essential qualification does not entitle a candidate for selection.
- 5) Candidates must specify their preference for joining organizations under HPUs in the application form itself.
- 6) All computations of upper age limit shall be as on the cut off date for the said purpose.
- 7) Date of issuance of final marks sheet shall be taken as the date of acquaintance of qualification.
- 8) <u>Correspondence / Part-time Degree</u> shall not be considered.
- Ocandidates are required to send their application form on prescribed format & complete in all respects alongwith necessary documents in support of their claim by 31.08.2017 upto 5:00 P.M (on all working days) in the office of Deputy Secretary, HR&SR (Recruitment Cell), HVPNL, Room No. 230, First Floor, Shakti Bhawan, Sector-6, Panchkula Any Application Form received after the closing date shall not be entertained.
- 10) The original documents/certificates would be checked by HPUs at the time of verification/ checking of documents for the preparation of Selection/ Merit list.
- 11) The certificates pertaining to Domicile/ SC/ BC/ EBP(G) & OSP must be as per the prescribed format of the State Government.
- 12) The selected candidates are required to submit original documents for verification alongwith Character & Antecedents verification forms (which will be supplied with the offer of appointment) to the respective Utility in which he/ she have been selected.
- 13) No TA payment shall be paid to candidates for appearing for the verification/ checking of documents.
- 14) Candidates must have a valid e-mail ID & Mobile Number which shall be entered in the application form. The e-mail ID & Mobile Number entered in application form must remain valid for at least next one year. However, in case of change in e-mail ID & Mobile Number candidate must inform to HPUs failing which HPUs will not be responsible for bouncing back of any email/ message sent to the candidates, if any.
- 15) The necessary information relating to recruitment, if any, will be made available to all candidates only on the websites of HVPNL/ HPUs.

- 16) Percentage of marks in Essential Qualifications as awarded by the University / Institute shall only be considered. Wherever CGPA/OGPA/DGPA or Letter Grade in a degree / diploma is awarded, its equivalent percentage of marks must be indicated in the application form as per norms adopted by University / Institute. Proof of norms adopted by the University/ Institute to convert CGPA/OGPA/DGPA into percentage is to be submitted at the time of verification/ checking of documents, if called for.
- 17) In case the University / Institution does not have any scheme for converting CGPA into equivalent marks or in the absence of any proof of norms/formula, the equivalent percentage would be established by dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100.
- 18) Candidates working in Govt. Departments / PSUs / Autonomous bodies other than HPUs are required to produce "No Objection Certificate" at the time of verification/ checking of documents. No past service benefit to the candidates working in Govt. Departments / PSUs/ Autonomous bodies will be admissible.
- Competent Courts at Panchkula shall have exclusive jurisdiction with respect to any cause/ dispute.
- 20) Eligibility of the candidates can be checked at any stage during/after the selection process. Candidature is liable to be rejected at any stage of recruitment/ selection process or after joining, if any information provided by the candidate is not found in conformity with the eligibility criteria notified or if HPUs comes across any evidence / knowledge that the qualification, experience and any other particulars indicated in application / other forms / formats are not recognized / false / misleading and / or amounts to suppression of information / particulars which should have been brought to the notice of HPUs.
- 21) Canvassing in any form during any stage of recruitment shall lead to cancellation of candidature.
- 22) Mere submission of application to HPUs does not guarantee the adequacy of candidature for being considered for further selection process.
- 23) Applications should be submitted through offline mode only.
