- 1. Appointment is of purely on temporary basis and for six months subjected to the termination on closing of / termination of RKVY project. The candidature of the candidate will be cancelled at any time without giving reason(s) thereof.
- The selected candidate will be required to give an undertaking that he/she will not leave the
  assignment half way and shall complete the work in the prescribed time limit. In this regards
