OTHER ELIGIBILITY CONDITIONS

- a. The Contractual engagement will be subject to medical fitness to perform the assigned duty/ responsibility. Certificate for this purpose will have to be obtained from a Government doctor.
- b. There should not be any departmental proceedings or criminal cases contemplated or pending against them and they should have not been penalized for misconduct during the period up to five years preceding the date of application.

SELECTION PROCESS

Selection will be made through personal interview by a Selection Committee.

TERMS AND CONDITIONS OF ENGAGEMENT

- a. The engagement is purely temporary in nature and on contract basis initially for a period of two (2) years or till the officer attains the age of 68 years, whichever is earlier. The engagement may be extended further depending on satisfactory performance and requirement of OPTCL.

- c. During the period of contractual engagement, he will be entitled to get Traveling Allowance for approved tours in line with the Corporation's prevailing norms.
- d. He will be provided with a CUG SIM of the Corporation.
- e. Wherever required, accommodation will be provided in the residential colony of the Corporation.
- f. The appointee shall perform the duties assigned to him/her by the competent authority. It reserves the right to assign any duties as and when required. No extra/additional allowance will be admissible in case of such assignment.
- g. This is a full time appointment, hence the appointee shall not accept any other appointment paid or otherwise.
- h. The contractual engagement is terminable at any time by giving a notice of one month by either side and in cases of any misconduct including but not limited to misappropriation, negligence or causing loss to the Corporation without any prior notice.
