Services Air India Engineering Limited (AIESL), is an Aircraft Maintenance, Repair and Overhaul (MRO) Organization, approved by DGCA (India) under CAR 145, to undertake MRO activities in India. AIESL, invites applications from Indian Nationals fulfilling the requirements 1st September, 2017 to fill up the posts of "Aircraft Technician and Skilled Trades Men in Upholstery and Painting Trades", on "Fixed Term Employment basis" (FTE). The selected candidates will be posted at Trivandrum, Air India Engineering Services Limited (AIESL, MRO) or any other station/MRO as required by the company. Selection and empanelment does not guarantee that the candidate will be appointed immediately. Release of candidates from the panel would depend upon the requirement of AIESL and decision taken by the company in this regard. Management reserves all rights to take any decision in regard to his exercise.

A) Aircraft Technician

1. Number of Vacancies:

Total estimated present and future Vacancies are as follows, which may, however, vary depending upon change of situation/workload and actual requirement of AIESL.

Distribution of vacancies:

Aircraft Technician : Total 14 (SC = 07, ST = 07)

2. Eligibility Criteria as on 1st September 2017:

AME Diploma/Certificate in Aircraft Maintenance Engineering from Institutions approved by DGCA under Rule 133 B with 60% marks/equivalent grade (55% or equivalent grade for SC/ST/OBC candidates).

Candidates from DGCA Approved AME Training Institute as per current list are who eligible. (Or)

Successful completion of Group 1 related equivalent qualification of Diploma in Engineering for Airframe/Engine/Electrical/Instrument/Radio trades conducted by the Indian Air-force, which are acceptable as qualification by DGCA for fulfilling the eligibility requirement for BAMEL examination. (Or)

Successful Completion of 4 years course *I* Diploma in Aircraft/ Electrical/ Instrument/ Radio Artificer training, conducted by Indian Navy, which are acceptable as qualification by DGCA for fulfilling the eligibility requirement for BAMEL examination.

(Or)

Diploma in Engineering (3Years) in Mechanical/ Electrical/Instrumentation/ Electronics and Telecommunication/ Radio Engineering or equivalent recognized by Central/State Government with 60% marks/equivalent grade (55% or equivalent grade for SC/ST/OBC candidates).

The candidates must have at-least 01 years Aviation experience post-qualification on B737-800 Aircraft Maintenance or B737-800 Aircraft components.

3. Age Limit:

General Category - Not above 35 yrs. as on 1st September, 2017. OBC- Not above 38 Yrs. as on 1st September, 2017. SC/ST- Not above 40 yrs. as on 1st September, 2017.

Ex-Servicemen- Upper age limit of 35 yrs. would be relaxed to the extent the candidate has served in a regular post in Army/Navy/Air Force before retirement/release or discharge from such post plus three years.

3. Age Limit:

General Category - Not above 45 yrs. as on 1st September, 2017. OBC- Not above 48 Yrs. as on 1st September, 2017. SC/ST- Not above 50 yrs. as on 1st September, 2017.

Emoluments:

(For Experienced Aircraft Technician and Trades Men in Upholstery and Painting Trades)

Emoluments will be as per approved salary structure for Technician and will be approximately Rs. 20000/Per Month at the time of joining. The selected candidates would have a career progression in the Company as per the approved career progression for Technicians in AIESL.

Period of Contract:

Fixed term contract initially for a period of 5 years, extendable for further 5 years period at a time as per the requirements of the company and performance of the candidate.

Selection Procedure

Selection would be done on:

- ✓ Walk-In Interview followed by Trade Test
- **✓** Pre-employment Medical Examination.

Candidates will have to bear the cost of the Pre-Employment Medical Examination(s), if may selected and offered appointed.

6. GENERAL CONDITIONS

- a) Candidates found suitable and shortlisted will be engaged on fixed-term contract basis for a period of 05 years. The contract may be terminated at the discretion of the Management during the tenure of the contract and/or in the event of unsatisfactory performance.
- b) The contract is extendable for further term of 5 years and upon satisfactory performance of the candidate and requirement of the company.
- c) The candidates will initially be positioned at *THIRUVANANTHAPURAM* till they obtain authorization to certify B737-800NG aircraft and posted either at Thiruvananthapuram or to any outstation as per the requirement of the company. The job is transferable to any station in India, based on Company's requirement.
- d) The candidates will have to make their own arrangement for housing accommodation at the place of posting.
- e) The Company, at its discretion, may assign additional duties, as and when required.



- f) SC/ST candidates who reporting for Walk-in Interview and residing beyond 80 kms. from the Walk-in Interview and not employed in any Government, Semi-Government / Public Sector Undertaking or Autonomous Bodies, will be reimbursed second class to & fro rail / bus fare by the shortest route as per rules, on production of document of travel.
- g) Candidates must ensure that they fulfil all the laid down procedure eligibility criteria, prescribed for the post before reporting for Walk-in Interview.
- h) At any stage of the selection process, if it is found that the particulars furnished by the candidate in the Application Form or testimonials are incorrect / false or the candidate does not meet the Eligibility Criteria prescribed for the post, or has suppressed any material fact(s), his/her application shall be summarily rejected without making any further reference.

- b) The Applications of the candidates would be scrutinized and prima-facie, after scrutiny if they found eligible then only they will be allowed for walk-in interview.
- c) A recent (not more than three months old) colored passport-size photograph of the full face (front view) should be pasted neatly in the space provided in the Application Form.



- d) The candidates belonging to OBC categories, at the time of walk-in interview, must submit a self-attested photocopy of the Non-Creamy Certificate, recently issued by the Competent Authority, in the format as prescribed by Govt. of India. The Certificate, inter alia, must specifically state that the candidate does not belong to socially advanced sections excluded from the benefits of reservations for OBC in civil posts and services under the Government of India. The Certificate should also contain the "Non-Creamy Layer" Clause. The Certificate produced by the candidates of OBC community should be as per the Central List published by the Government of India and not as per the State Lists.
- e) Applicants ordinarily domiciled in Kashmir Division of J & K State during 01.01.1980 to 31.12.1989 who are eligible for the upper age relaxation, must produce the Domicile Certificate to this effect at the time of Interview from the District Magistrate in the Kashmir Division, within whose jurisdiction the applicant had ordinarily resided or any other authority designated in this regard by the Government of Jammu & Kashmir.
- f) The applicant should ensure that they fulfil all the eligibility criteria as on **01 SEPTEMBER 2017**. Other particulars furnished should be correct in all respects. At any stage of the Selection Process, if the particulars provided by the candidates in the application or testimonials supplied are found incorrect/false, or not meeting with the eligibility requirements prescribed for the post, the candidature is liable to be rejected and, if engaged, services terminated, without giving any notice or reasons therefor.
