- **Ans.92 (C)** The Bharat Parv 2020 will be celebrated from 26th to 31st January 2020. The theme of this year's Bharat Parv is 'Ek Bharat Shreshtha Bharat' and 'Celebrating 150 Years of Mahatma Gandhi'.
- **Ans.93 (B)** The Padma Awards Committee, which is constituted by the Prime Minister every year gives a recommendation for the award. 33 of the awardees are women and the list also includes 18 persons from the category of Foreigners/NRI/PIO/OCI and 12 posthumous awardees.
- **Ans.94 (A)** The 62nd annual Grammy Awards billed as "music's biggest night" took place in Los Angeles on 26th January 2020. The Recording Academy presents the Grammy Award, originally called Gramophone Award to recognize achievements in the music industry.
- **Ans.95 (B)** Maharashtra government launched 'Shiv Bhojan' scheme on 26th January 2020, on the occasion of the 71st Republic Day. The scheme is launched on a pilot basis at an expected expenditure of Rs 6.4 crore.

- **Ans.96 (A)** Sachin Bansal resigned from Ujjivan Small Finance Bank's board "in the interest of propriety and corporate governance as an entity owned and controlled by him has made an application to the Reserve Bank of India for a universal banking license."
- **Ans.97 (B)** The East-West Metro corridor builds under the Government of India entity Kolkata Metro Rail Corporation (KMRC) will have 6 elevated stations and six underground stations. The length of the river crossing is 520 metres and the internal diameter of each tunnel is 5.55 metres.
- **Ans.98 (D)** It can destroy a missile approaching it at a high speed of nearly 11 km per second. The technology placed India at par with the club of three nations- US, Russia and China, which possess this capability.
- **Ans.99 (D)** India-Brazil set a target to achieve \$ 15 billion trade by 2022. 15 MoUs of cooperation has been signed on investments, trade facilitation, social security, agriculture, defence and double taxation etc.
- **Ans.100 (C)** Gujarat is one of the leading producers of Potato in the country, with a productivity of more than 30 tonnes per hectare. In the last two decades, two Global Potato Conferences were organized in 1999 and 2008.
- **Ans.101 (C)** The Vakrangee Limited also Re-designated Dinesh Nandwana, Executive Chairman as the Managing Director and Group CEO in place of Anil Khanna.
- **Ans.102 (C)** The Bhuvan Panchayat V3 web Portal is launched to enhance network application of gram panchayats. The Portal will function with the help of satellite technology developed by ISRO.
- **Ans.103 (D)** The Ramsar Convention is an inter-governmental accord signed on 2nd February 1971 by member countries to preserve the ecological character of their wetlands of international importance. The numbers of Ramsar sites in India are now 37 and the surface area covered by these sites is now 1,067,939 hectares.
- **Ans.104 (B)** Indian Railways has commissioned the country's first governmental Waste to Energy Plant in Mancheswar Carriage Repair Workshop at Bhubaneswar in East Coast Railway. The Waste to Energy Plant is first-of-its-kind in Indian Railways and fourth in India.
- **Ans.105 (B)** The Finance Ministry said that through Pradhan Mantri Kisan Urja Suraksha Evam Utthan Mahabhiyan (PM KUSUM) scheme, the farmers will be empowered to be the producer of energy. PM-KUSUM scheme was launched on 22nd July 2019 under the Ministry of New and Renewable Energy.
- **Ans.106 (A)** The creation of a social stock exchange and electronic transparent fundraising platform for organisations working on social welfare was mooted in the 2019-20 budget proposal. Considering the proposal, the Institutional Trading Platform (ITP) is envisaged with limited trade-ability to select investors.
- **Ans.107 (D)** Martyrs' Day is observed in India every year on 30th January to honour the sacrifices made by the Father of the Nation, Mahatma Gandhi. India is observing 72nd death anniversary of Mahatma Gandhi on 30th January 2020.
- **Ans.108 (B)** Janak Raj has replaced Michael Debrata Patra, who was recently elevated as Deputy Governor of the RBI. The MPC was constituted in 2016 by amending the Reserve Bank of India Act, 1934 with Finance Act (India), 2016 to set the benchmark interest rate.
- **Ans.109 (D)** The limit of termination of pregnancy has been increased from 20 weeks to 24 weeks. The opinion of one provider will be required for termination of pregnancy up to 20 weeks of gestation, whereas the opinion of two providers will be required for termination of pregnancy of 20-24 weeks of gestation.

**Ans.110 (C)** Arvind Krishna has replaced the current CEO Ginni Rometty (IBM's first female CEO, 2012), but she will continue as executive chairman of the board through the end of 2020. The company had also appointed James Whitehurst, CEO of Red Hat, as President at the company, effective 6th April 2020.

**Ans.112 (B)** The World Games announced the Indian women's team captain Rani Rampal as the winner on 30th January after 20 days of polling in January 2020 by sports fans worldwide. She has won the 'World Games Athlete of the Year' award 2019 with a clear majority of 1,99,477 votes.

**Ans.113 (A)** The WSDS has continued the legacy of the erstwhile Delhi Sustainable Development Summit (DSDS) which was initiated in 2001 with the aim of making 'sustainable development' a globally shared goal. The theme of the WSDS 2020 is "Towards 2030: Making the Decade Count".
