### **YOJANA MAGAZINE SUMMARY: APRIL 2021**

## **TOPIC: JAL JEEVAN MISSION**



- The JalJeevan Mission was announced by Prime Minister Narendra Modi in August 2019, the major objective of this mission is to ensure pipe water supply (HarGharJal) to all rural households by the year 2024.
- The priority of the JalJeevan Mission is to provide safe drinking water in all parts of the country.
- Under this mission, attention will also be paid to building local infrastructure for rainwater harvesting, ground water recharge and management of domestic wastewater for reuse in agriculture.
- It is noteworthy that the Ministry of Jalshakti has been appointed as the nodal ministry for the implementation of the JalJeevan Mission.
- Statistics show that India has about 16 % of the world's total population, while only 4 percent of
  potable water is available in the country. At the same time, the effect of climate change on the
  constantly falling ground water and water sources are some other challenges in water conservation. In
  such a situation, it is a big challenge for the government to balance the demand and supply of potable
  water.

#### TAKING WATER TO EVERY HOME AND SOUL:



- Recently, in the 'Mann Ki Baat' program, Prime Minister Narendra Modi has called for a water conservation movement with active participation of the public mind, just like the cleanliness movement.
- Recovering from this crisis is not under government alone. Consumption of drinking water in various
  uses in households, harvesting of rainwater and water recycling will be done at the local, provincial and
  national level in the field of water recycling.
- We have to be determined to avoid zero water situation. The government will have to make it
  mandatory to build small domestic water recycling plants in colonies of multi-storeyed buildings and
  metros, as most of the water is wasted in these areas. These should be strictly prohibited.
- The most important thing is for the public to be self-aware, as it has been said, "Rahim paaniashiye, bin pani subsaun".

#### WATER SECURITY:



- If we consider some facts of water availability and usage in India, only 4%01of the global fresh water source exists in India, which has to provide water to 18 percent (Indian population) of the global population.
- According to the data, around 330 million people (a quarter of the country's population) have been affected due to severe drought across the country after two consecutive years of weak monsoon.

#### **MEASURES TAKEN BY THE CENTRAL GOVERNMENT:**

"JAL SHAKTI ABHIYAN: CATCH THE RAIN" CAMPAIGN



- The campaign implemented in the country from March 22, 2021 to November 30, 2021 (pre-monsoon and monsoon periods).
- The objective of this campaign is to construct rainwater harvesting structures (RWHS) to store the state and all other stakeholders to store rainwater suited to climatic conditions and subsoil levels.

- Under the Union Housing and Urban Affairs Ministry to provide universal coverage of water supply to households through working tap in all statutory cities, as per Sustainable Development Goal-6 (SDG-6) in the Union Budget for the financial year 2021-22 JalJeevan mission (urban) has been announced.
- This is a supplement to the JalJeevan Mission (Rural), which envisages supply of 55 liters of water per person daily to all rural households through a working household tap connection (FHTC) by the year 2024.

### WATER FUTURE IN A CLIMATE RISKED WORLD: THE INDIAN EXPERIENCE



• The 'Union Ministry of Health and Family Welfare' (MoHFW) has implemented the state governments to ensure the availability of clean drinking water and its management during the lockdown to control the spread of COVID-19 in the country. Necessary guidelines have been issued for this.

### **CHALLENGES:**

 Although hand hygiene or keeping hands clean regularly has been considered as an effective way to avoid coronavirus, the lack of clean water for all has been a major challenge for the country for many years.

#### **USHERING SOCIAL REVOLUTION:**



- At present, the agriculture sector is the most exploited water, so if 20-30% of water is saved in agriculture, then it will be a big success in tackling the current challenge of the water crisis.
- Efforts such as drip or sprinkler irrigation and agroforestry should be encouraged to conserve water in the agricultural sector.
- The groundwater level can be improved by stopping the encroachment of natural water resources and increasing the green cover i.e., afforestation.
- There has been an increase in the water used in homes during lockdown, so the water use can be reduced to some extent by promoting the economical use of water in the houses and recycling / reuse of waste water coming out of the houses.
- Promote water conservation by rainwater harvesting at the level of households and housing societies.

With the implementation of stringent laws for industrial water pollution, industries should be encouraged to set up treatment plants for pollution control.

To increase social support towards water conservation through public awareness campaigns.

#### WATER GOVERNANCE:



For 'good water governance ', apart from government, all communities, societies, NGOs (Non-Governmental Organisation), action groups, startups and individual efforts will also have to be integrated.

#### FRAMEWORK FOR RIVER REJUVENATION:



• Since the 1990s, the Central Pollution Control Board (CPCB) has been monitoring the quality of rivers mainly on the basis of Biological Oxygen Demand (BOD). The higher the quantity of BOD, the worse the quality of the river is considered.

#### LATEST DIRECTION

- Despite the Water Act enacted in the year 1974, the water quality of the rivers has been declining.
- The objective of this act was to improve quality at the earliest.

#### **ESTABLISHMENT OF NRRM:**



 According to the suggestion given by the NGT, this system can be called the 'National River Rejuvenation Mechanism' (NRRM). The NRRM may consider establishing an environmental data grid at the national, state, or district level as an effective monitoring strategy.

### **NATIONAL WATER MISSION (2010):**

• It ensures better water resource management for water conservation, less wastage and equal distribution.

### NATIONAL CLEAN GANGA MISSION:

- This mission envisages a five-tier structure at the national, state and district levels to take measures for the prevention, control and reduction of environmental pollution in the Ganges river.
- Its objective is to ensure continuous adequate water flow for the rejuvenation of the Ganges River.

#### NAMAMI GANGE PROJECT:

• It integrates efforts to clean and preserve the Ganges River in a comprehensive manner.

#### **GROUNDWATER MANAGEMENT: A PARADIGM SHIFT**



• India has adequate water availability compared to Israel, but the water management there is much better than India. Recycled water is used in Israel for farming, industry, irrigation, etc., so people do not face a shortage of drinking water there.

#### **SOLUTION:**

- It is essential that we see ground water as a collective resource rather than as an individual resource. Most people think that 'if this land is mine, the water under it will be mine', but until we leave this assumption, proper management of ground water will not be possible.
- Issues such as waterlogging, salinity, use of chemical fertilizers in agriculture and industrial waste need to be given serious attention.





- The Swachh Bharat Abhiyan was launched by the government on 2 October 2014 with an aim to accelerate efforts to focus on universal sanitation in the country.
- It is to be noted that this mission is being executed by two different ministries Ministry of Drinking Water and Sanitation for rural areas and Ministry of Housing and Urban Affairs for urban areas.
- The main reason for dividing the campaign into two parts is that both areas (rural and urban) have different hygiene requirements, which require different approaches.
- The problem of open defecation, whose elimination is the primary objective of the Swachh Bharat Abhiyan, is not limited to rural India alone. While the implementation of total sanitation is a major challenge in rural India, there are some serious challenges on the urban sanitation front, which need to be addressed from a different perspective.

### **JAL SHAKTHI ABIYAN:**



• The Ministry of Personnel and Training of the Central Government has announced the launch of 'Jal Shakti' campaign from July 1, 2019, for the collection and conservation of rainwater in 255 districts of the country facing water scarcity.

### SALIENT FEATURES OF JAL SHAKTI ABHIYAN:

- It focuses on the management of integrated demand and supply of water at the local level, including the creation of local infrastructure for rainwater harvesting, groundwater recharge and domestic wastewater management for reuse.
- It mainly focuses on five aspects:
  - Water conservation and rainwater harvesting.
  - Renovation of conventional and other water bodies / tanks.
  - Development of reuse and recharge structures.
  - Watershed Development.
  - Intensive afforestation.

### INTEGRATED WATER MANAGEMENT FOR FASTER SOCIO-ECONOMIC DEVELOPMENT AND WATER SECURITY:



Why Water Supply Management Program is required?

Indian agriculture has a greater dependence on the monsoon.

- Excess of rainfed areas.
- Due to problems of low income, poverty etc.
- Due to the presence of food insecurity.

### Components of water supply management program

- Promoting crop intensification.
- Promote crop diversification.
- To conserve the land by managing pesticides and nutrients.
- Orient people from agriculture to non-agricultural activities like animal husbandry, beekeeping etc.
- Capacity Building in a particular area.

### NITI AAYOG'S @ 75 STRATEGY AND WATER MANAGEMENT



- In the year 2018, the NITI Aayog had issued a strategy for Abhinav Bharat @ 75, under which it was decided that by 2022-23 India's water resource management strategy should include water for life, agriculture, economic development, ecology and environment. There should be water security facilities to ensure adequate availability.
- Providing adequate and safe drinking water for citizens and animals for sanitation.
- Ensuring proper irrigation system in all farms (water every field) and improving agricultural water utility.
- To ensure the continuous and uninterrupted stream of the Ganges and its tributaries.

#### **ROAD AHEAD**



- The bureaucratic, non-transparent and non-participatory approach still continues in the functioning of water governance institutions in India. Hence, it cannot be denied that there is a need to improve the water administration of the country.
- It is essential that reliable information about natural disasters such as droughts and floods and its data are available to us as soon as possible so that they can be dealt with in time and possible damage can be minimized.
- It is necessary that important decisions regarding raising ground water level and regulating ground water use are taken at the earliest.
- The condition of the rivers in the country remains miserable and the efforts of the present government to make the river Ganga pollution free may not achieve the anticipated success, so it is necessary to seriously consider the situation of the rivers in the country and to make them pollution free. For the above policies should be formulated.

#### THE CONCLUSION:

- Water is the most valuable resource of the earth and we not only have to protect it for ourselves but also to preserve it for future generations. At present, when India as well as the whole world is facing a water crisis, it is necessary to pay serious attention to it. Water management or conservation policies exist in India, but the problem lies in the level of implementation of those policies. Therefore, the implementation of policies should be overcome and the implementation of them should be ensured so that the biggest problem of water mismanagement can be addressed in the country.
- Especially during the COVID-19 epidemic, it is extremely important to ensure safe water supply inside homes. This initiative, which provides water from domestic tap connections in rural India in the form of silent revolution, will prove to be a progressive step towards making India a 'New India'.

### **NURTURING INDIA'S RICH CULTURAL HERITAGE:**





- Micro, Small and Medium Enterprises (MSMEs) have always played an important role in the Indian economy. Currently, about 6.3 crore MSMEs operating in the country not only make a major contribution to the GDP of the country but also provide employment opportunities to a large population.
- Significantly, this sector plays an important role in the stability of the labor market, providing around 110 million jobs. In such a situation, the role of MSMEs has become more important from the point of view of India's economy and economic strategy, with special emphasis on the presently self-reliant India campaign by the government.
- Given the importance of the MSME sector, the Government of India estimated in 2019 that the sector
  would be responsible for half of India's GDP and the creation of about 50 million new jobs in the next
  five years.


• While there were signs of a slowdown in the supply side due to the demand side and the structural reforms like the 'Goods and Services Tax '(GST) due to the COVID-19 epidemic, demonetisation also has a wide negative impact on the MSME sector.

### **MAJOR CHALLENGES OF MSME SECTOR:**



• Significantly, the participation of MSMEs in GDP of Germany and China is 55% and 60% respectively, indicating that India has yet to travel a long journey in this area, some of the major obstacles to the path of progress of MSME are the following:

### FINANCIAL CHALLENGES:



- Lack of credit supply remains a major challenge in the MSME sector in India.
- The formal debt available in this sector is only 16 trillion rupees, due to which there is still a gap of about 20 trillion rupees in relation to the total practical loan requirement (36 trillion rupees) in this sector.

- At the same time, MSMEs in India mostly depend on 'Non-Banking Financial Companies' (NBFCs) or Micro Financial Institutions (MFIs) due to lack of banking access.
- The liquidity crunch in the NBFC sector since September 2018 has further exacerbated the financial challenge of MSMEs.

**Lack of formalization of MSMEs:** A major reason for the credit gap in this sector has been the lack of formalization among MSMEs.

### **TECHNICAL CONSTRAINTS:**



- India's MSME sector is largely based on outdated and obsolete technology, constraining its production capacity.
- The emergence of artificial intelligence, data analytics, robotics and other related technologies (collectively known as Industrial Revolution 4.0) presents a much greater challenge for MSMEs than organized sector enterprises.
- Production Challenges: Most of the MSMEs currently operating in the country are in the micro enterprises category.

### THE ROAD AHEAD:

### **DEVELOPING THE BOND MARKET:**



- Amidst the progress made in the Indian bond market in recent years, the promotion of SME Bonds can boost the participation of MSMEs in debt capital markets.
- While encouraging SME bonds will provide MSMEs with a lower interest rate advantage than other financial intermediaries, these bonds will serve as a viable high return tool for aware and educated investors working in the market.

### **REFORM IN LABOR LAWS:**



- The labor laws currently in force in the country are not very favorable for the development of MSMEs.
- If we truly want MSMEs to have a significant intervention in the economic sector of the country, then it is very important to provide MSMEs with a regulatory framework free from the current complexities that work for them rather than working against them.

#### **WARLIS: LIFE AROUND NATURE**



• Warli painting originated in Maharashtra, it is widely made by the Warli tribe in northern Sahyadri.

#### **CHARACTERISTICS OF WARLI PAINTING:**

- Natural elements are the main attraction in Warli painting, in this painting a mixture of rice paste, gum and water are used to decorate the paintings. The bamboo stick is used as a brush.
- Geometric figures like circles, triangles and squares are used in this painting, as well as many shapes are made in this painting depicting different aspects and beliefs of life.
- The Warli painting shows a close connection between man and nature.

- Rs 4800 crore will be infused in Central Bank of India, Rs 4100 crore in Indian Overseas Bank, Rs 3,000 crore in Bank of India and Rs 2,600 crore in UCO Bank.
- These securities will be issued in six different maturities, and the special securities would be 'at par' for the amount as per the application made by the eligible banks.

Current Context: The World Bank (WB) and Asian Infrastructure Investment Bank (AIIB) approved the loan amount for canal-based drinking water projects in Punjab.

#### **KEY FACTS**

- The loan amount of USD 300 million was approved for the same.
- The canal-based drinking water projects in the state will grant quality drinking water along with minimizing water losses for Amritsar and Ludhiana cities of the state.
- The project will be co-financed by IBRD (International Bank for Reconstruction and Development) of World Bank with the contribution of USD 105 million. The AIIB will contribute USD 105 million and the state government will contribute USD 90 million for the complete project.
- The source of the water for the project in Amritsar will be from Upper Bari Doab Canal.
- The project will be executed to develop a water treatment plant with a capacity of 440 million litres per day. The water treatment plant will be constructed at Vallah village of Amritsar.
- The treated clean water will be pumped to the Over Head Service Reservoirs which will grant water to the entire city.
- Whereas, the source of water for the project which will be developed in Ludhiana will be from Sirhind Canal.
- For this, a water treatment plant of 580 million liters per day capacity will be constructed which will be further provided to Over Head Service Reservoirs to supply water to the city.

- The policy focuses on reducing the cost of treatment for rare diseases, by increasing focus on indigenous research and local production of medicines.
- The policy promotes to have domestic research on medicines to cure rare diseases.
- The aim of the policy will be implemented with the help of the National Consortium which will be set up under the Health Research Department, Health Ministry as convenor.

- The policy also mentions setting up a national hospital-based registry of rare diseases, which will grant adequate data of rare diseases for research and development.
- The policy also focuses on the early screening and prevention of rare diseases through healthcare infrastructure. The screening will be supported by NidanKendras of the Department of Biotechnology.
- Also, the provision for financial support up to Rs 20 lakhs under RashtriyaArogya Nidhi is proposed to cure rare diseases which need a one-time treatment (diseases listed under Group 1 in the rare disease policy).
- It mentions strengthening tertiary health care facilities to offer treatment against rare diseases through 'Centres of Excellence', which will be funded with the one-time financial support of up to Rs 5 crore.

# WEST CENTRAL RAILWAY ZONE BECOMES FULLY ELECTRIFIED

Current Context: The Indian Railway's Western Central Railway zone has become the first fully electrified railway zone in India.

### DRDO DEVELOPED ADVANCED CHAFF TECHNOLOGY

Current Context: The Defence Research and Development Organization (DRDO) has developed advanced chaff technology.

## **DETAILS**

- The advanced chaff technology is developed to protect and safeguard India's naval ships against missile attacks from enemies.
- The technology is developed by DRDO's laboratory called Defence Laboratory Jodhpur.
- The laboratory has developed three variants of technology namely short-range chaff rocket, medium-range chaff rocket and long-range chaff rocket.
- All the variants fulfil the qualitative requirements of the Indian Navy as they conducted the trials for the same in the Arabian Sea.
- Chaff: It is a passive expendable electronic countermeasure technology that is used to protect naval ships from the enemy's radar and RF missile seekers. A small quantity of chaff material, when deployed in the air, acts as a decoy and deflects the enemy's missiles, which keeps the ships safe from enemy attacks.

#### RBI'S BI-MONTHLY MONETARY POLICY

Current Context: The Governor of the Reserve Bank of India (RBI) announced RBI's bi-monthly monetary policy review after conducting the Monetary Policy Committee (MPC) meeting.

## **HIGHLIGHTS**

- Following are the decisions taken by the central bank in the meeting:-
- The RBI's MPC has decided to keep the reporate unchanged at 4% and the reverse reporate stands at 3.35%.
- The MSF (Marginal Standing Facility) rate is kept unchanged at 4.25% and the bank rate is also kept unchanged at 4.25%.
- The real GDP growth for 2021-22 is projected at 10.5%.
- There are revised projections for CPI (Consumer Price Index) inflation to 5% in Q4 of 2021, 5.2%, in Q1 of 2021-22, 5.2% also in Q2 of 2021-22, 4.4% in Q3, and 5.1% in Q4 with risks broadly balanced.
- The inflation target was retained at 4% earlier on March 31, 2021, with a lower tolerance level of 2% and upper tolerance level of 6% for the next 5 years i.e. from April 2021 to March 2026.
- Also, to ensure adequate liquidity in the system so that the sectors get adequate credit, the central bank has decided to have fresh lending of Rs 50,000 to all Indian financial institutions.
- The RBI has announced to increase the centre's Ways and Means Advances by 46% with the current limit of Rs 32,225 crores, which is thus increased to Rs 47,010 crores.
- Also, RBI has announced that prepaid payment instruments and white label ATMs which are regulated by the RBI can now take up direct membership in NEFT and RTGS.

- Whereas, Uttarakhand, Haryana, Tamil Nadu, Kerala, Nagaland, Goa and Maharashtra are termed as states with low vulnerability.

# SUPPLEMENTAL OXYGEN DELIVERY SYSTEM--DRDO

Current Context: The Supplemental Oxygen Delivery System is developed by Defence Research Development Organisation (DRDO).

#### **KEY POINTS**

- The system will be used by soldiers who are posted at extreme high-altitude areas and by COVID-19 patients.
- It is an automatic system that delivers supplemental oxygen based on the SpO2 (blood oxygen saturation) levels and prevents the person from sinking to a state of hypoxia, which is fatal in most cases if it sets in.
- The system is developed by DRDO's lab which is named Defence Bio-Engineering & Electro Medical Laboratory (DEBEL) in Bengaluru.
- The electronic hardware of the system is designed in such a way that it operates at extremely low temperature, low humidity and low barometric pressures.
- The system reads the SpO2 levels of the person through a wrist-worn pulse oximeter. Based on the SpO2 levels, the solenoid valve is adjusted to supply oxygen to the person and thus the system delivers oxygen through nasal nares.
- It supplies oxygen for 750 minutes at a flow rate of two litres per minute and is low in weight.

### RBI FRAMES COMMITTEE TO REVIEW REGULATIONS ON ARCS

Current Context: The Reserve Bank of India (RBI) has set up a six-member committee to review regulations on asset reconstruction companies (ARCs).

# **RBI BANS AMERICAN EXPRESS AND DINERS CLUB**

Current Context: The Reserve Bank has restricted American Express Banking Corp and Diners Club International Ltd from onboarding new domestic customers onto their card networks from 1st May 2021.

#### **HIGHLIGHTS**

- They are restricted because of violating data storage norms.
- Both the entities were authorised to operate card networks under the Payment and Settlement Systems Act, 2007 (PSS Act). And it was found that both the entities were not following the directions on Storage of Payment System Data setup by RBI.
- In April 2018, RBI imposed regulations under the PSS act for the Storage of Payment System Data to payment system providers. The regulation was to ensure that within a period of six months the entire data (full end-to-end transaction details/information collected/carried/processed as part of the message/payment instruction) relating to payment systems operated by them should be stored in a system only in India.
- Also, payment system providers were required to report compliance to RBI and submit a System Audit Report (SAR) conducted by a CERT within Dec 2018.

### RBI FIXED BANK'S MD AND CEOS TENURE AT 15 YEARS

- As per the changes in the rules, RBI has fixed the tenure of MD and CEOs or Whole Time Directors (WTD) of banks to 15 years.

- As per the rules, MD, CEO or WTD who is also a promoter or shareholder cannot serve the post for more than 12 years.
- The RBI has also announced that the upper age limit for MD, CEO or WTD is retained at 70 years.
- The maximum age limit for chairman and non-executive directors (NED) is fixed at 75 years. The total
  tenure of a NED, continuously or otherwise, on the board of a bank, is not allowed to exceed 8 years.
  After completing 8 years on the board of a bank the person may be considered for re-appointment
  only after a minimum gap of three years.

- During the three-year cooling period, the individual cannot be appointed or associated with the bank or its group entities in any capacity, either directly or indirectly.
