#### INTERNATIONAL NEWS

6TH SESSION OF THE INTERNATIONAL SOLAR ALLIANCE ASSEMBLY

- The International Solar Alliance is committed to making solar the energy source of choice and fostering environments conducive to attracting investments.
- It aims to ensure ample energy availability to meet the surging global demands.
- This is indeed a significant step towards a sustainable and renewable future.

THREE INDIAN-ASSISTED DEVELOPMENT PROJECTS WERE JOINTLY INAUGURATED BY PRIME MINISTERS OF INDIA AND BANGLADESH

- The three projects are: Akhaura Agartala Cross-Border Rail Link, Khulna Mongla Port Rail Line, Unit
   II of the Maitree Super Thermal Power Plant:
- The length of the rail link is 12.24 km with a 6.78 km Dual Gauge rail line in Bangladesh and 5.46 km in Tripura, Mongla, the second largest port of

Bangladesh, gets connected with the broad-gauge railway network.

UNESCO NAMED KOZHIKODE AS THE CITY OF LITERATURE AND GWALIOR AS THE CITY OF MUSIC

- This city has a rich literary heritage and is the birthplace of the Malayalam language.
- Gwalior is known for its deep association
  with Hindustani classical music and is the birthplace
  of the influential Gwalior Gharana, a celebrated
  musical tradition.

## INDIA UAE MOU EDUCATION AND SKILL DEVELOPMENT & ENTREPRENEURSHIP

- The MoU aims to strengthen the existing cooperation in the field of educational institutions in both countries.
- The MoU will also facilitate academic collaboration between Higher Education Institutions in both the countries for offering Twinning, Joint Degree and Dual Degree Programmes.



#### HSBC BECAME THE FIRST FOREIGN BANK TO INTRODUCE E-BGS IN INDIA

- This move is aimed at digitizing trade and easing the guarantee issuance process digitally with the introduction of e-stamping and e-signing.
- This facility has been made possible through a collaboration with National E-Governance
   Services Ltd (NeSL), a digital solutions provider.

### INDIA AND ITALY SIGNED THE MIGRATION AND MOBILITY PARTNERSHIP AGREEMENT

- This agreement was signed during External Affairs
   Minister S Jaishankar's visit.
- The aim of this agreement is to facilitate the smooth movement of workers, students, and professionals between the two countries.
- This is a significant step towards strengthening the cooperation between India and Italy.

## INDIA-FRANCE SIGNED LOI IN PUBLIC ADMINISTRATION & ADMINISTRATIVE REFORMS

- The LoI aims to enhance the bilateral cooperation between the two countries in the field of good governance, administrative reforms, digital transformation, public grievance redressal, and other areas of mutual interest.
- The LoI will be valid for three years and will be implemented by a Joint Working Group that will be established under its aegis.

## THE 6TH EDITION OF THE INDIA-KOREA BUSINESS PARTNERSHIP FORUM

- The Secretary of the Department for Promotion of Industry and Internal Trade, Rajesh Kumar
   Singh, highlighted the nation's deep cultural and business ties with South Korea.
- He mentioned that South Korea has always been a trusted trade partner despite the geo-political instabilities around the world.
- He expressed hope that the introduction of a onestop platform and Korea Startup Center will make the nation a key growth partner of India.

## INDIA'S SEA SIGNED MOU WITH BRAZIL'S ABIOVE FOR SUPPLY OF SOYA OIL TO INDIA

- The objective of the MoU is to create a common platform to facilitate the joint interaction of both institutions under the governmental spheres of both countries.
- India is the largest importer of edible oils in the world and imports nearly 15-16 million tonnes of various edible oils, including 3.5 to 4.0 million tonnes of soybean oil, mainly from Latin America.

## MYANMAR-RUSSIA MARITIME SECURITY EXERCISE (MARUMEX)

- The joint exercise took place from November 7 to 9, 2023.
- It included aerial and underwater drills, and maritime security exercises with live firing.
- As a safety precaution, the Myanmar navy warned that ships would be restricted within a 5-mile radius of the exercise area, and aircraft were advised not to fly below an altitude of 15,000 feet during the training days.

## INDIA & NETHERLAND SIGNED MOI TO REGULATE MEDICAL PRODUCTS

- India and the Netherlands have signed a
   Memorandum of Intent (MoI) to cooperate on
   the regulation of medical products.
- This collaboration aims to enhance the quality of healthcare services in both countries.
- The Mol was signed during a meeting of Bhagwant Khuba, Union Minister of State for Chemicals and Fertilisers from India, and Ernst Kuipers, Minister of Health, Welfare and Sports of the Kingdom of the Netherlands.

## INDIAN NAVY AND BANGLADESH NAVY CONDUCTED THE BONGOSAGAR-23

- Ships and aircraft from both navies undertook joint patrolling along the International Maritime Boundary Line (IMBL), and subsequently conducted maritime exercises to enhance interoperability.
- The Indian Navy Ships Kuthar, Kiltan and Maritime
   Patrol Aircraft (MPA) Dornier participated in the



exercise along with Bangladesh Navy Ships Abu Bakr, Abu Ubaidah and MPA.

## THE INTERNATIONAL MONETARY FUND (IMF) EXECUTIVE BOARD HAS APPROVED A 50% QUOTA INCREASE

- This proposal is now set to be considered and made effective by the board of governors as part of concluding the 16th general review of quotas.
- The quota increase is intended to enhance the IMF's permanent resources and strengthen the quota-based nature of the Fund by reducing the reliance on borrowing.

### INDIA AND THE USA SIGNED MOU ON "ENHANCING INNOVATION ECOSYSTEMS"

- The MoU was signed at the kick-off industry roundtable titled, "Decoding the "Innovation Handshake": US-India Entrepreneurship Partnership" in San Francisco.
- The MoU is signed with the objective of connecting the startup ecosystems in the two countries and addressing specific regulatory hurdles to cooperation.
- The MoU signals a joint commitment to strengthen the startup ecosystem in deep tech sectors and promote cooperation in Critical and Emerging Technologies (CET).

## NASA AND ISRO HAVE COLLABORATED TO LAUNCH THE NISAR MISSION

- The mission aims to make global measurements of the causes and consequences of land surface changes.
- It will significantly advance our understanding of the earth's dynamics, natural processes, and climate change impacts.
- The much-anticipated launch of the NISAR Mission is expected to take place in early 2024

#### THE THIRD EDITION OF THE SEA GUARDIAN-3 IS BEING CARRIED OUT IN THE NORTHERN ARABIAN SEA

- The **Sea Guardian-3 exercise** was scheduled from November 11 to November 17, 2023.
- The exercise is dedicated to enhancing the allweather strategic cooperative partnership, boosting

- defense cooperation, and deepening professional cooperation.
- The exercise aims to jointly respond to maritime security threats and safeguard maritime peace.

#### CITY INVESTMENTS TO INNOVATE, INTEGRATE, AND SUSTAIN 2.0 (CITIIS 2.0) CHALLENGE LAUNCHED IN NEW DELHI

- The Government approved the CITIIS 2.0 on 31 May 2023.
- The CITIIS 2.0 has three major components:
- Financial and technical support for up to 18 Smart Cities for projects promoting circular economy with focus on Integrated Waste Management.
- Support to all States/Union Territories (UTs) for Climate action
- Interventions at National level to support scale-up across all cities and towns.
- The period of the program would be for 4 years.

#### UZBEKISTAN'S SAMARKAND INSTITUTE OF ECONOMICS AND SERVICES & UNIVERSITY OF DELHI ESTABLISHED MOU

- The MoU aims to promote cooperation in the fields of economics, management, tourism, and service, as well as to facilitate student and faculty exchange, joint research, and cultural activities.
- The MoU is expected to strengthen the ties between Uzbekistan and India, as well as to contribute to the development of education and science in both countries.

## EXERCISE MITRA SHAKTI-2023 STARTED ON 16 NOVEMBER 2023 IN AUNDH (PUNE)

- The aim of the exercise is to jointly rehearse subconventional operations under Chapter VII of the United Nations Charter, which authorizes the Security Council to take enforcement measures, including the use of military force.
- The joint military exercise "Exercise Mitra Shakti" between India and Sri Lanka focuses on counterterrorism drills.

NASA'S DSOC ACHIEVES "FIRST LIGHT" WITH RECORD-BREAKING DATA TRANSMISSION



- DSOC has achieved a historic milestone, beaming data via laser over a record-breaking distance of 400 million kilometers (250 million miles), marking a transformative leap in deep space communication technology.
- The pointing assembly ensures that the laser beam is accurately aimed at the Earth, while the camera helps to locate the ground station and provide feedback for fine-tuning the pointing.

#### JAMES WEBB SPACE TELESCOPE UNCOVERS MASSIVE "COSMIC VINE" IN EARLY UNIVERSE

- Pandora's Cluster (Abell 2744): The JWST uncovered new details in a region of space known as Pandora's Cluster.
- Massive Galaxies in Early Universe: The JWST spotted six massive galaxies that emerged not long after the Big Bang.
- Active Galactic Nuclei (AGN): A survey using the
  JWST revealed that AGN—supermassive black holes
  that are rapidly increasing in size—are rarer than
  many astronomers had assumed previously.

#### "VAJRA PRAHAR 2023" EXERCISE STARTED BETWEEN INDIA AND THE US JOINT SPECIAL FORCES

- The exercise aims to provide a training opportunity in counter-terrorism, airborne, and special operations.
- The joint military exercise is conducted in two
  phases: the first phase includes combat conditioning
  and tactical-level special mission training exercises,
  while the second phase involves 48 hours of
  validation of what the two forces have learned.

## THE SECOND EDITION OF JOINT MILITARY EXERCISE AUSTRAHIND-23

- The aim of the exercise is to enhance interoperability, share best practices, and conduct joint operations in semi-desert terrain under a UN peace enforcement mandate.
- The exercise will also involve the use of newgeneration equipment and specialised weapons, such as snipers, surveillance and communication equipment, casualty management, and evacuation.

#### INDIA HOSTS ASEAN-INDIA MILLETS FESTIVAL IN JAKARTA

- The festival aimed to create markets for milletbased products in the ASEAN region.
- It served as a platform for sharing knowledge and practices related to millet cultivation and consumption.
- This event is a significant step in promoting millets as part of the International Year of Millets 2023, as declared by the United Nations General Assembly.

# SURVEY OF INDIA & GENESYS INTERNATIONAL PARTNERED FOR 3D DIGITAL TWIN-MAPPING PROGRAMME IN INDIA

- This collaboration is aligned with India's National Geospatial Policy 2022, which emphasizes selfreliance in geospatial data production and usage.
- The initiative is set to revolutionize India's map content through the implementation of the 3D Digital Twin Mapping Program.

#### INDIA BECOMES CHAIR OF INTERNATIONAL SUGAR ORGANISATION FOR 2024

- India, being the largest consumer and the secondlargest producer of sugar globally, makes it an ideal candidate to lead this apex international body.
- With a substantial 15% share in global sugar consumption and contributing 20% to global sugar production, India's influence on global sugar trends is undeniable.
- India's Secretary (Food), Sanjeev Chopra, expressed the country's commitment to spearheading sustainable practices in sugarcane cultivation, sugar and ethanol production, and maximizing the utilization of by-product.

#### INTERNATIONAL NEWS- ONE LINER

- The China-based company Ehang has indeed received the world's first airworthiness certification for its fully autonomous, passenger-carrying air taxis.
- Thailand has announced that it will allow visa-free entry for tourists from India and Taiwan for a period of six months, starting from November 10, 2023, to May 10, 2024.



- India and Finland held their 12th Foreign Office Consultations (FOC) in New Delhi on 01 November 2023.
- Saima Wazed from Bangladesh has indeed won the election for the position of Regional Director for the World Health Organization's South-East Asia Region.
- The Philippines has indeed announced its exit from China's Belt and Road Initiative (BRI). This decision was made following a collision between a Philippine boat and a Chinese coastguard vessel in the South China Sea.
- The UGC has notified the draft regulations for foreign universities to set up and operate campuses in India on November 9, 2023.
- According to the World Energy Employment Report from the International Energy Agency (IEA), hiring in clean energy has pushed energy sector employment globally above pre-pandemic levels.
- The U.S. Food and Drug Administration (FDA) has approved the first vaccine to prevent disease caused by the Chikungunya virus.
- The 2nd India-Australia 2+2 Ministerial Dialogue was indeed scheduled to be held on November 20 in New Delhi
- Geert Wilders, the leader of the far-right anti-Islam Party for Freedom (PVV), won a shock victory in the Dutch parliamentary elections on November 22, 2023
- The newly elected government of New Zealand has indeed decided to repeal the 'Smoking ban' decision. This decision was taken to fund tax cuts. The smoking ban legislation, introduced under the previous Jacinda Ardern-led government, would have banned cigarette sales next year to anyone born after 2008.
- Madagascar's incumbent President Andry Rajoelina has won a third term. He won 59% of the vote to defeat his two closest rivals, ousted ex-President Marc Ravalomanana and Siteny Randrianasoloniaiko.\
- A gay couple in Nepal became the first in the country to receive official same-sex marriage status. This makes Nepal one of the first countries in Asia to allow it.
- The world's first transatlantic flight powered by 100% Sustainable Aviation Fuel (SAF) took off on Tuesday, November 28, 2023, from London and

- flew to New York. The flight was operated by Virgin Atlantic.
- "Our embassy and consulates in India issued an all-time record of more than 140,000 student visas,"
   the US State Department said in a statement. It
   added that the they issued more than 600,000
   student visas during this fiscal year, the highest since
   FY 2017.
- The International Labour Organization (ILO) has highlighted the deadly consequences of overworking worldwide. According to a paper published by the ILO and the World Health Organization (WHO), each year, three-quarters of a million people are dying from ischaemic heart disease and stroke due to working long hours.
- According to a report by the Global Energy Monitor (GEM) and the Centre for Research on Energy and Clean Air, China has been approving new coal power projects at an unprecedented rate.

#### **NATIONAL NEWS**

#### UTTAR PRADESH DRONE PRACHALAN SURAKSHA NITI-2023 HAS BEEN APPROVED

- This policy aims to regulate and monitor the usage of drones in the state, as well as to prevent their potential misuse for illegal or anti-national activities.
- The policy also lays down the guidelines for the operation, maintenance, security, and disposal of drones.

### SEBI UNVEILS NEW FORMAT FOR SID OF AMC

- The revamped format aims to streamline the dissemination of relevant information to investors, facilitate the periodic updation of the SID by mutual funds.
- The decision to revamp the SID format was based on the suggestions of the industry body AMFI and the recommendations of SEBI's Mutual Fund Advisory Committee.
- Under the new provisions, the scheme's portfolio holdings – top 10 holdings by the issuer and fund allocation toward various sectors – will be disclosed by way of a functional web link where such data will be hosted.



#### SWACHH DIWALI SHUBH DIWALI CAMPAIGN HAS BEEN LAUNCHED

- The campaign aims to invoke the cultural significance of Diwali, coupled with the journey of Swachh Bharat and the principles of Lifestyle for Environment (Mission LiFE).
- The campaign emphasizes the importance of a clean and eco-friendly celebration.
- It aims to instill a sense of responsibility towards the environment and communities by sensitizing and motivating individuals to opt for locally made products, embrace a Diwali free from single-use plastic, and prioritize pre and post-Diwali cleanliness.

DEFENCE MINISTRY APPROVAL OF MATERNITY AND CHILDCARE LEAVE FOR WOMEN SOLDIERS, SAILORS, AND AIR WARRIORS

- At present, the women officers get maternity leave of 180 days with full pay for each child, subject to a maximum of two children.
- Childcare leave of 360 days is granted in total service career (subject to the child being less than 18 years of age) to women officers.
- Child adoption leave of 180 days is granted after the date of the valid adoption of a child below one year of age.
- The extension of leave rules will go a long way in dealing with women-specific family and social issues relevant to the armed forces.

J&K POLICE BECOMES 1ST IN INDIA TO USE GPS TRACKER ANKLETS FOR TERROR-ACCUSED ON BAIL

- The GPS tracker anklet is a wearable device affixed around the ankle of the person to be monitored and tracks their movement.
- The use of these devices aims to prevent accused persons from jumping bail.
- This initiative by the J&K Police could help decongest prisons to a large extent.

#### MEGHALAYA CM LAUNCHES 'WATER SMART KID MEGHALAYA' CAMPAIGN

 This initiative is part of the Jal Jeevan Mission (JJM) and aims to create awareness about water conservation among children.

- Punjab National Bank (PNB): A penalty of Rs 72 lakh has been imposed for non-compliance with certain provisions related to 'interest rate on advances' and 'customer service in banks'.
- Federal Bank: A penalty of Rs 30 lakh has been imposed for contravention of certain provisions of KYC norms. The bank was penalized for issuing demand drafts, each valued at rupees fifty thousand and above, without including the name of the purchaser on the face of the drafts.
- Mercedes-Benz Financial Services: A penalty of Rs 10 lakh has been imposed for non-compliance with certain provisions of the Know Your Customer (KYC) Direction, 2016.

Kosamattam Finance: A monetary penalty of Rs 13.38 lakh has been imposed for non-compliance with certain provisions of the 'Non-Banking Financial Company - Systemically Important Non-Deposit taking Company and Deposit taking Company (Reserve Bank) Directions, 2016'.

#### BANK OF BARODA HAS APPOINTED KADGATOOR SHEETAL VENKATESMURT AS HEAD OF DIGITAL CHANNELS

- The upper limit of an UPI Lite payment transaction is Rs. 200 and the total limit of UPI Lite balance for an on-device wallet is Rs. 2,000 at any point of time.
- Users can replenish funds in UPI Lite only in online mode with additional factor authentication (AFA) or using UPI AutoPay which has been registered by the user in online mode with AFA.

## RBI TELLS BAJAJ FINANCE TO STOP LOANS UNDER 'ECOM', 'INSTA EMI' PRODUCTS

On a review, it has been decided to increase the risk weights in respect of consumer credit exposure of commercial banks (outstanding as well as new), including personal loans, but excluding housing loans, education loans, vehicle loans and loans secured by gold and gold jewellery, by 25 percentage points to 125%.
- ➤ Consumer credit exposure of NBFCs: In terms of extant norms, NBFCs' loan exposures generally attract a risk weight of 100%. On a review, it has been decided that the consumer credit exposure of NBFCs (outstanding as well as new) categorised as retail loans, excluding housing loans, educational loans, vehicle loans, loans against gold jewellery and microfinance/SHG loans, shall attract a risk weight of 125%.
- Credit card receivables: As per extant instructions, credit card receivables of scheduled commercial banks (SCBs) attract a risk weight of 125% while that of NBFCs attract a risk weight of 100%. On a review, it has been decided to increase the risk weights on such exposures by 25 percentage points to 150% and 125% for SCBs and NBFCs respectively.



- Bank credit to NBFCs:-
- In terms of extant norms, exposures of SCBs to NBFCs, excluding core investment companies, are risk weighted as per the ratings assigned by accredited external credit assessment institutions (ECAI). On a review, it has been decided to increase the risk weights on such exposures of SCBs by 25 percentage points (over and above the risk weight associated with the given external rating) in all cases where the extant risk weight as per external rating of NBFCs is below 100%.

#### RBI HAS IMPOSED A PENALTY OF RS 90.92 LAKH ON AXIS BANK

- This action is based on the deficiencies in regulatory compliance and is not intended to pronounce upon the validity of any transaction or agreement entered into by the bank with its customers.
- The penalty was imposed for the following reasons:
- The bank did not maintain the prescribed margin in case of intraday facilities sanctioned to stockbrokers.
- The bank followed restrictive practices in the sale of insurance products to customers.
- The bank failed to verify the copy of officially valid documents so produced by the clients, with the originals, while establishing account-based relationships.
- There were instances of customer IDs having multiple CIFs instead of a Unique Customer Identification Code (UCIC).
- The bank levied penal charges for non-maintenance of minimum balance in savings bank accounts, not directly proportionate to the extent of the shortfall observed.
- The central bank has also imposed a fine of Rs 90 lakh on IDBI Bank.

## PNB INTRODUCES DIGITAL GOLD LOAN FOR HASSLE-FREE CREDIT ACCESS

**Current Context:** Punjab National Bank (PNB) has introduced a Digital Gold Loan. This service is designed to provide a hassle-free credit to customers to quickly meet their personal as well as agriculture credit requirements against the pledge of Gold Jewellery/ornaments.

 An individual can apply for a PNB Digital Gold Loan for their personal needs for an amount ranging

- from a minimum Rs 25,000 to maximum Rs 25 lakhs.
- The PNB Gold Loan Rate of Interest is 7.25% per annum.
- The age requirement is at least 18.
- Anyone who has gold jewellery, coins, or ornaments that the bank needs to mortgage is eligible.
- The borrower's fixed payback period may last up to 12 months. Every month, interest will be deducted from the account, but at maturity, it will also become an outstanding payment along with the principal. The repayment can be accomplished by a bullet payment, in which the principal and interest are paid together at maturity.
- This digital lending solution was launched during the bank's Digital Mahotsav event.

## UCO BANK FIASCO: GLITCH FIRST NOTICED IN JAIPUR, JODHPUR

- Some customers found that when they tried to transfer funds using the Immediate Payment Service (IMPS) from their IDFC First Bank savings accounts to UCO Bank, the amount got credited into the UCO Bank account without getting debited at IDFC First.
- The glitch that caused Uco Bank to wrongly credit Rs 820 crore to many accounts was first noticed in Jaipur and Jodhpur.
- This issue led to the temporary suspension of online Immediate Payment System (IMPS) transfers by UCO Bank due to issues where funds from transactions initiated by customers from other banks were credited to UCO Bank's account holders, without the lender actually receiving the money.

#### **GOVERNMENT SCHEMES**

PM NARENDRA MODI LAUNCHED 'MERA YUVA BHARAT' PLATFORM FOR YOUTHS OF INDIA

- This initiative aims to embrace the youth aged between 15 and 29 as "active drivers" of development.
- The 'Mera Yuva Bharat (MY Bharat)' platform is envisioned as a pivotal, technology-driven facilitator for youth development and youth-led development.

FINANCE MINISTRY HAS LAUNCHED AN AMNESTY SCHEME FOR FILING APPEALS AGAINST GOODS AND SERVICES TAX (GST)

- This scheme is aimed at providing relief to taxpayers who missed their appeal deadlines or had their appeals rejected on grounds of time limitations.
- The scheme is applicable to appeals pending before any appellate authority, including the Appellate Authority for Advance Ruling, the Appellate Tribunal, the High Court and the Supreme Court.

#### JHARKHAND CABINET APPROVED 'ABUA AWAS YOJANA' HOUSING SCHEME

- The scheme will be implemented in three phases, with a target of 2 lakh houses in the current financial year; 3.5 lakh houses in FY 2024-25 and 2.5 lakh houses in FY 2025-26.
- The government has allocated Rs 2 lakh per beneficiary in its budget, disbursed in four installments.



 In comparison, Pradhan Mantri Awas Yojana-Rural constructs houses with two rooms and one kitchen, with a provision of Rs 1.2-1.3 lakh per beneficiary.

## GOVERNMENT LAUNCHED 'BHARAT ATTA' TO PROVIDE WHEAT FLOUR AT A SUBSIDISED RATE

- The scheme was launched by the Union government to keep a lid on food prices during the festive season when demand for commodities rises.
- The plan involves releasing a quarter of a million tonne of state-owned wheat to Kendriya Bhandar, a network of cooperative general stores, and the National Agricultural Cooperative Marketing Federation and National Cooperative Consumers' Federation.
- These agencies will sell the flour, branded Bharat Atta, at a cut price.

### UNION MINISTER AMIT SHAH LAUNCHES 'BHARAT ORGANICS'

- In line with the Prime Minister Shri Narendra Modi ji's vision of "Sahakar Se Samriddhi", NCOL has been established as a national-level multi-state cooperative society to make India a global leader in organic products.
- The establishment of a national-level Cooperative to promote organic products is a significant step towards boosting the rural economy, promoting "Make in India" along with paving way for "Aatmanirbhar Bharat" and "Local to Global".

## 1% INTEREST RATE REBATE HAS BEEN ANNOUNCED BY THE GOVERNMENT TO DIVYANG BORROWERS

- This initiative is aimed at reducing the financial burden on Divyang individuals seeking financial assistance and encouraging responsible repayment practices.
- This step reflects the government's unwavering commitment to promoting inclusivity and ensuring that every citizen, irrespective of abilities, has equal access to financial opportunities.

## PM MODI INAUGURATED THE 2ND EDITION OF 'WORLD FOOD INDIA' IN NEW DELHI

- This proposal is significant as it aims to enhance the safety of vulnerable road users (VRUs), which include adult or child pedestrians or cyclists.

- The Indian Women's Hockey Team won the Women's Asian Champions Trophy 2023. They secured a resounding 4-0 victory over reigning champions Japan in the final.
- The Indian shooting team had a remarkable performance at the Asian Shooting Championships 2023. They won a total of 55 medals 21 gold, 21 silver, and 13 bronze. This achievement was celebrated by Prime Minister Narendra Modi.
- Virat Kohli scored his 50th ODI century in the World Cup semifinal match against New Zealand on November 15, 2023. He became the first player to reach this milestone, surpassing Sachin Tendulkar's record of 49 ODI centuries.
- KL Rahul hit the fastest century by an Indian in the ODI World Cup history. He achieved this feat in the match against the Netherlands at M. Chinnaswamy Stadium in Bengaluru on Sunday, November 12, 2023.

- Anish Bhanwala won the bronze medal at the ISSF World Cup Final 2023 on Friday, November 24, 2023 in Doha, Qatar. This was India's first medal in the 25m rapid fire pistol event in the history of the ISSF World Cup Final.
- In the World Wushu Championship 2023, India indeed had a commendable performance Roshibina Devi won a silver medal in the women's 60kg category.
- Anahat Singh won the National Squash
   Championship 2023 on November 23, 2023. Anahat

#### **ECONOMY- ONE LINER**

- The International Monetary Fund (IMF) has projected that global growth will slow down to 2.9% in 2024. This is a decrease from the 3.5% growth observed in 2022 and the 3% growth projected for 2023.
- The upgrade in **India's mid-term GDP growth forecast by Fitch from 5.5% to 6.2%** indicates a positive outlook for the country's economy.
- India's pharmaceutical exports grew by 5% in the first half of the fiscal year 2024 (H1 FY24), reaching \$13,361 million compared to \$12,723 million in the corresponding period of the previous financial year.
- Moody's Investors Service has indeed retained India's economic growth forecast for 2023 at 6.7%.
- India's exports increased by 6.21 percent from a year earlier to USD 33.57 billion in October 2023, according to the Ministry of Commerce and Industry.
- Goldman Sachs expects India's real economic growth to be 6.3% in 2024. This is the highest among large economies in the region, but slightly below the Indian central bank's target of 6.5% for fiscal 2024.



- The rating agency ICRA has estimated that India's GDP growth will moderate to 7.0% in Q2 FY2024, down from 7.8% in Q1 FY2024.
- The unemployment rate in urban areas has decreased from 7.2% to 6.6%. This is a decrease of approximately 8.33%. This could be due to various factors such as increased job opportunities, government initiatives, or economic growth.

#### SCIENCE & TECHNOLOGY:

- The "Amaterasu" is an extremely high-energy
  particle that was recently detected on 24th
  November 2023. Named after the sun goddess in
  Japanese mythology, it is one of the highest-energy
  cosmic rays ever detected.
- Researchers have found that Neanderthals had the capacity to both hear and produce speech sounds similar to those produced by modern humans. This discovery is based on detailed analysis and digital reconstruction of the bones present in their skulls.
- The swift spin of Sagittarius A\* marks a milestone in our cosmic exploration, offering astronomers new perspectives on black hole dynamics and their impact on the fabric of space-time. As the study unfolds, it promises to deepen our understanding of the universe's intricacies and unlock further cosmic mysteries.
- A new dinosaur species named Farlowichnus rapidus has been discovered in Brazil. This discovery was based on footprints found in the city of Araraquara. These footprints were first discovered back in the 1980s by Giuseppe Leonardi, an Italian priest and dedicated paleontologist.
- The Saurauia Punduana plant, a critically endangered species as per the International Union for Conservation of Nature (IUCN) Red List, has been recorded for the first time in Manipur's Tamenglong district. This discovery was made during a recent Rapid Biodiversity Assessment (RBA) field survey.
