NATIONAL NEWS

ODISHA LAUNCHES PM-USHA PROGRAMME TO STRENGTHEN HIGHER EDUCATION

- This initiative, supported by the Union Education Ministry, aims to improve the infrastructure and development of higher education institutions in Odisha.
- The programme has a budget of ₹500 crore, with 60% of the funding provided by the central government and 40% by the state.
- It aligns with the National Education Policy, 2020, focusing on access, equity, and excellence in higher education.
- The goal is to transform Odisha's universities into world-class institutions and equip students with 21st-century skills.

ON SEPTEMBER 3, THE ANTI-RAPE 'APARAJITA' BILL WAS PASSED IN THE WEST BENGAL ASSEMBLY

• This bill introduces stringent measures, including the death penalty for





rape and sexual offences if the victim dies or is left in a vegetative state.

- It also mandates a life sentence without parole for convicted rapists.
- The bill aims to create a safer environment for women and children by ensuring swift justice and harsher punishments for offenders.
- It was introduced by West Bengal Law Minister Moloy Ghatak and received unanimous support in the Assembly.

DOT NOTIFIES NEW RULES FOR 'DIGITAL BHARAT NIDHI' TO BOOST TELECOM ACCESS

- These rules aim to enhance the management and implementation of the Digital Bharat Nidhi initiative, which was established under Section 24 (1) of the Telecommunications Act, 2023.
- Key Provisions of the Rules:
 - Administrator's Role: The rules outline the powers and responsibilities of the administrator, who will oversee the implementation and management of the Digital Bharat Nidhi.
 - Project Criteria: Projects funded under the Digital Bharat Nidhi must meet specific criteria, such as improving telecom service affordability and security, enhancing access and affordability, and introducing next-generation telecom technologies in underserved rural, remote, and urban areas.
 - Focus Areas: The funds will be directed towards projects aimed at enhancing telecommunication services in underserved and remote regions, with a particular focus on

marginalized groups, including women, persons with disabilities, and economically and socially disadvantaged sections of society.

UNION MINISTER OF STATE DR. JITENDRA SINGH INAUGURATED 8 NEW NIDHI I-TBIS ACROSS INDIA

- This initiative is part of the Department of Science and Technology's (DST) efforts to foster innovation and entrepreneurship, particularly in Tier II and Tier III cities.
- These incubators aim to cultivate an entrepreneurial culture among students, faculty, and local communities, providing essential infrastructure and resources to support startups.

OPERATION SADBHAV LAUNCHED BY INDIA TO PROVIDE HUMANITARIAN

PM NARENDRA MODI INAUGURATED SEMICON INDIA 2024 IN GREATER NOIDA, UP

- **Theme:** "Shaping the Semiconductor Future."
- Prime Minister's Vision:
 - Electronics Sector Goal: Grow to \$500 billion by 2030.
 - Job Creation: Expected to create 60 lakh jobs.
- Focus Areas:
 - **Investment:** Encouraging global chipmakers to invest in India.
 - Innovation: Highlighting India's potential in the semiconductor industry.
 - Collaboration: Promoting partnerships between Indian and international companies.

NEW MSME POLICY 2024 LAUNCHED BY TELANGANA CHIEF MINISTER REVANTH REDDY

- Financial Support: The government has allocated ₹600 crore over the next five years to support MSMEs.
- Key Focus Areas: The policy addresses six critical areas: land acquisition, finance, raw materials, skilled labour, market access, and technology.
- Incentives: Special incentives include a 50% subsidy on land costs for SC/ST entrepreneurs and a 25% subsidy for other

MSMEs. Women entrepreneurs receive an additional 20% subsidy.

- Industrial Parks: Five out of ten new industrial parks will be exclusively for MSMEs, with one park reserved for womenowned enterprises and another for innovative start-ups.

- Employment and Skills: Initiatives like the Telangana Skilling University and the Digital Employment Exchange of Telangana (DEET) aim to enhance the skill set of the workforce.

- This program focuses on four key areas:

 Infrastructure: Improving the infrastructure needed for dairy farming and processing.

- Additionally, the initiative includes the rollout of RuPay Kisan Credit Cards and micro-ATMs for dairy farmers, along with the computerization of Primary Agriculture Credit Societies (PACS).

FABINDIA COLLABORATES WITH MOMSME TO EMPOWER INDIA'S ARTISANAL HERITAGE UNDER THE PM VISHWAKARMA SCHEME

• This collaboration aims to support and promote traditional Indian artisans by

providing them with financial support, skill development, and marketing assistance.

- The initiative focuses on enhancing the market reach of artisan-made products through Fabindia's extensive retail network.
- It also includes training programs to help artisans improve their craftsmanship and incorporate modern design trends.

PARYATAN MITRA AND PARYATAN DIDI INITIATIVE HAS BEEN LAUNCHED BY THE MINISTRY OF TOURISM

- These initiatives aim to promote responsible tourism across India by training locals to become tourism ambassadors.
- The focus is on enhancing hospitality, cleanliness, and sustainability, emphasizing empowering women and youth.
- Through this initiative, locals are trained to provide tourists with a positive experience, sharing local stories and lesser-known tourism wonders.

NATIONAL NEWS- ONE LINER

- The eShram portal has registered over 30 crore unorganised workers since its launch in August 2021. This initiative by the Ministry of Labour & Employment aims to integrate various social security schemes, ensuring benefits reach grassroots workers
- President Droupadi Murmu sanctioned the constitution of the 23rd Law Commission of India on September 1, 2024. This commission will serve a three-year term, from September 1, 2024, to August 31, 2027. The Law Commission is tasked with reviewing existing laws and recommending



legal reforms to improve and update the legal framework in India.

- On September 2, 2024, the Union Cabinet approved Kaynes Semicon Pvt Ltd's proposal to establish a semiconductor unit in Sanand, Gujarat. This project aims to boost India's semiconductor manufacturing capabilities, supporting the country's goal of becoming a global hub for electronics production.
- WWF-India's Vulture Count 2024 initiative, running from September 7 to October 6, aims to monitor and conserve vulture populations across India. This citizenscience project will gather data on vulture numbers and habitats, helping develop b as they prevent disease spread by feeding on carrion.
- The Himachal Pradesh Vidhan Sabha has introduced Zero Hour during its monsoon session. This 30-minute period allows members to raise urgent public issues that cannot be addressed through other motions.
- The Indian government launched the Vishvasya-Blockchain Technology Stack to enhance digital trust and governance. Key components include Blockchain-as-a-Service (BaaS), NBFLite for rapid prototyping, Praamaanik for app verification, and the National Blockchain Portal for research and development. This initiative aims to boost security, trust, and transparency in citizen-centric applications.
- The Punjab Assembly passed the Punjab Apartment and Property Regulation (Amendment) Bill, 2024 to control illegal colonies. It removes the NOC requirement for property registration in illegal colonies and extends the regularization cut-off date

to July 31, 2024. Non-compliance can result in imprisonment from five to ten years and fines ranging from Rs 25 lakh to Rs 5 crore.

- President Droupadi Murmu inaugurated the Vishwashanti Buddha Vihar in Udgir, Latur district, Maharashtra. The Vihar features a 520 kg, 10.5-foot tall statue of Lord Buddha and a main entrance inspired by the Sanchi Stupa. It can accommodate up to 1,200 people.
- India and Singapore upgraded their bilateral ties to a Comprehensive Strategic Partnership on September 5, 2024. This partnership aims to enhance cooperation in areas such as trade, defense, and technology. It reflects the deepening relationship and mutual strategic interests between the two nations.
- The Uttar Pradesh government announced on September 2, 2024, that they will build a Vedic-3D museum in Varanasi. This museum, located at the Sampurnanand Sanskrit University, will focus on Indian astrology, astronomy, and Vedic literature.

BANKING

SINGAPORE AIRLINES RECEIVES FDI APPROVAL FROM GOI FOR VISTARA-AIR INDIA MERGER

- This significant development paves the way for the creation of one of the world's largest airline groups.
- Key points:
 - FDI approval: Singapore Airlines has been granted permission to invest in the merged entity.
 - Stake acquisition: The airline is expected to acquire a 25.1% stake in the combined Air India-Vistara.



 Completion timeline: The merger is anticipated to be finalized by the end of 2024.

THE E-DISPUTE RESOLUTION SCHEME (E-DRS) HAS BEEN ANNOUNCED BY THE INCOME TAX DEPARTMENT

- Here are some key points about the scheme:
 - Objective: The e-DRS aims to reduce litigation and provide relief to eligible taxpayers by allowing them to resolve disputes electronically through Dispute Resolution Committees (DRCs) established under section 245MA of the Income-tax Act, 1961.
 - Eligibility: Taxpayers whose returned income for the relevant assessment year does not exceed ₹50 lakh and where the aggregate amount of variations proposed or made does not exceed ₹10 lakh can apply.
 - Application Process: Applications must be filed electronically in Form No. 34BC on the Income Tax Department's e-filing portal within one month from the date of receipt of the specified order.
 - DRC's Role: The DRC can make modifications to the variations in the specified order and decide on the reduction or waiver of penalties and prosecution.
 - Timeline: The DRC is mandated to pass its order within six months from the end of the month in which the application for dispute resolution is admitted.
 - This initiative is expected to streamline the dispute resolution

process and make it more efficient for taxpayers.

SEBI REVISED ELIGIBILITY CRITERIA FOR ENTRY, EXIT OF STOCKS IN F&O SEGMENT

- These changes are aimed at ensuring that only stocks with sufficient liquidity and market capitalization are included in the derivatives segment.
- Key Changes in the Eligibility Criteria:
 - Increased Median Quarter Sigma Order Size (MQSOS): The minimum MQSOS required for a stock to enter the F&O segment has been increased from Rs.25 lakh to Rs.75 lakh. This means that the stock must have a minimum order size of Rs.75 lakh to be eligible.
 - Higher Market-Wide Position Limit (MWPL): The minimum MWPL for a stock has been raised from Rs.500 crore to Rs.1,500 crore. This limits the maximum amount of positions that can be held by all market participants in a particular stock.
 - Revised Average Daily Delivery Value: The minimum average daily delivery value in the cash market has been increased from Rs.10 crore to Rs.35 crore. This indicates that the stock must have a certain level of underlying demand in the cash market.

REVIEW OF EXTANT INSTRUCTIONS -WITHDRAWAL OF CIRCULARS

- This decision aims to streamline and modernize the regulatory framework by removing obsolete instructions.
- Here are some key points from the review:

- Credit Facilities to Minority Communities: Circulars from 1987 and 1988 have been withdrawn as their instructions are now included in the updated Master Circular on Credit Facilities to Minority Communities issued in April 2023.
- No-Frills Accounts: The concept of "No-Frills" accounts has been discontinued. Instead, Basic Savings Bank Deposit Accounts (BSBDA) are now the standard banking service for all customers.
- Micro Credit

Guidelines: Instructions on microcredit have been integrated into the updated Master Circulars on Self-Help Group (SHG) Bank Linkage and Non-Banking Financial Company (NBFC) regulations.

LIBERALISED REMITTANCE SCHEME (LRS) FOR RESIDENT INDIVIDUALS-DISCONTINUATION OF REPORTING OF MONTHLY RETURN

- This limit is currently set at \$250,000 per financial year.
- Before April 1, 2020, resident individuals were required to report their monthly remittances under the LRS to the Authorized Dealer (AD) banks.
- This reporting requirement was aimed at monitoring the utilization of the LRS and preventing its misuse.
- However, effective April 1, 2020, the RBI discontinued the requirement for resident individuals to submit monthly returns for their LRS remittances.
- This change was introduced to simplify the process for individuals and reduce the administrative burden on banks.
- Key points to remember:



- The LRS limit remains unchanged at \$250,000 per financial year.
- Resident individuals are no longer required to submit monthly returns for their LRS remittances.
- The discontinuation of monthly reporting does not affect the overall LRS framework.

A MASTER CIRCULAR ON PROTECTION OF POLICYHOLDERS' INTERESTS 2024 HAS BEEN ISSUED BY IRDAI

- These circular aims to enhance transparency and efficiency in the insurance sector by consolidating various guidelines and regulations into a single document.
- Some key highlights include:
 - Electronic Issuance of Policies: All insurance policies must now be issued electronically, although policyholders can request physical copies if preferred.
 - Free Look Period: A 30-day free look period is applicable for life and health insurance policies, allowing policyholders to review the terms and conditions.
 - Claim Settlement Timelines: The circular outlines specific timelines for claim settlements to ensure timely service.
- This initiative is designed to better inform policyholders about their rights and streamline the processes related to insurance policies.

SJVN, NHPC, RAILTEL AND SOLAR ENERGY CORPORATION OF INDIA GET 'NAVRATNA' STATUS

- Here's a quick overview of the companies:
 - Satluj Jal Vidyut Nigam (SJVN)

- National Hydroelectric Power Corporation (NHPC)
- RailTel Corporation of India (RailTel)
- Solar Energy Corporation of India (SECI)
- This upgrade brings the total number of Navratna Central Public Sector Enterprises (CPSEs) in India to 25.
- What is Navratna Status?
 - Enhanced Autonomy: Navratna status empowers these companies with greater financial and operational autonomy.
 - Increased Investment Power: They can invest up to Rs.1,000 crore or 15% of their net worth in a single project without prior government approval.
 - Expanded Investment
 Flexibility: They can invest up to 30% of their net worth in a year, subject to a cumulative limit of Rs.1,000 crore.
 - Board-Level Decision-Making: Navratna companies have more flexibility in decision-making at the board level.

DEA ISSUED 6 NEW RULES FOR PPF, SUKANYA SAMRIDDHI YOJANA

 - Irregular NSS Accounts: Accounts opened irregularly under the National Small Savings (NSS) schemes will be regularized. Specific guidelines have been provided for accounts opened before and after certain dates.
 - PPF Accounts for Minors: New rules for PPF accounts opened in the name of minors to ensure compliance with deposit limits.



- Multiple PPF Accounts: Guidelines for handling cases where individuals have more than one PPF account.

SEBI AMENDS RULES TO STREAMLINE PUBLIC ISSUANCE OF DEBT SECURITIES

- The amendments, which came into effect on September 18, 2024, include the following:
 - Reduction in minimum subscription period: The minimum period for which a public issue of debt securities or non-convertible redeemable preference shares is kept open has been reduced from 3 working days to 2 working days. The maximum period remains the same at 10 working days.
 - Clarification on the use of QR codes: The regulations now clarify that issuers whose non-convertible securities are listed on the date of filing of the offer document or placement memorandum may provide a web link and a static QR code of the audited financial statements subject to certain conditions.
 - Additional requirements for debenture trustees: The regulations have been amended to specify the formats to be used in cases of secured and unsecured debt securities at the time of filing the draft offer document and at the



time of filing the listing application by the issuer.

 Introduction of a record date for payment of interest, dividend, and redemption or repayment amount: The regulations have been amended to require issuers to fix a record date for payment of interest, dividend, and payment of redemption or repayment amount or other purposes specified by the Board.

KARNATAKA, GUJARAT AND TN, BIGGEST GAINERS FROM 1990S REFORMS: EAC -PM

RBI RELEASED A REPORT TITLED "PEELING THE LAYERS: A REVIEW OF THE NBFC SECTOR IN RECENT TIMES"

- This report highlights the resilience of the Non-Banking Financial Companies (NBFC) sector under the Scale-Based Regulations (SBR) framework.
- Key Points from the Report:
 - Credit Growth: The NBFC sector maintained double-digit credit growth throughout 2023, driven by a diversified funding base, including

retail credit (gold loans, vehicle loans, and housing loans) and expanding into industrial and service sectors.

- Asset Quality: Since the introduction of the SBR framework in October 2022, the asset quality of NBFCs has improved significantly. The gross non-performing asset (GNPA) ratio decreased to 2.4% for government-owned NBFCs and 6.3% for non-government NBFCs by December 2023.
- Profitability: The sector witnessed a rise in profitability, as evidenced by better returns on assets (RoA) and equity (RoE).
- Capital Adequacy: NBFCs maintained adequate capital levels and a low delinquency ratio by the end of December 2023.
- Regulatory Measures: The report also mentions the extension of Prompt Corrective Action (PCA) norms to government-owned NBFCs from October 1, 2024, aiming to enhance financial discipline and risk management.

SBI'S ERD REPORT: INDIA'S POPULATION GROWTH ON A DOWNWARD TRAJECTORY

- According to the report, India's population growth rate is on a downward trajectory.
- The average annual exponential growth rate has decreased from 2.20% in 1971 to 1% in 2024.

INDIA'S CURRENT ACCOUNT DEFICIT WIDENS TO 1.1% OF GDP AT \$9.7 BN IN Q1FY25: RBI

- Here are the key points from the report:
 - Current Account Deficit: The CAD widened to \$9.7 billion, which is 1.1% of GDP, compared to \$8.9 billion (1.0% of GDP) in Q1FY24 and a surplus of \$4.6 billion (0.5% of GDP) in Q4FY24.
 - Merchandise Trade Deficit: The increase in CAD was primarily due to a rise in the merchandise trade deficit, which grew to \$65.1 billion in Q1FY25 from \$56.7 billion in Q1FY24.
 - Net Services Receipts: These increased to \$39.7 billion from \$35.1 billion a year ago, with significant contributions from computer services, business services, travel services, and transportation services.
 - Private Transfer Receipts: Mainly representing remittances by Indians employed overseas, these rose to \$29.5 billion from \$27.1 billion in Q1FY24.

Foreign Exchange Reserves: After financing the CAD, the net accretion to the forex reserves was \$5.2 billion in Q1FY25, compared to \$24.4 billion in Q1FY24

BANKING- ONE LINER

 The Reserve Bank of India (RBI) imposed penalties on UCO Bank and Cent Bank Home Finance Ltd (CBHFL). UCO Bank was fined ₹2.68 crore for violations related to

current accounts, deposit interest rates, and fraud classification. CBHFL received a **₹2.1 lakh penalty** for not complying with KYC guidelines. These actions underscore the importance of regulatory compliance in the banking sector.

- In September 4, 2024, the Government of India, Government of Tripura, and representatives of the National Liberation Front of Tripura (NLFT) and All Tripura Tiger Force (ATTF) signed a Memorandum of Settlement. This agreement aims to bring lasting peace and development to the region by addressing the grievances of the insurgent groups and integrating them into the mainstream
- The UN has allocated \$100 million from the Central Emergency Response Fund (CERF) to address underfunded humanitarian emergencies in 10 countries. Yemen and Ethiopia will receive the largest shares, with \$20 million and \$15 million respectively. This funding aims to support critical aid operations in regions severely affected by conflict, displacement, hunger, and climate disasters.
- MCA-Nepal (Millennium Challenge Account-Nepal) has signed a contract valued at USD 12.36 million with Transrail Lighting Ltd., an Indian company, to construct an 18 km cross-border electricity transmission line. This transmission line will run from the 400 kilovolt (kV) New Butwal Substation in Nawalparasi Bardhaghat Susta West to the Nepal-India border. The project is expected to be completed within 21 months.
- Tata AIA Life Insurance has introduced USD-denominated life insurance solutions for NRIs through its new offshore branch at

GIFT City. These plans offer financial protection in US dollars, covering risks like death, accident, disability, and critical illness, and aim to protect against currency fluctuations. Tata AIA also plans to launch unit-linked life insurance products soon.

- The Income Suraksha Plan by ABSLI and Policybazaar offers guaranteed monthly income to the policyholder's family in case of their death. It includes two options: Fixed Income Protection and Increasing Income Protection, with discounts for salaried individuals and females. Optional riders are available for additional coverage. This plan ensures financial security and peace of mind for families.
- The Finance Ministry has relaxed norms for expenditures over Rs 500 crore to boost capital expenditure (capex), aiming to accelerate government spending and infrastructure development. This move is expected to help achieve the record capex target of Rs 11.11 lakh crore for the current fiscal year. The relaxation provides operational flexibility while ensuring strict compliance by all ministries and departments.
- Starting January 1, 2025, EPS pensioners can receive their pensions from any bank branch across India, thanks to the new Centralized Pension Payment System (CPPS). This initiative will benefit over 78 lakh pensioners, enhancing convenience and efficiency in pension disbursement.

GOVERNMENT SCHEMES

DEA ISSUED 6 NEW RULES FOR PPF, SUKANYA SAMRIDDHI YOJANA

- Here are the key changes:
 - Irregular NSS Accounts: Accounts opened irregularly under the National Small Savings (NSS) schemes will be regularized. Specific guidelines have been provided for accounts opened before and after certain dates.
 - PPF Accounts for Minors: New rules for PPF accounts opened in the name of minors to ensure compliance with deposit limits.
 - **Multiple PPF Accounts:** Guidelines for handling cases where individuals have more than one PPF account.
 - NRI PPF Extensions: Rules for the extension of PPF accounts by Non-Resident Indians (NRIs).
 - Sukanya Samriddhi Account (SSA) Regularization: Regularization of SSA accounts opened by grandparents instead of guardians.

- Zero Interest on Non-compliant Accounts: From October 1, 2024, accounts that do not meet the specified criteria will earn zero percent interest.
- These changes aim to streamline the management of small savings schemes and ensure compliance with the regulations.

UNION CABINET APPROVED SEVEN SCHEMES TO IMPROVE FARMERS' LIVES AND INCREASE THEIR INCOMES

- Here are the key schemes:
 - Digital Agriculture Mission: Utilizing technology like AI and Big Data to enhance agricultural practices and connect farmers with buyers.
 - Crop Science for Food and Nutritional Security: Focused on research and education to improve crop resilience and food security.
 - Strengthening Agricultural Education, Management, and Social Sciences: Modernizing agricultural research and education in line with the New Education Policy 2020.
 - Sustainable Livestock Health and Production: Aiming to increase farmers' income from livestock and dairy.
 - Sustainable Development of Horticulture: Enhancing income from horticulture plants.
 - Strengthening of Krishi Vigyan Kendra: Improving agricultural extension services.
 - Natural Resource Management: Focusing on sustainable use of natural resources.
- These initiatives are designed to leverage modern technology and research to

support farmers in various aspects of agriculture.

MP GOVT LAUNCHES BRINDAVAN GRAM SCHEME & GITA BHAVAN PROJECT

- Brindavan Gram Scheme
 - Objective: To promote rural development and increase farmers' incomes.
- Key Features:
 - Establishment of gaushalas (cow sheds) in selected gram panchayats.
 - Promotion of milk production.
 - Implementation of roof-top solar policies in the selected villages.
- **Scope:** One gram panchayat will be selected from each of the 313 blocks in Madhya Pradesh.
- Gita Bhavan Project
- To promote spiritual knowledge and cultural heritage.
- Key Features:
 - Establishment of Gita Bhavans in all urban bodies across the state.
 - These centers will provide access to spiritual literature, including the Bhagavad Gita and other related texts.
 - The project aims to foster a deeper connection with the state's cultural and spiritual heritage

PRADHAN MANTRI MATSYA KISAN SAMRIDHI SAH-YOJNA LAUNCHED BY UNION MINISTER FOR FISHERIES

 This scheme is a significant initiative under the Pradhan Mantri Matsya Sampada Yojana (PMMSY) aimed at formalizing the fisheries sector and supporting micro and small enterprises in fisheries with an investment of over ₹6,000 crores over the next four years.

- The scheme focuses on:
 - Formalizing the fisheries sector through a National Fisheries Digital Platform.
 - Providing access to institutional credit for fisheries micro and small enterprises.
 - Supporting aquaculture insurance and promoting safety and quality assurance systems for fish and fishery products.
 - This initiative is expected to benefit fishers, fish farmers, fish workers, and vendors, along with various micro and small enterprises involved in the fisheries value chain.

GOVERNMENT RELAXED EXCLUSION CRITERIA UNDER THE PRADHAN MANTRI AWAS YOJANA-GRAMIN (PMAY-G)

- This change allows more families to benefit from the rural housing scheme.
- Here are the key updates:
 - Eligibility Expansion: Families owning two-wheelers, motorised fishing boats, refrigerators, and landline phones, and earning up to ₹15,000 per month, are now eligible.
 - Continued Exclusions: Households owning motorised three/fourwheelers, mechanised agricultural equipment, or having a Kisan Credit Card with a credit limit of ₹50,000 or above, remain ineligible.
- Additionally, households with any member as a government employee, those paying income or professional tax, and



those owning more than 2.5 acres of irrigated land are still excluded.

 This relaxation aims to make the scheme more inclusive and help achieve the target of constructing two crore additional houses by 2028-29.

PM ELECTRIC DRIVE REVOLUTION IN INNOVATIVE VEHICLE ENHANCEMENT (PM E-DRIVE) SCHEME

- This scheme aims to promote electric mobility in India with an outlay of ₹10,900 crore over two years.
- Key highlights of the scheme include:
 - Subsidies and Demand
 Incentives: ₹3,679 crore allocated
 for e-2Ws, e-3Ws, e-ambulances, etrucks, and other emerging EVs.
 - E-Vouchers: Streamlining the EV buying process with Aadhaar authenticated e-vouchers.
 - E-Ambulances: ₹500 crore allocated for the deployment of eambulances.
 - E-Buses: ₹4,391 crore for the procurement of 14,028 e-buses by public transport agencies.
 - Charging Infrastructure: ₹2,000 crore for installing fast chargers.
 - Vehicle Testing Infrastructure: ₹780 crore for developing testing agencies.
- This initiative is a significant step towards enhancing electric vehicle mobility and supporting greener healthcare solutions in India.

THE UNION CABINET APPROVED THE FOURTH PHASE OF THE PRADHAN MANTRI GRAMIN SADAK YOJANA (PMGSY)

- Construction of 62,500 km of allweather roads to provide new connectivity to 25,000 unconnected habitations.
- Focus on habitations with populations of 500+ in plains, 250+ in NE & Hill States/UTs, and special category areas.
- Use of advanced technologies like Cold Mix Technology, Waste Plastic, and Full Depth Reclamation for road construction.
- Integration with the PM Gati Shakti portal for efficient planning and implementation.
- This initiative aims to enhance rural connectivity, thereby supporting socio-economic development in remote areas.

PRADHAN MANTRI ANNADATA AAY SANRAKSHAN ABHIYAN (PM-AASHA) SCHEME

- This initiative aims to provide remunerative prices to farmers and control the price volatility of essential commodities for consumers.
- The government has allocated ₹35,000 crore for this scheme during the 15th Finance Commission Cycle up to 2025-26.
- The scheme includes components like the Price Support Scheme (PSS), Price Stabilization Fund (PSF), Price Deficit Payment Scheme (PDPS), and Market Intervention Scheme (MIS).
- Starting from the 2024-25 season, the procurement of specified pulses, oilseeds, and copra at minimum support prices (MSP) will be limited to 25% of the national production of these crops.



 However, for Tur, Urad, and Masur, there will be 100% procurement during the 2024-25 season.

NPS-VATSALYA SCHEME LAUNCHED BY FINANCE MINISTER NIRMALA SITHARAMAN

- Key Details:
- **Purpose:** The primary goal is to build a financial corpus for children until they reach the age of 18. It aims to inculcate early savings and investment habits among parents for their children's future.
- Eligibility:
 - Minors (children under 18 years of age) are eligible.
 - Parents or guardians can open and operate the accounts on behalf of the minors.
- Investment Amount:
 - The minimum annual contribution is ₹1,000.
 - There is no maximum limit on the investment.
- Benefits:
 - The scheme leverages the power of compounding, ensuring that even small, regular investments can grow into a substantial corpus over time.
 - The maximum exposure to equities is capped at 75%, balancing risk and potential returns.
 - Parents can open the account through major banks, post offices, pension funds' offices, or the e-NPS portal.
 - This initiative is part of the broader National Pension System (NPS) and is regulated by the Pension Fund Regulatory and Development Authority (PFRDA)

UNION CABINET APPROVED THE RS. 9,197 CRORE BIO-RIDE SCHEME

- This scheme, officially known as the Biotechnology Research Innovation and Entrepreneurship Development (Bio-RIDE), aims to support cutting-edge research and development in biotechnology.
- The Bio-RIDE scheme has three main components:
 - Biotechnology Research and Development (R&D)
 - Industrial & Entrepreneurship
 Development (I&ED)
 - $\circ \quad \text{Biomanufacturing and Biofoundry}$
- The scheme is designed to foster innovation, promote bioentrepreneurship, and strengthen India's position as a global leader in biomanufacturing and biotechnology.
- It aims to accelerate research, enhance product development, and bridge the gap between academic research and industrial applications.

TELANGANA GOVERNMENT LAUNCHED THE 'TELANGANA DARSHINI' SCHEME FOR STUDENT TOURS

- This initiative is designed to help students explore the state's rich cultural heritage, historical sites, and scientific institutions.
- The program is structured to cater to different age groups:
 - Classes 2-4: Short, one-day trips to nearby heritage sites and parks.
 - Classes 5-8: Day trips within 20-30 kilometers.
 - Classes 9 to Intermediate: Two-day trips covering up to 50-70 kilometers.



- University students: Four-day tours to locations outside their home districts.
- The government has allocated ₹12.10 crore for this program, covering travel, accommodation, and meals.
- The initiative aims to include 100,000 students this year, ensuring a broad participation from various schools.

 - Future Projections: Under a Business-As-Usual (BAU) scenario, the national supply of edible oil is projected to increase to 16 million tonnes by 2030 and 26.7 million tonnes by 2047.
 - Strategies for Self-Sufficiency: The report outlines various strategies to bridge the demand-supply gap, including enhancing domestic production and exploring new approaches to achieve selfsufficiency.
- This comprehensive roadmap aims to reduce dependency on imports and promote self-reliance in the edible oil sector.

WHO REPORT: ROAD ACCIDENT DEATHS IN INDIA SURGE BY 2% DURING THE PERIOD 2010-2021

 This report was published on September 2, 2024, during the 15th World Conference on



Injury Prevention and Safety Promotion (Safety 2024) held in New Delhi.

- Here are some key points from the report:
 - Increase in Road Traffic
 Deaths: India saw a 2% increase in estimated road traffic deaths during the period 2010-2021.
 - Fatalities in 2021: India reported 1,53,973 road traffic fatalities in 2021, but WHO estimates the number to be around 2,16,618.
 - Vulnerable Road Users: The highest number of fatalities were among drivers/riders of motorized two/three-wheelers (45.1%), followed by pedestrians (19%), and drivers/passengers of motorized four-wheelers (12.9%).
 - Regional Impact: The South-East Asia Region, which includes India, accounted for about 28% of global road traffic deaths in 2021.
- The report emphasizes the need for accelerated measures to improve road safety, especially for vulnerable road users like pedestrians, bicyclists, and two/threewheelers.

INDIA'S CURRENT ACCOUNT DEFICIT LIKELY TO RISE 1% OF GDP IN Q2FY25: IND-RA REPORT

- This increase is attributed to a combination of factors, including a 1% increase in merchandise exports and a widening goods trade deficit.
- In the first quarter of FY25, India's merchandise exports grew by 6% year-onyear, while imports grew by 7.6%.
- The report also highlights that the current account balance (CAB) registered a deficit of around \$8 billion (0.8% of GDP) in Q1

FY25, a reversal from the surplus of \$5.7 billion (0.6% of GDP) recorded in the previous quarter.

MOHFW RELEASES 'HEALTH DYNAMICS OF INDIA 2022-23' REPORT

- Here are some of the key findings from the report:
 - Health infrastructure: As of March 31, 2023, India had a total of 1,69,615 Sub-Centres (SCs), 31,882 Primary Health Centres (PHCs), 6,359 Community Health Centres (CHCs), 1,340 Sub-Divisional/District Hospitals (SDHs), 714 District Hospitals (DHs), and 362 Medical Colleges (MCs).
 - Human resources: As of March 31, 2023, India had a total of 1,15,319 doctors and specialists working in government health facilities. Of these, 32,578 were working in PHCs, 51,682 were working in CHCs, and 45,027 were working in SDHs/DHs. India also had a total of 2,41,232 nursing staff working in government health facilities. Of these, 47,955 were working in PHCs, 51,350 were working in CHCs, and 135,460 were working in SDHs/DHs.
 - Rural health: Between 2005 and 2023, the number of SCs, PHCs, and CHCs in India increased by 85%, 61%, and 120%, respectively. As a result, the percentage of rural population covered by PHCs increased from 68% in 2005 to 86% in 2023.
 - **Urban health:** As of March 31, 2023, India had a shortfall of 36% of Urban



PHCs (U-PHCs) as per the urban population norms.

 Inter-State disparity: There is a significant inter-State disparity in the availability of health services in India. For example, some States have a much higher number of doctors and nurses per population than others.

ECONOMY- ONE LINER
