### RBI CIRCULARS: DECEMBER 2020

#### 24X7 AVAILABILITY OF REAL TIME GROSS SETTLEMENT (RTGS) SYSTEM

- It has been decided to make RTGS available round the clock on all days of the year with effect from 00:30 hours on December 14, 2020.

#### CARD TRANSACTIONS IN CONTACTLESS MODE - RELAXATION IN REQUIREMENT OF ADDITIONAL FACTOR OF AUTHENTICATION

- Additional Factor of Authentication (AFA) requirement was relaxed for values up to Rs.2,000/- per transaction for card transactions in contactless mode at Points of Sale (PoS) terminals.
- The present COVID-19 pandemic has underlined the benefits of contactless transactions. Keeping this in view and based on stakeholder feedback. Given the sufficient protection available to users, it has been decided to increase the per transaction limit to Rs.5,000/-. All other requirements, including the discretion of cardholder to use contactless or contact mode of transaction, shall continue to remain applicable, as hitherto.

### **PERPETUAL VALIDITY FOR CERTIFICATE OF AUTHORISATION (COA) ISSUED TO PAYMENT SYSTEM OPERATORS (PSOs) UNDER PAYMENT AND SETTLEMENT SYSTEMS ACT, 2007 (PSS ACT)**

- Currently, RBI grants authorisation to new entities desirous of operating a payment system for specified periods up to five years. Similar approach is adopted for renewal of validity of authorisation to existing entities.
- To reduce licensing uncertainties and enable PSOs to focus on their business as also to optimize utilisation of regulatory resources, it has been decided to, hereafter, grant authorisation for all PSOs (both new and existing) on a perpetual basis, subject to the usual conditions.
- Existing PSOs who do not satisfy all conditions will be given one-year renewals to enable them to comply; if any entity fails to do so in a reasonable time, its authorisation may be withdrawn.

### **AUTHORISATION OF ENTITIES FOR OPERATING A PAYMENT SYSTEM UNDER THE PAYMENT AND SETTLEMENT SYSTEMS ACT, 2007 (PSS ACT) – INTRODUCTION OF COOLING PERIOD**

- To inculcate discipline and encourage submission of applications by serious players as also for effective utilisation of regulatory resources, it has been decided to introduce the concept of Cooling Period in the following situations –
  - Authorised Payment System Operators (PSOs) whose Certificate of Authorisation (CoA) is revoked or not-renewed for any reason; or
  - CoA is voluntarily surrendered for any reason; or
  - Application for authorisation of a payment system has been rejected by RBI.
  - New entities that are set-up by promoters involved in any of the above categories; definition of promoters for the purpose, shall be as defined in the Companies Act, 2013.
- The Cooling Period shall be for one year from the date of revocation / non-renewal / acceptance of voluntary surrender / rejection of application, as the case may be.
- During the Cooling Period, entities shall be prohibited from submission of applications for operating any payment system under the PSS Act.



## DECLARATION OF DIVIDENDS BY BANKS

- In view of the ongoing stress and heightened uncertainty on account of COVID-19, it is imperative that banks continue to conserve capital to support the economy and absorb losses.
- It has been decided that banks shall not make any dividend payment on equity shares from the profits pertaining to the financial year ended March 31, 2020.

## PROCESSING OF E-MANDATES FOR RECURRING TRANSACTIONS

- Relaxation in Additional Factor of Authentication (AFA) was permitted while processing e-mandates / standing instructions on cards and Prepaid Payment Instruments (PPIs) for recurring transactions with values up to Rs.2,000/-, subject to conditions listed therein. These instructions were later extended to Unified Payments Interface (UPI) as well.
- It has been decided to increase the above limit for AFA relaxation to Rs.5,000/- per transaction, with effect from January 1, 2021.

## INTRODUCTION OF LIQUIDITY ADJUSTMENT FACILITY (LAF) AND MARGINAL STANDING FACILITY (MSF) FOR REGIONAL RURAL BANKS (RRBS)

- In order to provide an additional avenue for liquidity management to Regional Rural Banks (RRBs), it has been decided that Liquidity Adjustment Facility (LAF) and Marginal Standing Facility (MSF) will be extended to Scheduled RRBs meeting the following criteria:
  - Implemented Core Banking Solution (CBS)
  - There is a minimum CRAR of nine per cent and
  - Fully compliant with the terms and conditions for availing LAF and MSF issued by Financial Markets Operations Department (FMOD), Reserve Bank of India.

## EXTERNAL TRADE – FACILITATION EXPORT OF GOODS AND SERVICES

### EXTERNAL TRADE – FACILITATION - EXPORT OF GOODS AND SERVICES

- A.P. (DIR Series) Circular No. 8 “External Trade-Facilitation-Export of Goods and Services” issued by the Reserve Bank of India (RBI) on 4 December 2020 and effective as from that date further liberalizes policies governing export transactions.
- The circular delegates additional powers to authorized dealer (AD) banks including the authority to write-off unrealized export bills, set-off export receivables against import payables, and refund export proceeds.
- This is the latest in a series of measures relating to external trade announced by the RBI to enhance export competitiveness and help Indian exporters and importers.

## **“WRITE-OFF” OF UNREALIZED EXPORT BILLS**

- Previously, AD banks were authorized to allow the write-off of unrealized export bills up to specified limits, above which the banks were required to seek directions from the RBI.
- To simplify the procedure, lessen the time taken to obtain approvals, and hence reduce the regulatory cost, the RBI has delegated to the AD banks the power to write-off export receivables without any limit in specified circumstances, namely where the:
  - Overseas buyer has become insolvent;
  - Settlement of the export proceeds to be received has been made via the Indian embassy, Foreign Chamber of Commerce, or a similar organization; or
  - Goods have been destroyed by the port, customs, or health authorities in the importing country.

## **SET-OFF OF EXPORT RECEIVABLES AGAINST IMPORT PAYABLES**

- Previously, AD banks were able to allow exporters/importers to set-off their outstanding export receivables against outstanding import payables from/to the same overseas buyer/supplier.
- The RBI has allowed AD banks to approve requests from Indian exporters/importers to set-off export receivables against import payables in respect of goods and services with overseas group or associated companies, either on a net or gross basis, via an in-house or outsourced centralized settlement arrangement.
- The arrangement must be established and overseen by a single AD bank. Set-off of export receivables for goods against import payables for services, and vice versa, is not permitted.

## **REFUND OF EXPORT PROCEEDS**

- AD banks through whom the export proceeds were originally realized have been able to consider requests for refunds of export proceeds of goods exported from India and reimported on account of poor quality.
- The circular permits AD banks to consider refund requests without insisting on reimportation of goods that have been auctioned or destroyed by the port, customs, or health authorities, or another accredited agency in the importing country, subject to production of documentary evidence and compliance with the conditions specified in the circular.

## **REGIONAL RURAL BANKS - ACCESS TO CALL/NOTICE/TERM MONEY MARKET**

- It has been announced that Regional Rural Banks (RRBs) shall be permitted to participate in the call/notice/term money market.
- Accordingly, RRBs shall be permitted to participate in the call/notice and term money markets both as borrowers and lenders.



## OPENING OF CURRENT ACCOUNTS BY BANKS - NEED FOR DISCIPLINE

- On a review, it has been decided to permit banks to open specific accounts which are stipulated under various statutes and instructions of other regulators/ regulatory departments, without any restrictions placed in terms
  - Accounts for real estate projects mandated under Section 4 (2) I (D) of the Real Estate (Regulation and Development) Act, 2016 for the purpose of maintaining 70% of advance payments collected from the home buyers.
  - Nodal or escrow accounts of payment aggregators/prepaid payment instrument issuers for specific activities as permitted by Department of Payments and Settlement Systems (DPSS), Reserve Bank of India under Payment and Settlement Systems Act, 2007.
  - Accounts for settlement of dues related to debit card/ATM card/credit card issuers/acquirers.
  - Accounts permitted under FEMA, 1999.
  - Accounts for the purpose of IPO / NFO /FPO/ share buyback /dividend payment / issuance of commercial papers/allotment of debentures/gratuity, etc. which are mandated by respective statutes or regulators and are meant for specific/limited transactions only.
  - Accounts for payment of taxes, duties, statutory dues, etc. opened with banks authorized to collect the same, for borrowers of such banks which are not authorized to collect such taxes, duties, statutory dues, etc.
  - Accounts of White Label ATM Operators and their agents for sourcing of currency.

## AMENDMENT TO MASTER DIRECTION (MD) ON KYC– ROLL OUT OF LEGAL ENTITY TEMPLATE & OTHER CHANGES

- The Reserve Bank of India (RBI) on Friday extended the applicability of centralized know your customer (KYC) registry to legal entities, from individual accounts, effective 1 April 2021.
- Banks, non-banks, and other entities regulated by RBI have been uploading the KYC data pertaining to all individual accounts opened on or after 1 January 2017 on to the centralized KYC registry (CKYCR).

- RBI has also ordered to stop sourcing new credit cards to the customers and has asked the board members of HDFC Bank to examine the lapses and fix the accountability.

### ADB AND INDIA SIGNS LOAN AGREEMENT FOR WEST BENGAL

- The Asian Development Bank (ADB) and the GOI has signed a loan agreement to improve financial management procedures and operational efficiencies in West Bengal.
- They have signed a loan agreement of \$50 million.
- The loan amount will be utilized under the project titled 'West Bengal Public Finance Management Investment Programme'.

### RBI'S MONETARY POLICY COMMITTEE MEET

- RBI has decided to keep interest rates unchanged for the third time in a row and has maintained the policy stance at 'accommodative'.

**Lack of Wi-Fi hotspots:** The biggest challenge facing the Digital India program is the delay in infrastructure development. According to an estimate, India will need more than 8 million Wi-Fi hotspots for better internet connectivity, while their availability is very less at the moment.

- **Digital Gap:** Digital India needs to end the digital gap by providing adequate connectivity even in remote villages. There are still more than 50 thousand villages in the country where mobile connectivity is not available. There is a need to take initiative to strengthen the infrastructure of digital services in rural areas to remove the digital gap between villages and cities.
- **Policy Constraints:** Some issues related to taxation and other regulatory guidelines also become obstacles in the path of Digital India. One of the common policy hurdles is the lack of clarity in FDI policies that have affected the growth of the e-commerce sector. Due to ambiguity in the policy framework, transport service companies like Uber and Ola are frequently in dispute with local governments.

- Factors such as technical feasibility, lack of physical infrastructure and standardisation combined with archaic laws and policies need to be addressed on priority.
- The central as well as state governments have realised this and have made a spate of announcements that aim to improve the functioning of PPP projects.

## GOVERNMENT'S INITIATIVES:

### BHARATNET

- The BharatNet project aimed to provide broadband connectivity at a speed of 100 Mbps to more than 2.5 lakh gram panchayats through a gigabyte passive optical network developed in the country by the end of 2018.
- It is the largest digital connectivity project in the world and is specialized in many dimensions, which will provide reliable and quality broadband connectivity in rural areas.

### DIGITAL VILLAGE SCHEME

- This is a new scheme for villages and in its first phase, a target has been set to digitalize 5 thousand villages in a year. The following standards have been set for digital villages, on the basis of which a village can be declared digital.

### TELE-MEDICINE SERVICE:

- Under this, the nearest primary health center of the village will be digitally connected to that village.
- Through this, health facilities will be made available to patients and their families digitally and online advice will also be provided.

### TELE-EDUCATION SERVICE:

- All the schools in the village will be provided with the facility of online education in addition to the school, as well as online classes for children.

### WI-FI HOTSPOT SERVICE:

- It will be necessary to have a mobile Wi-Fi hotspot. At least 5 hours of free Wi-Fi facility will be available every day.

### SKILL DEVELOPMENT:

- A permanent skill development team will work in every village, which will help the villagers in digital work.

## THE CONCLUSION:

- The nature of Digital India is transformative and this is ensuring that government services are available to citizens electronically. The Digital India program aims to transform India into a knowledge-based economy by taking advantage of information technology as a growth engine of a new India and a new India as a growth engine.

- With this, public accountability is also being ensured by making government and administrative services accessible to the common people. While India is considered a software superpower, availability of electronic government services to citizens is still relatively low. There needs to be more emphasis on ensuring effective progress in electronics manufacturing and e-governance in the country. - Cleanliness rankings are being conducted in league format for the first time. It is worth noting that the ranking has been divided into three categories based on three quarters (April to June, July to September and October to December, 2019) and the population of the city. It is noteworthy that this survey was started in June, 2019. Indore and Jamshedpur topped the cleanliness chart in the categories of cities with more than 10 lakh population and cities with population of 1 lakh to 10 lakh respectively in two consecutive quarters.

According to the new version of the recently released Global Multidimensional Poverty Index- MPI, India's poverty rate has fallen from 55 % to 28 % between 2005-06 and 2015-16.

- The index has been developed by the United Nations Development Program (UNDP) and the Oxford Poverty and Human Development Initiative (Oxford Poverty and Human Development Initiative- OPHI).
- During 2005-06 to 2015-16, India's poorest sections such as Muslims and Scheduled Tribes contributed the most to reduce poverty.
- A total of 271 million (27.10 crore) people in India came out of the poverty index during these ten years.
- This index is based on a list prepared on 10 dimensions of deprivation. In which deprivation has been taken mainly for health facilities, education and standard of living.
- The MPI measures multidimensional poverty, which includes people who are facing a variety of shortages, for example those who are undernourished and who do not have safe drinking water, adequate sanitation and clean fuel.

## STATUS OF INDIA

- The report said that Alirajpur district of Madhya Pradesh is the poorest among 640 districts in India, where 76.5 percent of people according to MPI are poor.
- The states have significantly improved MPI in Jharkhand along with Arunachal Pradesh, Bihar, Chhattisgarh, and Nagaland.

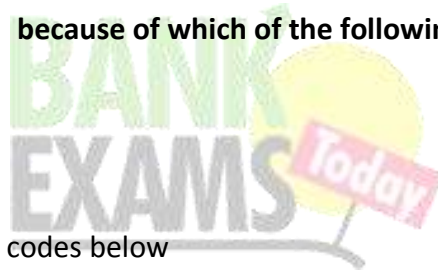

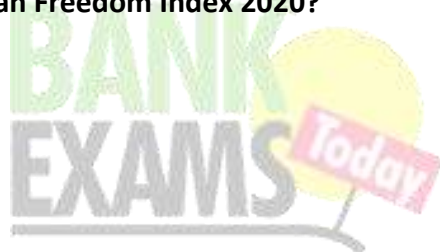

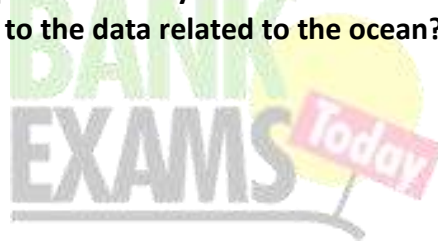
