RBI NOTIFICATIONS: SEPTEMBER 2018

AMENDMENTS TO RESERVE BANK OF INDIA (NOTE REFUND) RULES, 2009

NOTIFICATION

- Reserve Bank of India has made amendments to the Reserve Bank of India (Note Refund) Rules, 2009
 to enable the public to exchange mutilated notes in Mahatma Gandhi (New) series at bank branches
 and RBI offices(which are smaller in size compared to the earlier series).
- There is a change in the minimum area of the single largest undivided piece of the note required for payment of full value for notes of rupees fifty and above denominations, which is detailed in the amendments.

SUMMARY OF THE RESERVE BANK OF INDIA (NOTE REFUND) AMENDMENT RULES, 2018

FOR RS 50, RS 100 RS 200, RS 500:

To get a full refund of Rs 50, Rs 100 Rs 200 and Rs 500 notes, a note must be composed of 2 pieces which individually have an area equal to or more than 40% of total area of note in that denomination.

FOR RS 2000 NOTES:

The value of a mutilated note of Rs 2000 denomination may be refunded in full or half depending upon the case. For a full refund, the minimum undivided area of the single largest piece of the note should be 88 square. For a half refund, the area should not be less than 44 square cm.

EXTERNAL COMMERCIAL BORROWINGS (ECB) POLICY - LIBERALISATION

NOTIFICATION

It has been decided, in consultation with the Government of India, to liberalise some aspects of the ECB policy including policy on Rupee denominated bonds as indicated below:

(I) ECBS BY COMPANIES IN MANUFACTURING SECTOR:

- As per the extant norms, ECB up to USD 50 million or its equivalent can be raised by eligible borrowers with minimum average maturity period of 3 years.
- It has been decided to allow eligible ECB borrowers who are into manufacturing sector to raise ECB up to USD 50 million or its equivalent with minimum average maturity period of 1 year.

(II) UNDERWRITING AND MARKET MAKING BY INDIAN BANKS FOR RUPEE DENOMINATED BONDS (RDB) ISSUED OVERSEAS:

- Presently, Indian banks, subject to applicable prudential norms, can act as arranger and underwriter
 for RDBs issued overseas and in case of underwriting an issue, their holding cannot be more than 5 per
 cent of the issue size after 6 months of issue.
- It has now been decided to permit Indian banks to participate as arrangers/underwriters/market makers/traders in RDBs issued overseas subject to applicable prudential norms.

IMPORTANT TERMS

RUPEE DENOMINATED BONDS (RDB)

- A rupee denominated bond is a bond issued by an Indian entity in foreign markets and the interest payments and principal reimbursements are denominated (expressed) in rupees.
- The peculiarity of rupee denominated bond is that buying of bonds, interest payments and repayment all are expressed in rupees. All payments are converted into corresponding dollar values at the time of payment.
- The term 'masala bond' is also used to describe rupee denominated ever since the first issuer of rupeedenominated bonds used the name masala bonds in its first issue. RBI in its August 2016 regulations also used this name.

EXTERNAL COMMERCIAL BORROWINGS

- ECB is basically a loan availed by an Indian entity from a nonresident lender. Most of these loans are provided by foreign commercial banks and other institutions. It is a loan availed of from non-resident lenders with a minimum average maturity of 3 years.
- The significance of ECBs their size in India's balance of payment account. In the post reform period,
 ECBs have emerged a major form of foreign capital like FDI and FII.
- External Commercial Borrowings (ECBs) includes commercial bank loans, buyers' credit, suppliers'
 credit, securitized instruments such as Floating Rate Notes and Fixed Rate Bonds etc., credit from
 official export credit agencies and commercial borrowings from Multilateral Financial Institutions.
- ECBs are being permitted by the Government as a source of finance for Indian Corporate for expansion of existing capacity as well as for fresh investment. Following are the advantages of ECBs.

CO-ORIGINATION OF LOANS BY BANKS AND NBFCS FOR LENDING TO PRIORITY SECTOR

NOTIFICATION

- The Reserve Bank of India (RBI) has released the guidelines on co-orgination of loans by banks and non-deposit taking non-banking financial companies (NBFCs) in the priority sector.
- The move is aimed at leveraging the reach of NBFCs to help banks meet their priority sector lending targets, leveraging the reach of NBFCs.
- Under the new guidelines, NBFCs will take minimum 20% of the credit risk by way of direct exposure, with the balance being taken by banks.
- According to the RBI, the NBFC will have to give an undertaking to the bank that its contribution towards the loan amount is not funded out of borrowing from the co-originating bank or any other group company of the partner bank.
- In cases of grievance redressal, the NBFC has to explain to the borrower the difference between products offered through the co-origination model as compared to its own products. The lender will be primarily responsible for providing the customer service and grievance redressal to the borrower.
- In case the complaint is not resolved within 30 days, the borrower would have the option to escalate the same with banking ombudsman/ombudsman for NBFCs, concerned.
- Both the lenders will follow independent provisioning requirements and create a framework for day to day monitoring and recovery of the loan, the guidelines state.
- Banks will follow the old system while NBFCs will follow IndAS.

IMPORTANT TERMS

PRIORITY SECTOR LENDING NORMS BY THE RBI

- Priority sector lending (PSL) is aimed to provide institutional credit to those sectors and segments for whom it is difficult to get credit. According to priority sector norms, scheduled commercial banks have to give 40% of their loans (measured in terms of Adjusted Net Bank Credit or ANBC) to the identified priority sectors in accordance with the RBI regulations.
- The regulations are modified periodically by setting limits for subsectors and other qualifications for the beneficiary groups. If these targets are not realized, banks have to finance the development programmes implemented by the government for the concerned sectors.

• In April 2016, RBI has introduced Priority Sector Lending Certificates so that banks can trade the loan certificates given to the different sectors to meet their targets.

INDAS(INDIAN ACCOUNTING STANDARDS)

- Indian Accounting Standard (abbreviated as Ind-AS) is the Accounting standard adopted by companies
 in India and issued under the supervison of Accounting Standards Board (ASB) which was constituted
 as a body in the year 1977.
- ASB is a committee under Institute of Chartered Accountants of India (ICAI) which consists of representatives from government department, academicians, other professional bodies viz. ICAI, representatives from ASSOCHAM, CII, FICCI, etc.
- The Ind AS are named and numbered in the same way as the International Financial Reporting Standards (IFRS). National Advisory Committee on Accounting Standards (NACAS) recommend these standards to the Ministry of Corporate Affairs (MCA). MCA has to spell out the accounting standards applicable for companies in India.
- As on date MCA has notified 41 Ind AS. This shall be applied to the companies of financial year 2015-16 voluntarily and from 2016-17 on a mandatory basis.
- Based on the international consensus, the regulators will separately notify the date of implementation of Ind-AS for the banks, insurance companies etc. Standards for the computation of Tax has been notified as ICDS in February 2015.

BASEL III FRAMEWORK ON LIQUIDITY STANDARDS - LIQUIDITY COVERAGE RATIO (LCR), LIQUIDITY RISK MONITORING TOOLS AND LCR DISCLOSURE STANDARDS

NOTIFICATION

- Presently, the assets allowed for the purpose of computing the LCR of banks, inter alia, include (a)
 Government securities in excess of the minimum SLR requirement and, (b) within the mandatory SLR
 requirement, (i) Government securities to the extent allowed by RBI under Marginal Standing Facility
 (MSF) [presently 2 per cent of the bank's NDTL] and (ii) under Facility to Avail Liquidity for Liquidity
 Coverage Ratio (FALLCR) [presently 11 per cent of the bank's NDTL].
- It has been decided to permit banks with effect from October 1, 2018, to reckon Government securities held by them up to another 2 per cent of their NDTL, under FALLCR within the mandatory SLR requirement.
- For the purpose of LCR, banks shall continue to value such government securities reckoned as HQLA at an amount not greater than their current market value.

IMPORTANT TERMS

LIQUIDITY COVERAGE RATIO - LCR

• The liquidity coverage ratio (LCR) refers to highly liquid assets held by financial institutions to meet short-term obligations. The ratio is a generic stress test that aims to anticipate market-wide shocks. The LCR assures that financial institutions have the necessary assets on hand to ride out any short-term liquidity disruptions.

VOLUNTARY TRANSITION OF PRIMARY (URBAN) CO-OPERATIVE BANKS (UCBS) INTO SMALL FINANCE BANKS (SFBS)

- According to the RBI, Urban cooperative Banks (UCBs) interested in voluntary conversion into small
 finance banks (SFB) will have to first promote a public limited company and then transfer its assets and
 liabilities into that new entity.
- According to the guidelines issued by the Reserve Bank of India, eligible UCB shall identify promoters for making an application to RBI for transition.
- After due diligence exercise, RBI will issue an in-principle approval for transitioning of the UCB into SFB for which the regulator will allow a maximum period of 18 months to start a business as Small Finance Bank.
- RBI has said that the promoters will have to incorporate a public limited company under the Companies Act, 2013 having the word 'bank' in its name after receiving the in-principle approval from RB and its board should meet RBI's 'fit and proper' criteria.
- The promoters can then seek a licence with evidence of equity funds.
- The SFB has to start operations with a minimum net worth of Rs.1 billion and minimum promoters' contribution of 26% of the paid-up equity capital.
- RBI will issue SFB licence after the execution of sale agreement to transfer the assets and liabilities of the UCB to the new company. The licence will be effective only after transfer of assets and liabilities of the UCB to the SFB and meeting the minimum net worth requirement.

IMPORTANT TERMS

URBAN COOPERATIVE BANK (UCB)

A cooperative bank located in urban/semi-urban centre is known as Urban Cooperative Bank (UCB).
 These banks are essentially formed to finance small business. A major difference between the UCBs and the commercial banks is in the nature of the organisational ownership.

- Usually a cooperative society is formed around communities, localities or small groups with a common interest. Cooperative banks work on the basis of mutual benefit. Therefore they can lend only to the members of the society though they can borrow/accept deposits from the general public.
- While the commercial banks are registered under the Companies Act, the UCBs are registered as
 cooperative societies. As such the rules and regulations as applicable to societies would be operative in
 UCBs as far as the ownership is concerned.
- However, with the entry of commercial banks in a big way in financing the small borrowers and small businesses, the distinction between them and the UCBs in the market segments in which they operate is getting blurred.

AUCTION OF GOVERNMENT OF INDIA DATED SECURITIES

NOTIFICATION

- Government of India has offered to sell (re-issue) four dated securities for notified amount of Rs.
 12,000 crore
- The auction for securities will be price based using multiple price method. The Reserve Bank of India at Mumbai will conduct the auctions.
- Both competitive and non-competitive bids for the auction should be submitted in electronic format on the Reserve Bank of India Core Banking Solution (E-Kuber) system.
- An investor can submit more than one competitive bid at different prices in electronic format on the Reserve Bank of India Core Banking Solution (E-Kuber) system. However, the aggregate amount of bids submitted by a person in an auction should not exceed the notified amount of auction.

IMPORTANT TERMS

DATED GOVERNMENT SECURITIES

- Dated Government Securities are longer term securities and carry a fixed or floating coupon (interest rate) paid on the face value, payable at fixed time periods (usually half-yearly).
- The Public Debt Office (PDO) of the RBI acts as the registry/depository of Government securities and deals with the issue, interest payment and repayment of principal at maturity.
- Most of the dated securities are fixed coupon securities.
- The nomenclature of a typical dated fixed coupon Government security has the following featurescoupon, name of the issuer, maturity and face value.

DIFFERENT TYPES OF GOVERNMENT DATED SECURITIES

- Zero Coupon Bonds
- Floating Rate Bond
- Tap Stock
- Partly Paid Stock
- Capital Indexed Bonds
- Inflation linked Bonds
- Fixed Rate Bonds

NON-COMPETITIVE BIDDING FACILITY

To encourage retail participation in the primary market for Government Securities, the facility of non-competitive bidding in Dated Government Securities and Treasury Bills auctions has been introduced. This will enable the investor to purchase a specified number of securities at the weighted average rate of the accepted competitive bids.

1. Who can participate in the Scheme?

Participation in the Scheme of non-competitive bidding is open to retail investors. Retail investor is any person including individuals, firms, companies, corporate bodies, institutions, provident funds, trusts and any other entity as prescribed by RBI.

2. Will non-competitive bidding be allowed in all auctions?

No. It will be decided by the RBI, on particular basis.

E-KUBER

- e-Kuber is the Core Banking Solution of Reserve Bank of India. E-Kuber provides the provision of a single current account for each bank across the country, with decentralised access to this account from anywhere-anytime using portal based services in a safe manner.
- Core Banking Solutions (CBS) can be defined as a solution that enables banks to offer a multitude of
 customer-centric services on a 24x7 basis from a single location, supporting retail as well as corporate
 banking activities, as well as all possible delivery channels existing and proposed. The centralisation
 thus makes a "one-stop" shop for financial services a reality. Using CBS, customers can access their
 accounts from any branch, anywhere, irrespective of where they have physically opened their
 accounts. Almost all branches of commercial banks, including the Regional Rural Banks (RRBs), are
 brought into the core-banking fold.
- Core Banking Solutions (CBS) marked a paradigm shift as it made a bank's particular branch customers, now bank customers as they can access their accounts from any branch for defined purposes. CBS links all branches of a bank and offers opportunities for information management, better customer service and improved risk management.

- e-Kuber enables ease of operations. The system also benefits state /central Governments as users.
 Some of the facilities offered include the provision of portal based access which allows Government departments to access on anywhere-anytime basis and view their balances of all types including the Ways and Means Advances, drawings, funds positions and the like all in a consolidated manner so as to help them in better funds management. The capability of consolidating revenue collections by banks through the e-Kuber offers the potential for better flexibility for the Government in managing its finances apart from moving over towards higher levels of electronic banking.
- The e-kuber system can be accessed either through INFINET or Internet. The INFINET is a Closed User Group Network for the exclusive use of member banks and financial institutions and is the communication backbone for the National Payments System, which caters mainly to inter-bank applications like Real Time Gross Settlement (RTGS), Delivery Vs Payment, Government Transactions, Automatic Clearing House, etc.
- The e-kuber system, implemented in 2012, is reported to be one of the foremost central bank oriented Core Banking Systems in the world.
- Auction of Government securities is done through e-kuber system. Sovereign Gold Bonds are available
 for subscription at the branches of scheduled commercial banks and designated post offices through
 RBI's e-kuber system. Goods and Service Tax (GST) settlements are also proposed to be done through
 e-kuber. On 7 April 2016, RBI launched a platform to enable trading in the priority sector lending
 certificates (PSLC) through its Core Banking Solution (CBS) portal (e-Kuber).

AUCTION FOR SALE (RE-ISSUE) OF GOVERNMENT STOCK (GS)

NOTIFICATION

- Government of India(GoI) notifies sale (re-issue) of the Government Stocks.
- Subject to the limit of ₹12000 Cr, being total notified amount, GoI will have the option to retain additional subscription up to ₹1000 Cr each against any one or more of the above securities. The sale will be subject to the terms and conditions spelt out in this notification (called 'Specific Notification').
- The Government Stock up to 5% of the notified amount of the sale will be allotted to eligible
 individuals and institutions as per the enclosed Scheme for Non-competitive Bidding Facility in the
 Auctions of Government Securities.

IMPORTANT TERMS

GOVERNMENT STOCKS/BONDS/SECURITIES?

One of the bonds sold by a government to finance its budget deficit (the difference between what it
gets in taxes and what it spends). Government bonds are usually considered to be a very safe form of

investment.

- A government security is a bond issued by a government authority with a promise of repayment upon maturity. Government securities such as savings bonds, treasury bills and notes also promise periodic coupon or interest payments. These securities are considered low-risk, since they are backed by the taxing power of the government.
- The terms on which a government can sell bonds depend on how creditworthy the market considers it to be. International credit rating agencies will provide ratings for the bonds, but market participants will make up their own minds about this.
