SEBI CIRCULARS: MARCH – JULY 2020

RELAXATIONS DUE TO THE IMPACT OF COVID 19

- ILDS (Issue and Listing of Debt Securities) Regulations, NCRPS (Non-Convertible Redeemable Preference Shares) Regulations, and circulars related to Listing of Commercial Papers (CPs) require an Issuer to inter-alia submit its latest audited financials which should not be older than six months.
- Due to the COVID pandemic, SEBI extended the timelines for submission of financial results for the quarter/halfyear/annual financial year for the period ending March 31, 2020, till July 31, 2020.
- SEBI has permitted listed Issuers who have issued NCDs/NCRPS/CPs, on or after July 01, 2020, and intend/propose to list such issued NCDs/NCRPS/CPs, on or before July 31, 2020, to use available financials as on December 31, 2019.
- In March 2020 due to the impact of COVID 19, SEBI had extended the timelines for issuers of Municipal Debt Securities up to June 30, 2020. SEBI has now decided to further extend these timelines to July 31, 2020.
- SEBI had specified guidelines regarding Margin obligations to be given by way of Pledge/ Re-pledge in the Depository System. The provisions of this circular were to come into effect from June 01, 2020. Due to the impact of COVID 19, it has been decided to extend the implementation date of the provision to August 01, 2020.
- SEBI has extended the date of implementation of the Review of Margin Framework for Cash and Derivatives segments (except for Commodity Derivatives Segment) from 1 May 2020 to 1, June 2020.
- If the valuation agencies appointed by AMFI (Association of Mutual Funds In India) are of the view that the delay
 in payment of interest/principal or extension of the maturity of security by the issuer has arisen solely due to
 COVID-19 pandemic lockdown and/or in light of the moratorium permitted by Reserve Bank of India (RBI)
 creating temporary operational challenges in servicing debt, then valuation agencies may not consider the same
 as a default for the purpose of valuation of money market or debt securities held by Mutual Funds.
- SEBI had introduced a Stewardship Code for all Mutual Funds and all categories of AIFs, in relation to their investment in listed equities. The Code was to come into effect from April 1, 2020. Due to the impact of COVID 19, it has been decided to extend the implementation date of the provision to July 01, 2020

TRANSACTION IN CORPORATE BONDS/COMMERCIAL PAPERS THROUGH RFQ (REQUEST FOR QUOTE) PLATFORM AND ENHANCING TRANSPARENCY ABOUT DEBT SCHEMES

- Mutual Funds shall undertake at least 10% of their total secondary market trades by value (excluding Inter Scheme Transfer trades) in the Corporate Bonds by placing/seeking quotes through one-to-many mode on the Request for Quote (RFQ) platform of stock exchanges.
- The percentage as specified shall be reckoned on the average of secondary trades by value in immediately preceding three months.

• This will be effective from October 1, 2020.

CIRCULAR ON LISTING OF MUTUAL FUND SCHEMES THAT ARE IN THE PROCESS OF WINDING UP

- Currently, every close-ended scheme and units of the segregated portfolio shall be listed on recognized stock exchanges.
- The units of Mutual Fund schemes which are in the process of winding-up shall be listed on recognized stock exchange, subject to compliance with listing formalities as stipulated by the stock exchange.
- Trading in units of such a listed scheme that is under the process of winding up shall be in dematerialized form.
- The AMC, its sponsor, employees of AMC, and Trustee shall not be permitted to transact (buy or sell) in the units of such schemes that are under the process of being wound up. The compliance of the same shall be monitored both by the Board of AMC and Trustee.

RBI NOTIFICATIONS: JULY 2020

IMPLEMENTATION OF INDIAN ACCOUNTING STANDARDS (IND AS)

- The Indian Accounting Standards (Ind AS), as notified under section 133 of the Companies Act 2013, are set of accounting principles that are in line with the IFRS (International Financial Reporting Standards) Standards. Ind AS will ensure that the financial statements of Indian companies are in line with global standards.
- As per Ind AS, any net unrealized gains arising on fair valuation of financial instruments, should not be included in owned funds whereas all such net losses should be considered.
- RBI has decided that the unrealized gain/loss on a derivative transaction undertaken for hedging may be offset
 against the unrealized loss/gain recognized in the capital on the corresponding underlying instrument. If after
 such offset and netting with unrealized gains/losses on other financial instruments, there are still net unrealized
 gains, the same should be excluded from regulatory capital.

FAIR PRACTICES CODE FOR ASSET RECONSTRUCTION COMPANIES (ARC)

• An Asset Reconstruction Company (ARC) is a financial institution that buys the NPAs or bad assets from banks and financial institutions so that the banks and financial institutions can clean up their balance sheets.

- In order to achieve the highest standards of transparency and fairness in dealing with stakeholders, Asset Reconstruction Companies (ARCs) are advised to put in place Fair Practices Code (FPC) duly approved by their Board. The following points are the minimum criteria in the Fair Practice Code of the ARC:
 - ✓ ARC shall follow transparent and non-discriminatory practices in the acquisition of assets
 - ✓ The process of selling assets should enable the participation of as many prospective buyers as possible to ensure transparency in the process.
 - ✓ ARCs shall release all securities on repayment of dues or on the realization of the outstanding amount of loan, subject to any other legitimate claim they may have against the borrower.
 - ✓ ARCs should have a Board approved policy on the management fee, expenses, and incentives.
 - ✓ ARCs intending to outsource any of their activity shall put in place a comprehensive outsourcing policy, approved by the Board. It should ensure that outsourcing arrangements neither diminish its ability to fulfill its obligations to customers and the RBI nor impede effective supervision by RBI.
 - ✓ ARCs shall not resort to harassment of the debtor for the recovery of loans.
 - ✓ ARCs are responsible for the actions of their Recovery Agents and they should have a Board approved Code of Conduct for Recovery Agents and obtain their undertaking to abide by that Code.
 - ✓ ARCs should constitute Grievance Redressal machinery within the organization
 - ✓ ARCs shall keep the information strictly confidential and shall not disclose it to anyone including other companies in the group except when required by law or there is a duty towards the public to reveal information or there is a borrower's permission.
 - ✓ The Board should periodically review compliance of the ARC with the Fair Practice Code.

CREDIT FLOW TO MICRO, SMALL AND MEDIUM ENTERPRISES SECTOR

• The Government of India has notified new criteria for classifying the enterprises as Micro, Small, and Medium enterprises. The new criteria will come into effect from July 1, 2020. The details are as following:

CLASSIFICATION OF ENTERPRISES

- An enterprise shall be classified as a Micro, Small or Medium enterprise based on the following criteria:
 - Micro Enterprise: The investment in plant and machinery or equipment does not exceed one crore rupees and turnover does not exceed five crore rupees.
 - ✓ Small Enterprise: The investment in plant and machinery or equipment does not exceed ten crore rupees and turnover does not exceed fifty crore rupees.
 - ✓ Medium Enterprise: The investment in plant and machinery or equipment does not exceed fifty crore rupees and turnover does not exceed two hundred and fifty crore rupees

COMPOSITE CRITERIA OF INVESTMENT AND TURNOVER FOR CLASSIFICATION

- If an enterprise crosses the ceiling limits specified for its present category in either of the two criteria of investment or turnover, it will cease to exist in that category and be placed in the next higher category.
- No enterprise shall be placed in the lower category unless it goes below the ceiling limits specified for its present category in both the criteria of investment as well as turnover.
- All units with Goods and Services Tax Identification Number (GSTIN) listed against the same Permanent Account Number (PAN) shall be collectively treated as one enterprise and the turnover and investment figures for all of such entities shall be seen together and only the aggregate values will be considered for deciding the category as a micro, small or medium enterprise.

CALCULATION OF INVESTMENT IN PLANT AND MACHINERY OR EQUIPMENT

- The calculation of investment in plant and machinery or equipment will be linked to the Income Tax Return (ITR) of the previous years filed under the Income Tax Act, 1961.
- In case of a new enterprise, where no prior ITR is available, the investment will be based on self-declaration of the promoter of the enterprise and such relaxation shall end after the 31st March of the financial year in which it files its first ITR.
- Plant and machinery or equipment of the enterprise shall include all tangible assets (other than land and building, furniture, and fittings).
- The purchase (invoice) value of a plant and machinery or equipment, whether purchased first hand or second hand, shall be taken into account excluding Goods and Services Tax (GST), on self-disclosure basis, if the enterprise is a new one without any ITR.

CALCULATION OF TURNOVER

- Exports of goods or services or both shall be excluded while calculating the turnover of any enterprise whether micro, small or medium, for classification.
- Information related to turnover and export turnover for an enterprise shall be linked to the Income Tax Act or the Central Goods and Services Act (CGST Act) and the GSTIN.
- The turnover figures of enterprise which do not have PAN will be considered on a self-declaration basis for a
 period up to 31st March 2021 and thereafter, PAN and GSTIN shall be mandatory.

In case of an upward change in investment in plant and machinery or equipment or turnover or both, and consequent re-classification, an enterprise will maintain its prevailing status till the expiry of one year from the close of the year of registration. Also, in case of a downward change of an enterprise, the enterprise will continue in its present category until the closure of the financial year.

SPECIAL LIQUIDITY SCHEME FOR NBFCS/HFCS

- The Government of India has approved a scheme to improve the liquidity position of NBFCs/HFCs through a Special Purpose Vehicle (SPV) to avoid any potential systemic risks to the financial sector. **To be eligible under the Scheme, the following conditions should be met:**
 - ✓ NBFCs including Microfinance Institutions should be registered with the RBI under the Reserve Bank of India Act, 1934, excluding those registered as Core Investment Companies.
 - ✓ Housing Finance Companies that are registered under the National Housing Bank Act, 1987.
 - ✓ The CRAR (Capital to Risk-Weighted Asset Ratio)/CAR (Capital Adequacy Ratio) of NBFCs/HFCs should not be below the regulatory minimum, i.e., 15% and 12% respectively as on March 31, 2019.
 - ✓ The net non-performing assets of NBFCs/HFCs (Net NPA) should not be more than 6% as of March 31, 2019.
 - ✓ They should have made a net profit in at least one of the last two preceding financial years (i.e. 2017-18 and 2018-19).
 - ✓ They should not have been reported under SMA-1 or SMA-2 (Special Mention Account) category by any bank for their borrowings during the last one year before August 01, 2018.
 - ✓ They should be rated investment grade by a SEBI registered rating agency.
 - ✓ They should comply with the requirement of the SPV for an appropriate level of collateral from the entity, which, however, would be optional and to be decided by the SPV.

- SBI Capital Markets Limited (SBICAP), a subsidiary of the State Bank of India has set up an SPV to manage this operation. The SPV will purchase the short-term papers from eligible NBFCs/HFCs, who shall utilize the proceeds under this scheme solely to extinguish existing liabilities.
- The instruments will be CPs and NCDs with a residual maturity of not more than three months and rated as
 investment grade. The facility will not be available for any paper issued after September 30, 2020, and the SPV
 would cease to make fresh purchases after September 30, 2020, and would recover all dues by December 31,
 2020.

EXEMPTION FROM REGISTRATION AS NBFC – ALTERNATIVE INVESTMENT FUND (AIF)

- Venture capital fund companies, holding a certificate of registration obtained under section 12 of the Securities and Exchange Board of India Act, 1992 (Act 15 of 1992) and not holding or accepting public deposit are exempted from certain provisions of the RBI Act, 1934 and also from the applicability of guidelines issued by the Bank for NBFCs.
- RBI has decided to substitute the word "Venture Capital Fund Companies" with "Alternative Investment Fund Companies", in the exercise of the powers conferred the RBI Act, 1934.

EXTENSION OF THE TIMELINE FOR FINALIZATION OF AUDITED ACCOUNTS - NBFCS

- As per the existing master circular, every applicable NBFC shall finalize its balance sheet within a period of 3 months from the date to which it pertains.
- Due to the impact of COVID 19, RBI has decided that in addition to the above or the NBFCs can finalize its balance sheet within three months of any revised date as notified by SEBI for submission of financial results by listed entities.

REVISED SCHEME OF PENALTIES FOR CURRENCY CHESTS

RBI has issued guidelines for imposing penalty on banks for unsatisfactory services and non-compliance in Currency Chests, the details are as following:

- The Competent Authority to decide the type of irregularity will be the Officer-in-Charge of the Issue Department of the Regional Office under whose jurisdiction the defaulting currency chest/bank branch is located.
- The appeal against the decision of the Competent Authority may be made to the Regional Director/Chief General Manager/Officer-in-Charge of the Regional Office concerned, within one month from the date of debit, who may decide whether the same can be accepted/ rejected.
- Appeals for waiver of penalty made on grounds such as staff being new/untrained, lack of awareness of staff, corrective action having been taken/will be taken, etc. will not be considered.

FITCH FORECASTS INDIA'S GROWTH TO 8% FOR FY 2022

- As per the report, India's growth forecast for the financial year 2021-22 is marked at 8%. Initially, it was marked at 9.5% by the Fitch. However, it has reduced it to 8%.

- Network for Greening the Financial System (NGFS) is a global forum which brings together all the central banks and supervisors around the globe and commits the to manage the financial risks and develop protection and saving opportunities with respect to climate change and environment.

'ZIPDRIVE' INSTANT AUTO LOAN FACILITY-BY HDFC BANK

- HDFC Bank has announced to offer instant auto loan named as 'Zipdrive' to its customers.
- This instant loan facility will be offered to its customers in about 1000 cities i.e. in tier 2 and tier 3 cities of India.
- The Zipdrive loan facility will be offered only for customers with preapproved offers.

INDIAN ECONOMY TO CONTRACT BY 6.4% -- BY CARE RATINGS

- Care (Credit Analysis and Research Limited) Rating has forecasted that Indian Economy to contract 6.4% for the financial year 2020-21.
- This contraction value in GDP is cited because the economic activities are getting continuously hindered due to lockdown situation of COVID-19.
- The rating agency has also expected a positive growth will come from agriculture and government sector.

'BHAVISHYA' SAVING ACCOUNT-BY FINO PAYMENTS BANK LTD

- After Tamil Nadu, the ranking is followed by Maharashtra, Andhra Pradesh and Rajasthan respectively.

7TH SBI BANKING & ECONOMICS CONCLAVE

• RBI Governor Shaktikanta Das addressed the 7th SBI Banking & Economics Conclave.

- The overall capital adequacy ratio for scheduled commercial banks (SCBs) stood at 14.8% as in March 2020, compared to 14.3% in March 2019. The CRAR of PSBs had improved from 12.2% in March 2019 to 13.0 per cent in March 2020.
- The gross NPA ratio and net NPA ratio of SCBs stood at 8.3 % and 2.9% in March 2020, compared to 9.1% and 3.7% as of March 2019, respectively.

PANEL FORMED FOR 'INDIAN PANDEMIC RISK POOL'-- BY IRDAI

- The Insurance Regulatory and Development Authority of India (IRDAI), being the regulatory provider has formed a panel which will examine the degree of convenience of 'Pandemic Risk Pool'.
- The panel will be headed by Suresh Mathur, Executive Director of IRDAI.
- The panel will also study the need of setting up Pandemic Risk Pool, will recommend structure and operating model for the pool and will examine other related matter to the subject.

INDIA: SECOND LARGEST FOREIGN DIRECT INVESTOR IN THE UK

- UK Government has released new data in the Department for International Trade (DIT) inward investment statistics for 2019-2020.
- As per the statistical analysis, India has become the second-largest Foreign Direct Investor in the United Kingdom (UK).
- The list is topped by the United States.

FISCAL DEFICIT TO SHOOT UP TO 7.6 PC IN FY21: IND-RA

- According to a report by India Ratings and Research (Ind-Ra), fiscal deficit of the Centre is expected to increase to 7.6% in FY21 which is twice the Budget estimate.
- This is because the government has spent more to fight against COVID-19.
- If looking at the combined level, the fiscal deficit of the Centre and states together will be 12.1%.
- The contribution of states in this is 4.5%.

INDIAN ECONOMY TO CONTRACT BY 9.5% IN FY21: ICRA

- According to a forecast by the rating agency ICRA, India's GDP growth is estimated to contract by 9.5% in the financial year 2020-21.
- The agency had earlier projected in May that the Indian economy will contract by 5%.
- This increase has been made considering the effect of nationwide lockdown in the country.
- According to the agency, the output of second quarter is likely to be -12.4% and the country will see a positive growth of 1.3% by the 4th quarter.

NABARD LAUNCHES DEVELOPMENT PROJECTS IN ANDAMAN AND NICOBAR ISLANDS

- National Bank for Agriculture and Rural Development (NABARD) has launched development projects in Andaman and Nicobar Islands to boost Atmanirbhar Bharat Abhiyan.

YOJANA MAGAZINE SUMMARY: JULY 2020

TOPIC: SELF-RELIANT INDIA

Self-reliant India does not mean country is reliant on outside in strategic sectors.

 Since the month March 2020, almost all the economies of the world are under stress due to the declining health and economic sector due to the global pandemic coronavirus (COVID-19). To deal with the epidemic, countries around the world adopted a system of complete lockdown to impose restrictions on movement of people, international travel and transportation of goods and services. As a result of this many industries and organizations have either shut down or are operating at minimum capacity, and its impact is now visible globally.

 According to the World Bank's estimate, the growth rate of the Indian economy will be reduced to just 5 % in the financial year 2019-20, while on a comparative basis there will be a huge decline in the growth rate of the economy in 2020-21 which will come down to just 2.8 %. The report said that the epidemic came at a time when the Indian economy was already suffering due to pressure on the financial sector. Corona virus has increased pressure on it.

SELF-RELIANT INDIA MISSION:

- While addressing the nation on May 12, 2020, Prime Minister (PM) Narendra Modi announced 'Atmanirbhar Bharat Abhiyan (or Self-reliant India Mission)' with Rs 20-lakh-crore stimulus package, equivalent to about 10% of India's Gross Domestic Product (GDP) in 2019-20.
- This special economic package will help overcome difficult situation and revive the economy, which will help in
 providing relief to public and private investment (both domestic and international).



- India believes in the concept of 'Vasudhaiva Kutumbakam'. Since India is a part of the world, India progresses, so
 it contributes to the progress of the world.
- The creation of 'self-sufficient India' will not promote globalization exclusion or protectionism but will help in the development of the world.

MISSION STAGES:

The mission will be implemented in two phases:

- **First Stage :** It will encourage sectors like medical, textiles, electronics, plastics, toys to promote local manufacturing and exports.
- Second stage: In this phase, sectors like gems and jewelery, pharma, steel will be encouraged.

FIVE PILLARS OF SELF-RELIANT INDIA:

Self-sufficient India will stand on five pillars:

- Economy: This is based on Quantum Jump instead of Incremental Change;
- Infrastructure: Infrastructure that becomes the hallmark of modern India;
- System: Systems based on 21st century technology driven systems;
- Vibrant Demography: This is a source of energy for self-reliant India;
- Demand: The full potential of India's demand and supply chain must be harnessed.



ECONOMIC STIMULUS FOR SELF-RELIANT INDIA:

- The Prime Minister has announced a special economic package towards building self-reliant India. This package was done by the government towards the COVID-19 epidemic .
- 20 lakh crore combined with earlier announcements and decisions taken by RBI, which is equivalent to about 10% of India's ' gross domestic product- GDP '. The package will focus on land, labor, liquidity and laws (Land, Labor, Liquidity and Laws- 4Ls).

ECONOMIC PACKAGE ANALYSIS:

- The announced package is in reality considered to be much lower than the declared price as it also includes earlier announcements made by the RBI as part of the government's 'fiscal' package.
- Direct measures announced by the government under the package include subsidy, direct benefit transfer, payment of salaries, etc. The benefit of which is directly received by the real beneficiary. However, the benefit of indirect assistance from the government, such as 'Reserve Bank of India' loan easing measures, does not reach the beneficiary directly.

- Instead of lending, banks can again protect the assistance given by RBI. Recently Indian banks have deposited Rs 8.5 lakh crore with the central bank.
- Thus, despite the declared amount being 10% of GDP, less than 5% of GDP is expected to reach people directly.

SPECIAL INCENTIVES FOR INDUSTRIES:

Businesses including MSMEs

- 1. Rs 3 lakh crores Collateral free Automatic Loans for Business, incl MSME
- 2. Rs 20,000 crore Subordinate Debt for MSMEs
- 3. Rs 50,000 cr equity infusion through MSME Fund of Funds

- 5. Global tender to be disallowed upto Rs 200 crores
- 6. Other interventions for MSMEs
- 7. Rs 2500 crores EPF support for Businesses and Workers for 3 more months

CREDIT GUARANTEE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (MSMES):

- Most of the loans given by banks to MSMEs are given on the basis of assets (as collateral) of MSMEs. But during
 a crisis, the prices of this property may fall and this may hamper MSMEs' ability to borrow. That is, due to the fall
 in the prices of assets during a crisis, banks reduce the lending of these enterprises.
- Credit guarantee is given by the government to banks in this regard that if the MSMEs enterprises are not able to repay the loan then the loan will be repaid by the government. For example, if the government gives 100% credit guarantee to a firm for loans up to Rs 1 crore, it means that the bank can lend Rs 1 crore to that firm. If the firm fails to pay back, the government will pay Rs 1 crore to the banks.

CHANGE IN DEFINITION OF MSMES:

WHY CHANGE THE DEFINITION?

• The definition of MSME has been changed because according to the 'Economic Survey', small enterprises want to remain small as it gives many benefits to these industries. Therefore, there is a continuous demand for change in the definition of MSME.

NEW DEFINITION:

- The investment limit has been revised.
- The turnover of the company has been added as a criterion.
- The gap between construction and service sector has been eliminated.
- However, for the new definition, necessary laws will still have to be amended.

CRITICISM OF THE NEW DEFINITION:

• The new definition of MSMEs will enable enterprises to solve the profitability problem they receive due to their size. However, this change is being criticized, because the definition of the new MSME should be in accordance with the global standard. In the new definition, companies with a turnover of up to Rs 5 crore will be considered small but globally enterprises with a turnover of up to Rs 75 crore are considered small.

POTENTIAL CHALLENGES BEFORE THE SELF RELIANT INDIA MISSION:

COST AND QUALITY

Currently Indian companies do not have a lot of experience in many areas, so maintaining quality of products
and services will be a major challenge in order to stay competitive in the global market while keeping the budget
to a minimum.

FINANCIAL PROBLEM

- Recently, the Indian industrial sector saw an increase in cases of active capital and financial liquidity challenge, with the pandemics of COVID-19 adding to industrial activity and reduced market demand leading to problems in the industrial sector.
- In such a situation, the government should promote targeted schemes in different categories to give a boost to the industrial economy.

INFRASTRUCTURE:

• According to experts, one of the main reasons for most companies coming out of China to India is the lack of a strong infrastructure in the Indian industrial sector (especially in terms of technology). In the last few years, Indian producers have been dependent on imports in one way or the other.

GLOBAL STANDARD:

• Assistance provided by the government to local producers and traders can be released only in accordance with the Free Trade Agreements and the World Trade Organization (WTO) standards.

COVID-19'S IMPACT ON THE GLOBAL SUPPLY CHAIN:

- In the last few years China has emerged as a major producer for the world and during this time China has also
 received huge amount of foreign investment from many countries.
- Following the challenges posed by the COVID-19 epidemic, many countries in the world have given special attention to reducing their industries' dependence on China and developing local capacity.
- The Government of Japan has decided to provide more than US \$ 2 billion in aid to the Japanese companies operating in China.
- Additionally, many US (United States) companies have started reducing their dependence on China.
- The Indian pharmaceutical industry imports around 70% of its total requirement of <u>'</u> Active Pharmaceutical Ingredient (API) from China, but after this epidemic, the Indian government, in collaboration with the industrial sector, specialized to encourage API manufacturing in the country.

THE CONCLUSION:

- After the circumstances arising due to COVID-19, there is a need to empower the citizens of the country so that they can solve the problems related to the country and contribute to build a better India.
 Despite the many challenges facing the Self-Reliant India Campaign, India needs to invest in enterprises that have the potential to emerge as a global force for strengthening the industrial sector. Working in this direction, the government has announced a special economic and comprehensive package of 20 lakh crore rupees under the 'Self-reliant India campaign'.
- Reforms were announced not only in the Micro, Small and Medium Enterprises-MSMEs sector, but also through long-term reforms through self-reliance relief packages; these include areas such as coal and mining sectors.

Not only this, under the 'Agenda 2030' for sustainable development, the principle of universality of social security is contained in the various goals related to it. In this context, the imperative of providing universal social security has gained immense importance.

SOCIAL SECURITY MEANS:

- According to the International Labor Organization (ILO), social security is a broad concept that provides
 assurance of providing a minimum income to oneself and their dependents and protects the individual from any
 form of uncertainty.
- It is described in the American Encyclopedia as "Social Security refers to some special government schemes whose initial goal is to at least liberate all families from poverty by providing means of subsistence and education and medical care.
- Social security consist of 2 elements, namely:
 - **Right to a Standard of Living:** It has been adequate for the health and well-being, including food, clothing, housing and medical care and necessary social services.
 - **Right to Income Security:** It will pave the way in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond any person's control.

WHY THE NEED FOR UNIVERSAL SOCIAL SECURITY?

LARGE UNORGANIZED SECTOR OF INDIA

- The unorganized sector contributes over 80 % of the total workforce, contributing over 50% to the country's economy.
- The unorganized sector of India is basically made up of rural population and consists mostly of people who do traditional work in the village.
- Apart from those who do traditional work in villages, landless farmers and small farmers also fall in this category.
- In cities, these people mostly work in retail business, wholesale business, manufacturing industry, transport, storage and construction industry.
- Most of them are people who go to the villages at the time of sowing and harvesting the crop and seek livelihood to work in cities and metros for the rest of the time.

EXPENSIVE HEALTH SERVICES

- Due to expensive health services, the expenditure on health by the common man has increased tremendously, due to which it is being considered as a major reason for increasing poverty in present times.
- Along with this, the global pandemic COVID-19 has attracted the attention of state policy-makers for making rapid progress towards achieving universal health coverage.
- Universal health coverage is not only the basic condition for achieving the Sustainable Development Goals related to health and welfare, but also other goals such as poverty alleviation (SDG-1), quality education (SDG-4), gender equality and women empowerment (SDG -5), excellent work and economic growth (SDG-8), infrastructure (SDG-9), reducing inequality (SDG-10), justice and peace (SDG-16) etc. are also necessary.

INSUFFICIENT EXPENDITURE ON SOCIAL SECURITY

• Social security programs have a broader purpose in India, but overall public expenditure on social security (excluding public healthcare) is only estimated.

MAJOR PROBLEMS OF UNORGANIZED SECTOR:

- Extremely low income: The income of workers in the unorganized sector is not only less than that of the organized sector, but at times it is not even worth the minimum standard of living. In addition, the annual income is often reduced due to non-availability of work throughout the year in agriculture and construction sectors. There is also no minimum wage in this area, which is binding on the employees. Therefore, these workers are forced to sell their labor at prices lower than the minimum wage rates. Anyway, the minimum wage rates in our country are much lower than the global standards.
- **Temporary employment:** Due to lack of employment guarantee in the unorganized sector, the nature of employment is temporary, which discourages workers engaged in this sector. Due to lack of employment stability, the risk of psychosis among them is more than the workers of organized sector. They also do not get the benefit of various government schemes & also ignored by middlemen and their employers.
- Not covered under labor laws: Most unorganized workers work in enterprises where labor laws do not apply. Therefore their working condition is also not safe and health hazards are very high for them.
- There is no protection even in hazardous enterprises: Child labor, inequality to the extent of injustice with women and their physical, mental and sexual exploitation are common even in hazardous enterprises. The issue of lack of health standards in many businesses is also a challenge to this sector. There are a large number of

child laborers working in matchbox factories, glass industry workers, diamond cutters, polishing on precious stones, junk pickers, brass and bronze utensils and fireworks making enterprises.

• Increasingly complex economic-social system: Due to increasing complex economic-social system, the daily life of these workers is much busier and standard of living is much lower. The incompatibility between income and expenditure has not left their economic condition to be able to lead a better life. That is why the government runs many schemes from time to time, but there are many obstacles in front of it, which are hindering the implementation of those plans and policies.

GOVERNMENT EFFORTS:

• Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) Pension Yojana: When the Interim Budget for the financial year 2019-20 was presented, the government introduced 'Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) Pension Yojana' for the unorganized sector workers with monthly income up to Rs 15,000. In fact, the scope of this scheme can be increased by reducing the amount of monthly income in view of the present circumstances.



- With this pension scheme, workers of the unorganized sector will be able to get a fixed monthly pension of Rs 3000 from the age of 60 with a small monthly contribution of a small amount.
- Under this, the unorganized sector workers who join this pension scheme at the age of 29 years will have to contribute only Rs 100 per month till the age of 60 years.
- Workers joining this pension scheme at the age of 18 have to contribute only Rs 55 per month.
- The Workers Social Security Act, 2008: Government enacted the Unorganized Workers Social Security Act, 2008 in relation to giving social security to workers in the unorganized sector in legislative measures. The Act provides some important arrangements to the National Social Security Board. Through this, recommendations are made for the formulation of social security schemes, life and disability cover, health and maternity benefits, old age security and any other benefit which has been set by the government for the unorganized laborers. Apart from this, National Social Security Board has also been formed.
- **Providing Universal Health Coverage:** The Government of India has implemented universal health coverage (UHC) at all levels of governance for management of the Pradhan Mantri Jan Aarogya Yojana (PM-JAY) based on the recommendation went by the National Health Policy in 2017 to achieve the objective of UHC. The scheme aims to eliminate barriers to the healthcare system at the primary, secondary and tertiary levels. Along with this, efforts are also being made to bring 40 percent population of the country under the coverage of health cover.
- Aam Aadmi Bima Yojana: The government has launched Aam Aadmi Bima Yojana (AABY) to provide insurance in the event of death and disability.

• Prime Minister Employment Generation Program- MNREGA (Mahatma Gandhi National Rural Employment Guarantee Act):



- MNREGA is the world's largest social welfare program to guarantee employment to the people at the legal level, making rural India aware of 'dignity of labor Under the MNREGA program, a provision of 100 days of guaranteed employment, daily unemployment allowance and transport allowance (in case of distance of more than 5 km) has been made for adult members willing to do unskilled labor of each family. Thus, there is a case for extending this programme to urban areas with municipal bodies being given the responsibility for providing a fixed no of days work to all those seeking it.
- The government is implementing many other employment generation / social security schemes for workers in the unorganized sector, such as Swarna Jayanti Gram Swarozgar Yojana, Swarna Jayanti Shahari Rozgar Yojana, , Handloom Weavers Scheme, Handicraft Artisan Comprehensive Welfare Schemes , National Scheme for the Welfare of Fishermen, Training and Extension, Janani Suraksha Yojana (JSY), National Family Benefit Scheme etc.
- The government has established welfare funds to provide social security to certain categories of workers, namely, beedi workers, some non-coal mine workers. Other welfare measures include health care, housing, educational support for children, drinking water supply, etc.

But in spite of all this, the difficulties in identifying the workers in the unorganized sector are a very big problem. Also, due to internal migration, the issue of identity and lack of registration of large number of companies is no less an obstacle.

CONCLUSION:

- In spite of all this, the issue of social security of this unorganized class remains a matter of constant concern. Issues such as livelihood insecurity, child labor, maternity protection, care of young children, housing, drinking water, sanitation, leisure benefits and minimum wages become extremely important among the people associated with this sector.
- In such a situation, the government should formulate a holistic policy, which should e implemented in 3 phases over 10 years for the workers of the unorganized sector and give proper participation in the system, acknowledging their contribution to the economy. The government should especially focus on construction sector, domestic servants, laborers working in mandis and street vendors. People working in unorganized sector should participate in policy making and social security should be provided in view of their share in revenue.
